Operating Report:

- 2A. Porto Bello Restaurant intends to provide live music entertainment for the restaurant and bar area, including outdoor patio spaces while the restaurant is open for lunch and dinner services. Porto Bello Restaurant would anticipate a maximum of 129 total persons as outlined by the Village, Suffolk County Department of Health, and Fire Marshal. Porto Bello Restaurant will operate in compliance with Chapter 88 of the Village Code or its Proposed Amendments.
- 2B. Porto Bello Restaurant contemplates hosting entertainment during its regular business operating hours and when hosting special occasion events. Entertainment and catered affairs will adhere to village code and regulations. Live entertainment would not continue past 10:00pm. No alterations to seating are proposed from the business's regular operations.
- 2C. There is no intention of installing any permanent stage or dancing areas. Security arrangements will be made if/when necessary. Speakers will not be directed outward from the property.
- 2D. Music and entertainment volume levels will be managed to respect surrounding neighborhoods.
- 2E. Porto Bello Restaurant is a fine dining establishment where most of the music heard is through its stereo systems. Live music including bands and DJ's are only likely to perform during private special occasion events.
- 3. Porto Bello is a seasonal restaurant that operates from April through October, 6-7 days per week. Live entertainment is generally only offered on Friday and Saturday evenings, and for special occasion events. All live entertainment and catering affairs will adhere to village code and regulations.
