Entertainment Permit Application Responses

GREENPORT HARBOR BREWERY is a small craft brewery that opened its doors in the harbor side village of Greenport, New York in 2009. We brew small batches of beer and offer tasting samples and the opportunity for take away purchases of our beer. We are open 7 days a week during the summer and then have winter hours of Friday through Sunday during the off season. We are typically open from Noon to 9pm but sometimes will be open until midnight for special events and private parties.

Specific Responses to Application:

- 2.A. We periodically will have live music at the brewery, typically downstairs on the first floor where our beer production takes place. The types of events that we host may be a small private party, or a brewery centered event that celebrates a special occasion or event. We do not hold these events regularly and the number of guests for such an event with live music may range from 40 to 80 persons. We do host a couple of larger special events that include our anniversary celebrations around July 12th, our Oyster Festival the weekend of Columbus Day. These events typically include the outside where we may have a band playing on the edge of our property and are combined with a public assembly permit and request for road closure that may result in a gathering of several hundred people. Such events are rare and only happen 1 to 3 times in the course of a year.
- 2.B. As indicated above, almost always the location of the live music is on the first floor and there is no defined seating. This is an area of our production space and we have hi-top tables and stools. Typically live music will occur on Friday, Saturday or Sundays. The hours of our operation are Noon to 9pm but occasionally we may have a private party that may go until midnight.
- 2.C. We do not have any built in stages. We do not offer dancing during most of our events (other than the two larger celebrations mentioned above). We retain private, licensed and bonded security when larger events take place and the building is insulated with tin covering the walls that helps with noise mitigation.
- 2.D. This building was originally a fire house and is next to the commercial property of STIDD systems and next to a former Bed & Breakfast that is now used as employee housing for the GreenHill Hospitality Group. Across the street is Chase Bank Parking lot, architects offices and

medical offices. There are neighbors further down the road, but the doors and public access all face Carpenter Street and no music or noise is projected toward those residential areas.

- 2.E. We rarely have live music and when we do, it is typically contained and occurs during regular business hours with ending times before 8pm. There are only a few events that may last longer or be later than 8pm but in no case would continue past 11pm.
- 3. We are open 7 days a week during the summer and then have winter hours of Friday through Sunday during the off season. We are typically open from Noon to 9pm but sometimes will be open until midnight for a special events or occasional private party.
