- A. The business intends to provide occasional DJ entertainment for the restaurant and bar area
 on weekends and special occasions during the Summer Season from late May to the end of
 September. The approximate maximum number of persons anticipated to be present within the
 business or on the applicable property in connection with the hosting of any entertainment is
 around 100 guests.
- B. The anticipated days and hours for hosting entertainment and catered affairs are Fridays and Saturdays during the late afternoon or evening. There are no proposed alterations to seating from the normal operations of the business.
- C. There will be no stage or dancing areas. An independent security company will be hired to help enforce the area, and no speakers will be placed facing outside the property. The business plans to eliminate or reduce outdoor noise after 11:00 PM or whatever time the ordinance may mandate.
- D. The music and entertainment provided will be compatible with neighboring businesses, and the business is committed to maintaining volume levels out of respect for residential neighbors.
- 3. Days and Hours of Operation: The business's hours during the Summer Season may operate
 6-7 days a week but we have no plans on featuring live entertainment throughout all the time
 we are open. Any live entertainment and catering operations are planned for Fridays and
 Saturdays during the late afternoon or evening, up until 11:00 PM during the Summer Season.
