Discussion and possible motion on the application of Danielle Rodger. The applicant seeks approval to remove the green and yellow vinyl siding on the house and paint the original siding/clapboard in the Benjamin Moore color Intense White OC-51, with window trim in Sherwin Williams color Mediterranean Blue 7617.
