Work Session Meeting

- **Item #1.** Discussion on application for North Fork Housing Alliance. The owners of 412 South Street need to discuss changes in the site plan, relative to the demolition of a substandard cottage in the rear yard and replacement with a new attached dwelling unit. The expanded house meets all zoning requirements in the R-2 zone. NFHA has submitted an application with additional information as requested by the board.
- **Item #2.** Discussion on the proposed overhanging sign for Salamanders General Store. It meets all the requirement of the local law for overhead signs over sidewalks. The store is located at 38 Front Street; SCTM # 1001-4.-10-31.
- **Item #3.** Mr. Roberts Convenience Store has asked for permission to install an LP gas storage cage. The cage is to house approx. 24 LP units, it measures approx. 4 ft. in width, 5'ht. and 2.5 ft. in depth. The building Dept. is asking for a review to determine if the installation of a storage cage will require a revision to the approved site plan. Mr. Roberts is located at 300 Front Street. SCTM # 1001-4.-8-35.
- **Item #4.** Discussion on application submitted by Chris Dowling. This use evaluation is for opening a retail store at 211 Main Street. The store was previously a gallery. The owner has submitted a proposal for an overhanging side walk sign as well.
- **Item #5.** Discussion on change of use for 429 Main Street. Michael Sweigart has purchased the building and plans to construct an apartment on the second floor. Legal apartments are permitted in the CR zone. He intends to use the first floor retail space for a handmade/gift shop. Preliminary plans submitted to the building dept. meet all New York State Uniform Code.
