APPLICATION FOR TEMPORARY TENT, CANOPY, AIR SUPPORTED OR TENSIONED MEMBRANE STRUCTURE

All tents/membrane structures must adhere to International Fire Code Chapter 31.

You MUST obtain a permit if the tent exceeds 400 square feet.

PLEASE CALL 8-1-1 FOR MARK OUT PURPOSES BEFORE ERECTING TENT

The following must be submitted as part of this application:

- Liability insurance certificate (listing the Village of Greenport as additional insured)
- Site map (showing where tent(s) is being placed at site).
- Certificate of flame resistance.
- The use of tent stakes is the method which may be approved by the Village of Greenport. Any other method of securing shall be approved and signed by a licensed engineer and submitted to Village of Greenport Code Enforcement for approval <u>prior to</u> erecting any tent or membrane structure.
- Tents may only be erected for a period not exceeding 180 calendar days.

INCOMPLETE APPLICATIONS WILL NOT BE ACCEPTED.

NOTE: THIS PERMIT IS INDEPENDENT OF ZONING REGULATIONS AND IS NOT INTENDED TO INFER THAT THE TENT/CANOPY IS A PERMITED USE UNDER ZONING REGULATIONS.
