- 1 CHAIR RATSEY-WILLIAMS: Good evening, it is
- 2 five o'clock and I would like to open the meeting at the
- 3 firehouse in Greenport.
- 4 My name is Jane Ratsey-Williams and I'm
- 5 Chair of the Historic Preservation Commission. Would the
- 6 other members please introduce themselves.
- 7 MEMBER BORRELLI: Roselle Borrelli.
- 8 MEMBER DAVIDSON: Barbara Davidson.
- 9 CHAIR RATSEY-WILLIAMS: Thank you. We have a
- 10 quorum. Please note that Janice Claudio and Dennis
- 11 McMahon are absent this evening.
- If I may have a moment, I would like to
- 13 introduce Barbara Davidson, our newest member, to the
- 14 Historic Preservation Commission.
- Barbara has lived in the Village for over 20
- 16 years. In 2002 she moved here from Bayshore when she was
- 17 offered a job at the Horton Funeral Home as the
- 18 Administrator and as the Lady Attendant, a position she
- 19 still holds today.
- 20 She has always loved history and the
- 21 architecture of the Village and it is evidenced by her
- 22 community volunteer work.
- 23 Barbara has served on the Historic Green
- 24 Hill Cemetery Committee at its inception when they
- 25 received grant money to clean and repair fallen monuments

- 1 and work on the grounds there.
- 2 She has also volunteered at the Sterling
- 3 Historical Society and is a past board member there as
- 4 well. We welcome Barbara.
- 5 MEMBER DAVIDSON: Thank you.
- 6 CHAIR RATSEY WILLIAMS: Item No. 2 on the
- 7 agenda, we have a motion to schedule the next Historic
- 8 Preservation Commission meeting for 5:00 PM on October
- 9 20th, 2022, at the Third Street firehouse.
- 10 Do I have a second?
- 11 MEMBER BORRELLI: Second.
- 12 CHAIR RATSEY-WILLIAMS: Put the motion to
- 13 vote. All those in favor?
- 14 (ALL AYES).
- 15 CHAIR RATSEY-WILLIAMS: The motion is passed.
- 16 Thank you.
- Number three --
- 18 MR. PALLAS: Madam Chair, I apologize. Did
- 19 you skip the first one, Item 1, for the Minutes? I
- 20 didn't hear that.
- 21 CHAIR RATSEY-WILLIAMS: Oh, no, thank you.
- 22 My game is off a little.
- MR. PALLAS: That's fine.
- 24 CHAIR RATSEY-WILLIAMS: Item No. 1, I would
- 25 like a motion to accept and approve the Minutes of the

- 1 June 16th, 2022, regular meeting.
- 2 Do I have a second?
- 3 MEMBER BORRELLI: I'll second.
- 4 CHAIR RATSEY-WILLIAMS: All those in favor?
- 5 (ALL AYES).
- 6 CHAIR RATSEY-WILLIAMS: Motion carried.
- 7 Thank you.
- 8 Item No. 3, discussion and possible motion
- 9 on the application of Alsou Sanders, 630 First Street
- 10 Property LLC.
- 11 The applicant seeks approval to add a knotty
- 12 cedar fence on the property, which varies in height from
- 13 4' to 6'.
- 14 I'm assuming you are here to represent --
- MS. SANDERS: Myself, yes.
- 16 CHAIR RATSEY-WILLIAMS: Could you kindly come
- 17 to the lectern and give us your name and address. Thank
- 18 you.
- MS. SANDERS: My name is Alsou Sanders, I
- 20 just purchased the house on 1st Street, 630, a very
- 21 lovely house, and I've noticed the fence and issues, if
- 22 you look at the house on the right-hand side is a
- 23 beautiful fence that my neighbor, I just met, her name is
- 24 Janice Claudio, she has the most beautiful fence, and I'm
- 25 planning to just continue on with the same kind of look

- 1 and height. And I had a meeting with, his name is Greg
- 2 Bianci (sic) I think, from RBS, and to look at her fence,
- 3 my neighbor's fence, and see if I could match it, nicely,
- 4 material and whatever it's made of. Cedar. He said they
- 5 probably have it in stock, and before, you know,
- 6 installation, I should go to Town and ask for permission.
- 7 And I submitted pictures. I took a picture
- 8 of my neighbor's fence.
- 9 CHAIR RATSEY-WILLIAMS: Yes. Thank you.
- MS. SANDERS: And if you look directly at the
- 11 house, on the left side, the fence is falling down. So I
- 12 was thinking to replace that with a 4' fence. I actually
- 13 looked across, I don't know the neighbor yet, across the
- 14 way, and he has a very nice fence, and I took a picture
- of 4' fence. I mean, we could change that if you don't
- 16 like it, but I would like to have, on the back I would
- 17 like to have like Janice Claudio has, so we just look
- 18 uniform. If it is possible.
- 19 CHAIR RATSEY-WILLIAMS: Nice. Thank you, very
- 20 much. It was not clear to me whether, in your
- 21 application, first of all, the survey is old now, because
- 22 it shows the Methodist Church as your neighbor, not
- 23 Janice Claudio.
- MS. SANDERS: Yes, what happened was it was
- 25 estate sale and the owner's brother was selling the

- 1 property and he wants to move on. He wanted to just move
- 2 on. So we did apply for a new survey, it's going to be
- 3 here any day, any week. Unfortunately, it took longer.
- 4 So we closed on it. We just used the old survey. Because
- 5 he was very distraught and just wanted to close down and
- 6 just sell the house as soon as possible.
- 7 CHAIR RATSEY-WILLIAMS: The house looks
- 8 lovely.
- 9 MS. SANDERS: It's amazing.
- 10 CHAIR RATSEY-WILLIAMS: It looks wonderful.
- 11 So my question about the two sections of 6' fence, are
- 12 they going to be identical to Janice Claudio's?
- 13 MS. SANDERS: Yes. I would like that. I
- 14 would like that. If possible.
- 15 CHAIR RATSEY-WILLIAMS: Okay. Not a picket
- 16 cedar fence or something --
- MS. SANDERS: No, I would like to have
- 18 exactly what she has.
- 19 CHAIR RATSEY-WILLIAMS: Perfect.
- MS. SANDERS: Yes. If you permit it.
- 21 CHAIR RATSEY-WILLIAMS: I think it's lovely.
- 22 I think it will make a nice backyard.
- 23 My other question was though, I'm unclear
- 24 about the 4' fence.
- MS. SANDERS: It's only, you only need it on

- 1 the left-hand side.
- 2 CHAIR RATSEY-WILLIAMS: Right, I understand
- 3 where. But what will it be?
- 4 MS. SANDERS: The little one. That's it.
- 5 That's the one.
- 6 CHAIR RATSEY-WILLIAMS: Exactly like this?
- 7 MS. SANDERS: If you like, yes. If you don't
- 8 like it, I can -- it's just the same, has the same kind
- 9 of copy.
- 10 MEMBER BORRELLI: So you are not going to do
- 11 a cedar in the back, a 6' cedar with a white plastic in
- 12 front?
- 13 If you put these type of pickets here like
- 14 this --
- MS. SANDERS: It's not plastic.
- 16 MEMBER BORRELLI: White vinyl.
- MS. SANDERS: I want like nice wooden.
- 18 MEMBER BORRELLI: So this design, in cedar,
- 19 just like the back?
- MS. SANDERS: Exactly.
- 21 MEMBER BORRELLI: But with this design.
- MS. SANDERS: Yes. Exactly.
- 23 MEMBER BORRELLI: Perfect.
- MS. SANDERS: I do not like plastic. I will
- 25 paint it if I have to.

- MEMBER BORRELLI: No, that's fine. It just
- 2 looked like you were going to put white in the front with
- 3 cedar in the back. And this is vinyl, which we don't --
- 4 MS. SANDERS: No, no, no. I don't like
- 5 vinyl.
- 6 MEMBER BORRELLI: Perfect.
- 7 CHAIR RATSEY-WILLIAMS: So a carpenter will
- 8 make a fence like this but use cedar.
- 9 MS. SANDERS: Yes. Exactly.
- 10 CHAIR RATSEY-WILLIAMS: Perfect.
- 11 MEMBER BORRELLI: So you'll have 6' in the
- 12 back and 4' in the front.
- MS. SANDERS: Yes.
- 14 CHAIR RATSEY-WILLIAMS: Any questions?
- 15 MEMBER DAVIDSON: No.
- 16 CHAIR RATSEY-WILLIAMS: Do you have any other
- 17 questions?
- MEMBER BORRELLI: No.
- MS. SANDERS: It will be very pretty. I want
- 20 to match it like it's there in the front.
- 21 CHAIR RATSEY-WILLIAMS: Thank you. If there
- 22 are no other questions.
- 23 (No response).
- 24 Since there are no further questions, I
- 25 would like to vote on the application at 630 1st Street.

- 1 I would like to note that we are only voting on the work
- 2 described in your September 2nd application. Any other
- 3 changes or additions you wish to make, you'll have to
- 4 come back before the Board.
- 5 MS. SANDERS: Sure.
- 6 CHAIR RATSEY-WILLIAMS: Thank you.
- 7 I make a motion to approve the application
- 8 and issue a certificate of appropriateness as the
- 9 application is in keeping with the criteria in Greenport
- 10 Village Code Section 76-7. Is there a second?
- MR. PALLAS: Madam Chair, before you vote, if
- 12 I may, I would just add a stipulation that the front
- 13 section is unpainted cedar. Just to be clear. Because
- 14 the submittal shows it white. Just so it's clear when
- 15 that goes into the record that it's not two-tone as you
- 16 just described it.
- 17 CHAIR RATSEY-WILLIAMS: Thank you. So any
- 18 other changes or additions you wish to make, you'll have
- 19 to come back before the Board.
- 20 This acceptance is noting, though, that the
- 21 4' fence in the front will be cedar and unpainted at this
- 22 time.
- 23 MEMBER BORRELLI: And matching the back.
- MS. SANDERS: Do you want me to --
- 25 CHAIR RATSEY-WILLIAMS: And matching the

- 1 design as presented to us.
- MS. SANDERS: Okay. It's, if you don't want,
- 3 I mean, I could paint it or leave it like that. It's up
- 4 to you. I just love the shape. And it ties in with the
- 5 back very nicely.
- 6 CHAIR RATSEY-WILLIAMS: I think it's
- 7 beautiful, actually, yes.
- 8 MEMBER BORRELLI: Perfect.
- 9 CHAIR RATSEY-WILLIAMS: I make a motion to
- 10 approve the application and issue a certificate of
- 11 appropriateness as the application is in keeping with the
- 12 criteria in Greenport Village Code Section 76-7.
- 13 Is there a second?
- 14 MEMBER BORRELLI: I'll second.
- 15 CHAIR RATSEY-WILLIAMS: All those in favor?
- 16 (ALL AYES).
- 17 CHAIR RATSEY-WILLIAMS: Motion carries.
- 18 Thank you.
- MS. SANDERS: I have a quick question, while
- 20 I have you, with all your knowledge.
- I was wondering in front of the house they
- 22 told me in Town, it belongs to Town. And it's very
- 23 uneven, actually. It's kind of dangerous to walk on it.
- I was wondering, do I apply for that? How do I fix it?
- 25 CHAIR RATSEY-WILLIAMS: Is it the section

- 1 between the sidewalk and the street?
- MS. SANDERS: It's the sidewalk, like --
- 3 CHAIR RATSEY-WILLIAMS: Oh, the sidewalk?
- 4 MS. SANDERS: Yes. The sidewalk itself.
- 5 CHAIR RATSEY-WILLIAMS: We can send a message
- 6 over to the Village for you.
- 7 MS. SANDERS: Yes, because there is a tree
- 8 and I guess the roots are growing and --
- 9 MR. PALLAS: And the Village will send a note
- 10 to the tree committee.
- MS. SANDERS: There is the neighbors, they
- 12 fixed, their sidewalk it beautiful.
- 13 CHAIR RATSEY-WILLIAMS: We will definitely
- 14 check for you.
- MS. SANDERS: And I tripped. I don't want
- 16 anyone else to get hurt. That's all.
- 17 CHAIR RATSEY-WILLIAMS: Thank you.
- MS. SANDERS: Okay, thank you.
- 19 CHAIR RATSEY-WILLIAMS: Okay. All set. Thank
- 20 you. You can go over to Village Hall and speak to Tina
- 21 for your paperwork.
- I would like to -- Item No. 4, motion to
- 23 adjourn the meeting. Is there a second?
- 24 MEMBER BORRELLI: Second.
- 25 CHAIR RATSEY-WILLIAMS: All those in favor?
