1	Karen Doherty has been appointed to the
2	Historic Preservation Commission, for a term to
3	expire on April 1st, 2024.
4	The Annual May Mile event will be held
5	beginning at 10:00 a.m. on May 11th at Peconic
6	Landing.
7	The Village is hosting the annual town-wide
8	Memorial Day Parade, which is scheduled to kick
9	off at 10 a.m. at Steamboat Corner on May 27th.
10	TRUSTEE PHILLIPS: 29th.
11	MAYOR HUBBARD: Also, we are doing the local
12	Village parade at 8 o'clock from behind the Arcade
13	down to the Railroad Dock with the Boy Scouts,
14	Girl Scouts, and any community members that want
15	to come show up to that. That's at 8 o'clock on
16	May 27th.
17	Liquor License Applications: New
18	application from La Capri Pizza, Incorporated at
19	135 Third Street.
20	Public Hearings: Wetlands Permit
21	Application submitted by Wayne Turett and
22	Jessica Leighton to dredge from the dock to the
23	property at 746 Main Street has been postponed.
24	They're still working on paperwork from I believe
25	the DEC. They did not their permit had

1	expired, so they have to get that renewed, and
2	then that will be put on for a later date.
3	That's all the announcements and public
4	hearings that we had. So public to address the
5	Board on any topic, including the agenda or
6	anything else. Is there anybody from the public
7	who would like to address the Board? Just name
8	and address for the record.
9	MR. SALADINO: John Saladino, Sixth Street.
10	Two things. One, there's a noticeable I
11	want to thank the Board. There's a noticeable
12	difference at at the MTA parking lot.
13	MAYOR HUBBARD: Uh-huh.
14	TRUSTEE PHILLIPS: Uh-huh.
15	MAYOR HUBBARD: Very noticeable.
16	TRUSTEE PHILLIPS: Very noticeable.
17	MR. SALADINO: Dramatic. And, you know, for
18	the folks that didn't think it would matter, the
19	empty spaces proves them wrong. So good job.
20	Thank you.
21	The other thing I would ask is, is there
22	something the Board could share? I was at the
23	work session when there was a presentation by an
24	outside concern and a former Village Official.
25	It's Resolution 4-2019-34. Is there something you

could share with us about that agreement?

MAYOR HUBBARD: Sure. Actually, I was just

having a discussion with Trustee Phillips before the meeting started on the same topic.

Basically, there is no written contract at this point right now. The principals are trying to bid to win a contract. If they win the contract, we will be doing a contract written between the Village and the people that are going to do the geological surveys and everything else, and then that will be circulated amongst the Board Members and the public before we actually sign it.

What they need now is they needed a commitment to say that they had space that they could work out of Greenport. And then if they win the contract, we'll do -- if they win the bid, we'll do the contract. If they don't win the bid, there's no reason to go through and spend a lot of time and money writing up a full drawn contract, because it's not going to happen.

So that's basically why it's worded vaguely like that, just to say, yes, we are interested in the idea, but we'll have to hammer out a -- negotiate a deal if they win the bid. But they needed that to be able to move to the next step

1	on it.
2	MR. SALADINO: Okay, good. Thank you. So
3	if the corporation wins the contract and enters
4	into negotiation with the Village, it will be for
5	basically what's here, for 300 feet?
6	MAYOR HUBBARD: Yes.
7	MR. SALADINO: And up to four boats, I don't
8	really care about that. And American flag, I'm
9	kind of hoping that works.
10	The only the only thing I might question
11	is fueling services may be permitted with specific
12	restrictions. I kind of remember that fueling was
13	always restricted at that at the commercial
14	dock, because there was never available spill
15	response, and so I'm wondering why that might be
16	entertained. It doesn't seem like best practice,
17	unless, unless who's ever going to do the fueling,
18	I assume Hands or somebody is going to do the
19	fueling, provides spill response, you know, but
20	MAYOR HUBBARD: Okay. Yeah, basically, I
21	mean, originally, there were people in the Village
22	that were selling fuel oil at the time when the
23	code was written, so that the Village wasn't going
24	to compete with people that were already in
25	business doing that and take work away. There's

nobody in the Village now that is actually selling fuel from their docks and everything else. All those tanks on the docks have all been removed and there's nobody actually selling that.

So the reason we might do that, if you notice, it's not technically per code, but some of the other boats that are down there, the trucks don't go out on the dock, but they'll pull a hose out and they'll fuel a boat up and let them go. So we need to change the code to modify that, so that a local vendor would be able to sell fuel here, instead of the boat stopping someplace else and somebody else getting the benefit of it.

That's --

MR. SALADINO: I'm not opposed to a guy selling fuel, that's not -- that's not my concern. And I'm -- and I'm not concerned about a guy that stays on the hard with a truck and hauls a hose to the boat.

I'm not even concerned about the -- I don't think I'm concerned about the fuel truck actually going out on the dock. I think it's -- I'm concerned about -- about there's no available spill -- even in local marinas, they have -- they have provision for some kind of spill response,

1	booms, nettings, Dawn.
2	If the Village Board intends to allow
3	fueling on that dock, even on a limited basis, I
4	would suggest that in the contract that you sign
5	with anyone, that, that might be provided.
6	MAYOR HUBBARD: Sure.
7	MR. SALADINO: Because if you have to wait
8	for someone to come, I don't know anybody
9	except except Miller in Calverton that even
10	does it. So, I mean, if you have to wait for
11	someone to come to clean up and I don't expect
12	a big spill, I mean, but, you know, even if
13	something happens, a hose breaks, a tank leaks
14	MR. MILLER: I might be able to help with
15	that question.
16	MAYOR HUBBARD: Okay. Well, that's
17	MR. SALADINO: When I'm done, maybe
18	MAYOR HUBBARD: Yeah.
19	MR. SALADINO: Maybe you could answer. So
20	if the contractee would want to provide that, if
21	he intends to fuel there, or if you can get an
22	assurance from whoever might want to fuel there,
23	that they would provide some kind of
24	TRUSTEE PHILLIPS: Mayor, can I
25	MAYOR HUBBARD: Uh-huh.

TRUSTEE PHILLIPS: Can I just add to John's comment? There's two things. First of all, most of the tow companies, I believe, now, even for the recreational, carry some type of a -- oil spill covers, okay, to take with them, so that they can immediately deal with it.

MR. MILLER: That's correct.

TRUSTEE PHILLIPS: The other issue is that the boats that are at the Railroad Dock now have to carry water pollution insurance, which covers the Village. I know that that's an after effect, but at least it's some type of coverage, which is in -- that's part of the code, that they have to do that. We changed that a couple of years ago.

And the third thing is the actual fuel companies themselves, if we're going to do that, they need to provide us with liability and water pollution coverage as well. And I do know that at the ports that we fuel up at in Rhode Island and in New Bedford, we're required to have it stationed with a person at the fuel -- you know, they can't just -- a guy can't just put the hose into the fuel tank and leave, there actually has to be somebody stationed there the whole time.

That's part of the code, so --

1	MR. SALADINO: Well, my experience now with
2	fueling boats is that the person that's running
3	the fueling, the fuel dock, doesn't do the
4	fueling, they don't want to
5	TRUSTEE PHILLIPS: But, okay, that's not
6	MR. SALADINO: They don't want to be
7	TRUSTEE PHILLIPS: Those are the
8	recreational boats, and that I can't answer. I'm
9	only talking about the commercial guys, and I know
10	what their requirements are. There's a
11	different
12	MR. SALADINO: Seventeen hundred gallons of
13	diesel, whether it's in a recreational boat or a
14	work boat
15	TRUSTEE PHILLIPS: Because our code
16	MR. SALADINO: is still 1700 gallons of
17	diesel.
18	TRUSTEE PHILLIPS: I know. Our code's are
19	different. Okay. Our requirements are different,
20	that's all.
21	MR. SALADINO: I would just ask you to
22	consider that.
23	TRUSTEE PHILLIPS: No, I was planning on it.
24	MAYOR HUBBARD: Yes, we will. And to make
25	it a permanent thing, we would have to change the

1	code to do that, because it is written in the
2	code. So we would have a public hearing on that
3	to change the code to allow fueling down there.
4	MR. SALADINO: Thank you.
5	MAYOR HUBBARD: All right. You're welcome.
6	Did you want respond, or it's covered?
7	MR. MILLER: Yeah, I could say it right
8	on
9	MAYOR HUBBARD: Okay.
10	MR. MILLER: Jimmy Miller from Miller Marine
11	Services.
12	Mary Bess hit it right on the head.
13	Those the commercial vessels have to have a
14	written spill response plan as part of their Coast
15	Guard certification, and they also have to have a
16	spill response container on every one of the work
17	boats, filled with some sweep and absorbants, and
18	a whole plan.
19	And as far as refueling, they have to have a
20	Coast Guard certified refueling plan. And
21	Mary Bess is exactly right, it involves somebody
22	at the stop switch, somebody at the nozzle,
23	somebody to communicate. There's a whole series
24	that each individual vessel has to write for their
25	specific refueling plan and for a vessel response

1	plan. But she pretty much hit it right on the
2	head.
3	MAYOR HUBBARD: Okay.
4	MR. MILLER: I hope that answers some of it.
5	MAYOR HUBBARD: Okay.
6	TRUSTEE PHILLIPS: Yeah, I did learn from my
7	husband.
8	MS. HAMMES: Patricia Hammes, 603 Main
9	Street, Greenport.
10	Just to follow up on this, I guess one
11	question I had, based on what you all just said,
12	is, is the idea that we're going to you're
13	going to hold the space for some period of time
14	while they're pursuing the bid? It's just the way
15	the resolution is worded, it talks about signing
16	an agreement, and I didn't know if the idea was
17	that you're signing a letter of intent, or
18	because, presumably, when they go to bid, they're
19	going to need to know that they've got a backstop
20	on whatever their plans are.
21	MAYOR HUBBARD: Okay. Actually, there's
22	we're not holding any space, because the space
23	that's down there right now is empty.
24	MS. HAMMES: Right. But if somebody came to
25	you tomorrow with another proposal, I guess, is my

1 question. 2 MAYOR HUBBARD: We would definitely entertain the thought of that also. 3 This is 4 really just saying -- the people involved in it didn't know if the Village Board would be 5 6 interested at all or not. So I just wanted to get 7 a consensus of the Board. 8 MS. HAMMES: It's really like -- it's really like to show that we have -- we have an interest 9 10 in this. 11 MAYOR HUBBARD: Yes. 12 MS. HAMMES: Okay. Well, having said all 13 that, this is something that I would -- I would 14 like to say that I would be supportive of. I mean, there's a lot of talk in the Village about, 15 16 you know, the waterfront area and waterfront 17 activities. I'm a big believer, as I understand 18 that this is for an off-shore wind project, I'm a 19 big believer and supporter of renewable energy. I 20 know that off-shore wind can be very 21 controversial. I have dealt with it in my prior 22 career. But my experience has been that those 23 projects, before they get off the ground, are very 24 thoroughly vetted across the board environmentally 25 and everything.

1	And so to me, this seems to me like it would
2	be a great thing for the Village to use empty
3	space in a, you know, waterfront commercial area
4	for something that is waterfront related. So I
5	would just say that based on what I've heard about
6	it and I understand, I think it seems like it
7	would be a great thing.

CONTRACT FOR VENDOR SERVICES

AGREEMENT, made this day of 2019 by and between the Village of Greenport, with offices located at 236 Third Street, Greenport, New York 11944, party of the first part (the "Village") and Harry Munroe, with an address of 32 Laurelton Avenue, Lake Grove, New York 11755 (the "Contractor").

WITNESSETH: That for and in consideration of the promises and the agreements herein contained, and the payments herein provided to be made, the parties hereto agree as follows:

- 1. The Contractor shall perform all services required to be performed and completed as outlined (the "Contract Work") in the March 7, 2015 Request for Proposals (the "RFP") and the Contractor's proposal (together with the RFP the ("Contract Documents") as follows:
- A. Beginning on or about March 1, 2019, prepare Park for opening on May 1, 2019, and closing on October 31, 2019, and complete clean-up at closing, including verifying that electricity and water are turned on at opening, bathroom facilities are cleaned and prepared, and general clean up are performed, and that all services are turned off and trailers are removed by the closing of the Park on October 31, 2019.
- B. Collect all rents and fees when due and deliver rental fees to the Village offices on a daily basis, and work in conjunction with Village staff to assure accurate and timely accounting.
- C. Ensure that all parties for seasonal rentals execute rental agreements, provide identification and vehicle registration, and abide by campground rules and regulations, and leave in a timely and orderly manner at the end of their stay, and assist Village staff with the off-season registration process.
- D. Maintain the park grounds, including cleaning up and refuse left behind by campers, weed-whacking, mowing grass & overgrowth where riding Village lawnmowers cannot clear, checking all plumbing and electrical systems to ensure proper functioning, perform periodic Fall and Spring cleanups.
- E. Bathrooms will be checked and cleaned daily, re-stocked when necessary, and thoroughly cleaned weekly.
- F. Act as point of contact for all campers, handle camper inquiries and concerns, as needed, and resolve conflicts when required.
- G. Flexible on-site hours, with phone availability hours more regulated. Minimum of 15 hours on-site over five days per calendar week, including at least one weekend day.

- H. Additional duties related to the above that may reasonably be requested by the Village.
- 2. In consideration of the Contractor satisfactorily performing this Contract the Village of Greenport shall pay the Contractor the amount of \$19 per hour for service time provided with services to be provided at a minimum of 15 hours per week of the Contract period, and the Village will also provide a space for the Contractor's personal camper, at no charge to the Contractor, for the duration of time of the Contract.
- 3. The Contractor shall not assign or subcontract this Contract or any part thereof and shall not employ any Subcontractor or other person or organization (including those who are to furnish the physical of material or equipment), whether initially or as a substitute.
- 4. This agreement establishes a contract vendor-vendee relationship only between the Village and the Contractor and the neither the Contractor or any agent, employee, helper or assistant of the Contractor shall be considered an employee of the Village of Greenport. The Contractor shall procure and maintain where required, at Contractor's own expense, and without any contract expense to the Village, workman's compensation insurance, New York State disability insurance, and liability insurance and be prepared to provide the Village of Greenport proof of that coverage on request.
- 5. Contractor agrees to indemnify and hold the Village of Greenport harmless for any damages, fees or costs incurred by the Village of Greenport due to any negligent or intentional act or omission by Contractor.
- 6. Payment shall be made by the Village to the Contractor on a semiweekly basis, on the basis of invoices to be prepared and submitted by the Contractor.
- 7. Contractor shall provide the required services in a professional manner, to the best of the Contractor's ability, and in accordance with the Contract Documents. The Village of Greenport reserves the right to terminate this Contract at any time in the event that Contractor fails to provide the required services in a satisfactory manner or violates any provision of this Contract or the Contract Documents.
- 8. This Contract, and the Contract Documents constitute the entire agreement between the Village of Greenport and the Contractor and the Contract may only be altered, amended or repealed by a duly executed written instrument signed by both the Contractor and the Village.

MUNICIPAL ADVISOR SERVICES AGREEMENT

THIS MUNICIPAL ADVISOR SERVICES AGREEMENT (the "Agreement") is entered into as of, March 22, 2019 (the "Effective Date") between the Village of Greenport, ("Village") and Munistat Services, Inc. ("Munistat") (collectively referred to herein as the "Parties").

RECITALS

WHEREAS, Munistat is a Municipal Advisory firm specializing in municipal finance and municipal government related matters; and

WHEREAS, the Village desires to engage Munistat to provide certain services relative to the issuance of the certain obligations as set forth in **Appendix A** ("Work Orders"), and Munistat desires to provide services to the Village in connection with such Work Orders.

AGREEMENT

NOW THEREFOR, the Parties agree as follows:

- 1. <u>Municipal Advisory Services.</u> The Parties hereto agree that Munistat shall provide those services set forth in the Work Orders, and Munistat's services, as the Village's Municipal Advisor shall be expressly limited to the services noted therein.
- 2. <u>Term and Termination</u>. This Agreement shall be effective as of the Effective Date and shall remain in effect until terminated by either party upon (30) days written notice; provided, however, that in the event of termination of any such engagement, Munistat reserves that right to assess fees for any work performed pursuant to a Work Order in accordance with the Fee Schedule set forth in **Appendix B**.
- 3. <u>Agreement to Provide Information</u>. The Village agrees to provide Munistat with factual, not misleading information as shall be required by Munistat in furtherance of the services set forth herein, including financial statements, budgets, and other relevant documents. The Village further agrees to not intentionally omit any material information relevant to Munistat's provision of services. Munistat agrees to promptly amend or supplement this Agreement to reflect any material changes or additions to this Agreement, including material changes to the information provided in Sections 1, 2, 4, 6 and 7.
- 4. <u>Compensation</u>. Munistat shall receive a fee for any services rendered to the Village pursuant to this Agreement in accordance with the fee schedule set forth in Appendix B attached hereto and incorporated herein by reference.
- Indemnity. Each party shall defend, indemnify and hold harmless the other from and against any and all claims, demands, expenses, cost or causes, arising out of or in connection with any claim, suit, action, or proceeding for personal injury, death or property damage sustained or incurred as a result of any act, failure, or default by the other party's employee while acting within the scope of their duties as determined by this Agreement.

6. Required Regulatory Disclosures. Munistat is registered as a "Municipal Advisor" pursuant to Section 15B of the Securities Exchange Act and rules and regulations adopted by the United States Securities and Exchange Commission ("SEC") (Registration #867-00429) and the Municipal Securities Rulemaking Board ("MSRB") (Registration #K0114). As part of this SEC registration Munistat is required to disclose to the SEC information regarding criminal actions, regulatory actions, investigations, terminations, judgments, liens, civil judicial actions, customer complaints, arbitrations and civil litigation involving Munistat. Under a fixed fee form of compensation, the municipal advisor is paid a fixed amount established at the outset of the transaction. AGREEMENT

Agreement made this day of April, 2019 by and between the Village of Greenport, with an office address of 236 Third Street, Greenport, New York 11944, (the "Village"), and Gurwin Certified Home Health Agency with an office address of 68 Hauppauge Rd, Commack, NY 11725 ("Gurwin") (jointly referred to as the "Parties"), regarding the use of the 1840 Schoolhouse Museum (the "Schoolhouse") located at Front Street, in the Village of Greenport, Town of Southold, Suffolk County, New York in conjunction with CAST as follows:

- 1. The Village of Greenport agrees to allow Gurwin to use the Schoolhouse for home health aide training and evaluation classes during the dates and times of the term of this Agreement that are indicated on the attached schedule. There shall be no other use of the Schoolhouse by Gurwin or CAST and no other person or party using the Schoolhouse during these dates and times.
- 2. The Schoolhouse will be used by Gurwin for the training and evaluation of home health aides only.
- 3. Gurwin shall work with CAST to provide employment opportunities for members of the Greenport community.
- 4. A use fee of \$25 per use will be paid to the Village by Gurwin at the conclusion of each training session.
- 5. Gurwin is responsible for the cleaning including removal of all trash and garbage after each use and Gurwin shall restore the Schoolhouse to a clean condition at the conclusion of each use. Gurwin shall be responsible for the cost of damage to the Schoolhouse or its interior and for the any additional cleaning cost incurred by the Village due to Gurwin's failure to restore the Schoolhouse to a clean condition.
- 6. The Village may terminate the Agreement after five (5) days written notice to Gurwin that Gurwin is in breach or default of the Agreement whereupon the Agreement and the Village and Gurwin's obligations shall cease except that Gurwin shall be liable to the Village and shall indemnify the Village for any losses or costs and expenses incurred by the Village due to Gurwin's breach or default.
- 7. Gurwin shall effect and maintain throughout the period of this Agreement the following insurance coverages at its own cost and expense:

Workers' Compensation Insurance

Bodily injury each occurrence \$ 250,000 Aggregate \$ 500,000 Liability property each occurrence \$ 1,000,000 Aggregate \$ 1,000,000 Automobile Liability and General Liability Insurance each occurrence \$1,000,000 aggregate \$2,000,000 Professional Liability Insurance each occurrence \$ 1,000,000 Aggregate \$1,000,000

to protect itself from claims under Workers' Compensation Acts; from claims for damages because of bodily injury, including sickness, disease, or death of any of its employees; from claims for damages because of injury to or destruction of tangible property; and from claims arising out of the performance of professional services caused by errors, omissions, or negligent acts for which it is legally liable. Each policy shall name the Village of Greenport as additional insured. Gurwin shall provide evidence of such coverage to the Village in the form of original policies or policy endorsements, not less than five days prior to the execution of this Agreement by the Village. The Village shall receive written notice of the expiration, termination or any change in the policies that are provided in accordance with this Agreement.

- 8. Gurwin shall indemnify, defend, and hold harmless the Village from and against any and all claims, suits, actions, judgments, legal fees, demands, losses, costs, expenses, damages, and liability caused by, resulting solely from, or arising solely out of the actions, negligent acts, errors, failure to act, or omissions of Gurwin, its officers, employees, agents, or representatives under this Agreement.
- 9. The Village, with the prior approval of the Mayor, Village Administrator or Board of Trustees only, may make changes within the general scope of this Agreement. .
- 10. Gurwin shall not assign, subcontract, sell, transfer, or otherwise dispose of any of the Project or any interest in this Agreement without the prior written approval of Village.
- 11. All notices required or permitted under this Agreement shall be in writing and shall be deemed sufficiently served if served by Registered Mail addressed as follows:

- 13. This Agreement shall be governed by and construed in accordance with the laws of the State of New York.

This Agreement and the Plans represent the entire agreement between Village and Gurwin and supersedes and replaces all terms and conditions of any prior agreements, arrangements, negotiations, or representations, written or oral. The terms of this Agreement may only be amended by a mutually agreed document signed by both parties.

SECOND AMENDMENT

TO

SANITARY SEWAGE AGREEMENT

This AGREEMENT, made this day of 2019, by and between the Village of Greenport, a municipal corporation having its offices at 236 Third Street, Greenport, New York 11944, (the "Village") and Peconic Landing at Southold, Inc., a New York not for profit corporation with an office and principal place of business at 1500 Brecknock Road, Greenport New York ("Peconic Landing" and jointly referred to with the Village as the "Parties").

WITNESSETH:

WHEREAS the Parties entered into a Sanitary Sewage Agreement dated the April 26, 2000, and now wish to provide for a change to the sanitary sewage collection system at Peconic Landing's one hundred and forty-four (144) acre site in the Hamlet of Greenport (the "Premises"); and

WHEREAS the Parties hereto entered into a First Amendment to Sanitary Sewage
Agreement dated February 17, 2015, regarding the construction of an additional forty-six (46)
apartment units in a new building and the extension of its skilled nursing facility by adding
seventeen (17) units together with a sixteen (16) unit memory care facility and an extension of
the sewer capacity for that building, and the units and facility; and

WHEREAS Peconic Landing now desires to convert one of the units (Unit 107) to a duplex unit (one unit being converted to two units within the same building) with the possibility of converting an additional nine (9) units to duplex units for a total of ten (10) units that are converted to duplex units (total of ten existing units being converted to twenty (20) units after

April 15, 2019

conversion); and

WHEREAS Peconic Landing at its sole cost and expense, shall construct on the Premises whatever alterations to the sewage main and collection extension system (the "System") are required to accommodate the conversion of the units and waste collection of the new units; and

WHEREAS the details of the specifications and construction of any changes to the the System will be approved in advance by the Village; and

WHEREAS upon completion of the conversion and changes to the System, if any, the ownership of the changes to the System will be transferred to the Village; it is therefore

AGREED as follows:

- 1. That Peconic Landing may convert unit number 107 to a duplex unit, and may also convert up to nine (9) additional units to duplex units, and Peconic Landing, at its sole cost and expense, agrees to install any changes to the System that are required because of this contemplated conversion.
- 2. All planning and construction costs of the System including but not limited to the engineering, planning, surveying, construction, materials, connection, and other costs shall be paid by and be the responsibility of Peconic Landing.
- 3. Peconic Landing shall pay a fee to the Village to connect the new converted units to the municipal sewer treatment system in the amount of seven thousand five hundred dollars (\$7,500), for each unit that is converted and subdivided, with the first such payment of seven thousand five hundred dollars (\$7,500) to be paid on the signing of this Second Amendment to Sanitary Sewage Agreement, and the subsequent payments of seven thousand five hundred dollars (\$7,500) for each of the nine (9) units that may also be converted to be made on the filing

of an application for a building permit with the Town of Southold for each conversion or filing for approval by the Suffolk County Department of Health Services for approval of a conversion of a unit or units, whichever occurs first.

- 4. The installation and connection work shall be inspected by the Village Engineer of the Village or the designee of the Village, and all such work shall be approved by the Village. The reasonable costs of each inspection of the work shall be paid by Peconic Landing.
- 5. Peconic Landing shall continue to operate, care for, maintain, repair and replace, at its sole cost and expense, all of the piping and fixtures within and to its facilities.
- 6. Upon completion and approval, the Village shall operate the System to the portions of Peconic Landing that were covered by the Agreement, the First Amendment, and to the converted units. The Village shall charge, and Peconic Landing shall pay, municipal sewer charges at the same rate charged to customers of the Village municipal sewer system that are outside of the incorporated limits of the Village.
- 7. This Second Amendment is not intended to and shall not affect the Sanitary
 Sewage Agreement of April 26, 2000 and also shall not affect the First Amendment to Sanitary
 Sewage Agreement dated February 17, 2015, or the obligations of the Village or Peconic
 Landing under the Agreement or the First Amendment, except where specifically stated, and all
 other provisions of the Agreement of April 26, 2000 and the First Amendment dated February
 17, 2015 shall remain in full force and effect.
