- 4 right. I'm going to just open this meeting,
- 5 but observe that we do not have a quorum, and,
- 6 therefore, cannot take any actual actions
- 7 tonight beyond one administrative action.
- 8 So I'm suggesting that we make a
- 9 decision not to accept the site plan review
- 10 application for 221 Fifth Avenue on the
- 11 grounds that it needs to go before the Zoning
- 12 Board before --
- MR. PROKOP: Yes. It doesn't have the
- 14 legal requirements for you -- for the Board,
- 15 for the Planning Board to approve it, so,
- 16 therefore, you have to deny it.
- 17 My recommendation is, since you don't
- 18 have a quorum, as the Chairperson, you
- 19 basically give an administrative denial
- 20 tonight, and then what we'll do is we'll
- 21 ratify that with a vote at the Work Session.
- 22 But your decision tonight as the Chairperson
- 23 will allow it to go to the Zoning -- at least
- 24 start the process with the Zoning Board.
- 25 CHAIRPERSON ATKINSON-LOVELESS: In a

- 2 wait.
- 3 MR. PROKOP: Right.
- 4 CHAIRPERSON ATKINSON-LOVELESS: Okay.

- 7 a vote ratifying your decision.
- 8 CHAIRPERSON ATKINSON-LOVELESS: Okay.

- 11 221 Fifth Avenue because it does not meet the
- 12 requirements for zoning, and it will have to
- 13 come back to us after going to the Zoning
