We want some clarification on whether or not there was a restriction on that, but there was one item, the area, something I believe Glynis had first brought up, the different, making a distinction between a sign for accessory use and a sign as an accessory use, and that was mentioned in another section of the code.

There needs to be some clarification in there as to what, if any, restrictions are on those, as we discussed, the real estate signs and whatnot.
