1	(The meeting was called to order at 7:00 p.m.)
2	MAYOR HUBBARD: Call the meeting to order.
3	Pledge to the flag.
4	(All Stood for the Pledge of Allegiance)
5	MAYOR HUBBARD: Thank you. Okay. We'll
6	start off with the Fire Department report from
7	we've got Chief Wade Manwaring here, and we have
8	Warden Dave Nyce with him.
9	CHIEF MANWARING: As backup.
10	(Laughter)
11	MAYOR HUBBARD: Yep, okay.
12	CHIEF MANWARING: How are we doing?
13	TRUSTEE CLARKE: Good evening. We're good.
14	CHIEF MANWARING: Mine's easy. I guess this
15	the point sheet. This is the point sheet for the
16	month. This is the finance, finance for the
17	month. And we have two applications we'd like you
18	to approve, would be Peter Miller for the Standard
19	Hose Company and Jeffrey Piel for the oh, I'm
20	sorry. Peter Miller is the Star Hose Company and
21	Jeffrey Piel IS for the Standard Hose Company.
22	And that's it, that's what these guys have.
23	MAYOR HUBBARD: Okay. Well, I noticed we
24	did not get a report this month that went out with
25	the work session reports. Was there a reason for

1	that?
2	TRUSTEE PHILLIPS: I did ask Jim this
3	afternoon. I had a conversation with him, that he
4	perhaps should make sure that we get the reports
5	this afternoon.
6	CHIEF MANWARING: The Wardens' report?
7	TRUSTEE PHILLIPS: Well, we
8	TRUSTEE ROBINS: This is the work session.
9	TRUSTEE PHILLIPS: The work session report.
10	We got the minutes, but we didn't get the rest of
11	the information, the you know, the rest of the
12	documents.
13	CHIEF MANWARING: Right. I'll ask him.
14	He's in the office. Maybe we should drag him into
15	it, seeing that
16	(Laughter)
17	TRUSTEE PHILLIPS: Well, I did ask him to
18	make, you know
19	MAYOR HUBBARD: I mean, because, normally,
20	the week before our work session all the
21	Department reports are due. So it was due last
22	Thursday and we didn't get it. So that way nobody
23	had time to review any of the information,
24	anything you had going on, along with the Wardens'
25	minutes or anything else. So, normally, that's

1	due the week before the work session. I know
2	you're getting back in, you know.
3	CHIEF MANWARING: Yep, yep.
4	MAYOR HUBBARD: But that's so the work
5	session package went out to all the Trustees and
6	the Board and the public last Thursday and there
7	was nothing there. I know you have the sheets for
8	us now, but if anybody had any questions, they
9	haven't had time to review any of it. Just so
10	that's that is the procedure. The second
11	Thursday is when work session reports are due in
12	the Clerk's Office, and then they get it gets
13	in the package with everybody else's.
14	CHIEF MANWARING: I hope, I'll try.
15	(Laughter)
16	TRUSTEE PHILLIPS: The other issue I think
17	was you all and I'm not sure if that has to go
18	into Executive Session, but there was a discussion
19	last night about the legal suit that's against the
20	Fire Department. They wanted to know some
21	questions about the depositions, if they when
22	they come up. Is that an Executive Session
23	discussion?
24	ATTORNEY PROKOP: Well, if the Board wants
25	to discuss it, it's Executive Session. Otherwise,

1	they can contact me directly. I could I'd be
2	happy to discuss it with them.
3	TRUSTEE PHILLIPS: Okay.
4	ATTORNEY PROKOP: Whatever you'd like.
5	TRUSTEE PHILLIPS: All right. Because
6	they
7	ATTORNEY PROKOP: Or both.
8	TRUSTEE PHILLIPS: Because I mentioned it to
9	them and they were kind of a little bit in the
10	dark about what had been proceeding forward.
11	So
12	ATTORNEY PROKOP: Okay.
13	TRUSTEE PHILLIPS: I filled them in as to
14	what was in your report, but I think that there
15	needs to be a communication. They're not sure
16	whose who they should be you know, who the
17	contact is for that particular situation.
18	ATTORNEY PROKOP: Oh, you know what, that's
19	
20	TRUSTEE PHILLIPS: Yeah.
21	ATTORNEY PROKOP: So what I'll do is I'm
22	not the attorney that's handling that, I just
23	report the status as I get it. So what I'll do is
24	I'll have the attorney that's handling it contact
25	the Chief directly, if that's okay with the Board.

1	MAYOR HUBBARD: No, that's fine. Do they
2	plan on calling people from the Fire Department to
3	testify?
4	ATTORNEY PROKOP: I don't know.
5	MAYOR HUBBARD: Or is that just
6	ATTORNEY PROKOP: I'm not sure.
7	TRUSTEE PHILLIPS: I'm not sure.
8	MAYOR HUBBARD: All right. Because in the
9	past, it had just been the Village Administrator
10	was taking care of all that. They didn't as
11	far as I knew, they didn't plan on asking anybody
12	from the Fire Department if they had any questions
13	on it.
14	TRUSTEE PHILLIPS: I know. I just brought
15	them up to speed on it, because it was a matter of
16	them they kind of were asking questions about a
17	lot of legal things at that point at their
18	meeting, and so that's why I brought it up to
19	them, that's all.
20	MAYOR HUBBARD: Okay.
21	TRUSTEE PHILLIPS: Okay. All right. And
22	there is one, if we do go into Executive Session,
23	that they discussed the current situation with the
24	suspended Chief. So that's something that they
25	I just need a clarification from within Executive

1	Session as to where to go back to them to answer
2	the question. They had a question that is not a
3	public question.
4	MAYOR HUBBARD: Okay.
5	TRUSTEE PHILLIPS: Are we going into
6	Executive Session today or no?
7	MAYOR HUBBARD: I did not plan on one.
8	TRUSTEE PHILLIPS: Oh, okay.
9	MAYOR HUBBARD: But, I mean, we can. But if
10	they want to wait around for a couple of hours and
11	go to Executive Session to ask their questions of
12	us, they're welcome to do that, but that would be
13	at the end. I'm not going to ask all the public
14	to leave and come back in.
15	TRUSTEE PHILLIPS: No, no, no, no. I'm the
16	one asking the question, not them. I'm the I
17	have a question on some of it, that after our
18	discussion today, I have a question. But I could
19	ask you later, it doesn't have to be in Executive
20	Session.
21	MAYOR HUBBARD: Okay. All right. Well, I
22	mean, it's I know you're
23	TRUSTEE PHILLIPS: They just they just
24	CHIEF MANWARING: I have an EMT class right
25	after this.

1	TRUCTEE RULLIERCE The second sub-40
1	TRUSTEE PHILLIPS: I'm sorry, what?
2	CHIEF MANWARING: I have an EMT class right
3	after this.
4	TRUSTEE PHILLIPS: Yeah. No, I know. It's
5	just that a question got raised after I spoke to
6	you this afternoon, so.
7	MAYOR HUBBARD: Okay. I mean, but, really,
8	as the liaison, you know, you get information, you
9	answer questions for them. But if they have a
10	request that they need, they need to be asking the
11	whole Board for
12	TRUSTEE PHILLIPS: No I understand that,
13	but
14	MAYOR HUBBARD: for stuff. Just
15	TRUSTEE PHILLIPS: No, no.
16	MAYOR HUBBARD: It's the first month of
17	doing this. We're just we're starting out with
18	this. But, you know, if there's questions that
19	the Board of Wardens has, that's why we asked to
20	have a Warden come here also, if they had
21	questions they want to ask, to ask our whole Board
22	and the Treasurer to get things kind of answered.
23	TRUSTEE PHILLIPS: No, no, I understand
24	that. It's just
25	MAYOR HUBBARD: Okay.

1	TRUSTEE PHILLIPS: This was something that
2	just
3	ATTORNEY PROKOP: So I can give information
4	on that, but I can't give any I'm not the
5	again, I'm not the attorney that's handling it,
6	it's the Labor Counsel. So if you'd like a status
7	question, I could probably answer it, but,
8	otherwise, the Chief should probably contact the
9	attorney directly.
10	TRUSTEE PHILLIPS: Well, that's what they
11	needed to know.
12	ATTORNEY PROKOP: Or we could do a
13	conference call, whatever, whatever works better
14	for the Chief. I'd be happy to help in that.
15	TRUSTEE PHILLIPS: Okay.
16	MAYOR HUBBARD: Okay. Last month we had
17	asked to get an email chain set together, so that
18	the Village can email the Board of Wardens and the
19	Chiefs of stuff going on. Have you made any
20	progress with that?
21	CHIEF MANWARING: I've talked to Mike about
22	it and he's going to set it up for us.
23	MAYOR HUBBARD: Okay.
24	CHIEF MANWARING: I mean, with your guy.
25	But Mike has been in and out lately with a medical

1	injury a medical problem.
2	MAYOR HUBBARD: Okay. No, I understand.
3	Okay. But if we can get that
4	CHIEF MANWARING: We are working, we are
5	working on it.
6	MAYOR HUBBARD: because a lot of the
7	questions that I hear that came up would be
8	answered. If the emails and the communication
9	that went to Village Hall was going through the
10	Wardens, then they would know what's going on. So
11	the sooner you can get that set up, the better it
12	be for everybody, because then all the Wardens
13	would have the same information that is going to
14	the Chiefs' office. And that would be beneficial,
15	I think, to everybody if we could get that set up,
16	you know.
17	CHIEF MANWARING: We'll give it a shot.
18	MAYOR HUBBARD: All right. If you need a
19	hand, you know, contact Paul.
20	CHIEF MANWARING: Yeah, that's what I told
21	Mike, to get a hold of Paul.
22	MAYOR HUBBARD: And he can work it, and, you
23	know, just if you have, you know, a group email
24	that everybody you know, everybody's getting,
25	or whatever, just forward that to us, and then all

1	that information will be directed directly to the
2	Wardens and they would have that information
3	daily, instead of, you know, waiting once a month.
4	CHIEF MANWARING: Sounds good.
5	MAYOR HUBBARD: Okay. Any other question?
6	Anything else you wanted to bring up?
7	CHIEF MANWARING: That's about it.
8	MAYOR HUBBARD: Okay.
9	CHIEF MANWARING: I mean, I could text you
10	if you wanted the PESH stuff. We sent in the last
11	stuff from that they sent, and we hope
12	MAYOR HUBBARD: Yeah. Everything
13	CHIEF MANWARING: We hope all training is up
14	to date.
15	MAYOR HUBBARD: Everything looked good.
16	They figured that PERB said, the referred back
17	to Matt, that they should have an answer before
18	the end of the week.
19	CHIEF MANWARING: Okay.
20	MAYOR HUBBARD: So I was hoping we'd have it
21	for today. We don't have that, but they were
22	satisfied with everything we got. Now it's them
23	just saying, "Okay, we accepted all this. There
24	is zero penalties," there is whatever they decided
25	they want. But we've complied with everything.

You've complied with everything with their last training class that you did over the past couple of weeks.

As far as we know, Matt felt comfortable that everything would be sufficient, and then it's a matter of them just determining what they wanted to do with that.

CHIEF MANWARING: Good.

3	ATTORNEY PROKOP: Can you call Sylvia
4	tomorrow and get my cell phone number?
5	CHIEF MANWARING: Yep, that I can.
6	ATTORNEY PROKOP: And please call me
7	tomorrow, it's important.
8	CHIEF MANWARING: Okay.
9	ATTORNEY PROKOP: Okay.
10	CHIEF MANWARING: No problem.
11	ATTORNEY PROKOP: Thank you.
12	MAYOR HUBBARD: All right. Dave, did you
13	have any questions from the Wardens that's
14	MR. NYCE: No. I just as just a point of
15	clarification, I just went and talked to the
16	secretary, Jim Kalin. As far as the report that
17	you're looking for, he's supplied the Wardens'
18	minutes over the past years. He's not he
19	doesn't other than that, he hasn't supplied a
20	report that he's aware of.
21	CHIEF MANWARING: Right.
22	MR. NYCE: I think there's a copy of one. I
23	remember the ones from the past, the number of
24	calls and all the rest of that. If you guys can
25	supply him with an older one, so that he could

1	start doing that.
2	MAYOR HUBBARD: I gave him last month's that
3	he supplied. He's been doing it every month.
4	MR. NYCE: He just told me he had I
5	apologize. He just told me he had not been he
6	had not been supplying any other minutes from the
7	meeting.
8	MAYOR HUBBARD: Okay.
9	TRUSTEE ROBINS: No. He has been doing it
10	right?
11	CHIEF MANWARING: No.
12	CLERK PIRILLO: Chief, I've already written
13	it down, so I took the liberty of writing it down,
14	Wade, as we were speaking excuse me, Board
15	for Chief Manwaring. So what's involved, Wade, I
16	know I know you've done it before.
17	CHIEF MANWARING: Oh, yeah.
18	CLERK PIRILLO: But I just wanted to refresh
19	you. So what's involved is written on the sheet
20	of paper for the Fire Department. They have their
21	own little packet, if you will, involved in our
22	large packet, which consists of a Wardens' report,
23	Company Officers' report, if there is one, Finance
24	Committee Report, Calendar, point sheets. And
25	normally, it would be nice to get any written

1	resolutions that you need. For example, I've
2	included on your behalf permission for the
3	Washington's Birthday Parade.
4	CHIEF MANWARING: Correct.
5	CLERK PIRILLO: Okay? So that will be
6	included, as is the surplusing of the vehicles we
7	spoke about last time, okay? So I've included
8	those on your behalf. And copies, please, of
9	or if you want to give me the originals of the
10	applications, okay? So that's yeah. So that's
11	written for you there so you have a guide.
12	ATTORNEY PROKOP: So I'll say this with the
13	Chief here. Everything that everything that
14	PESH requested was submitted to PESH.
15	MAYOR HUBBARD: Yeah.
16	ATTORNEY PROKOP: And after, after reviewing
17	everything for a day or two, the PESH
18	representative called the attorney that's handling
19	that for the Village and had a question about
20	something, and I just have to get that question
21	answered with the Chief. So I'll take care of
22	that tomorrow.
23	MAYOR HUBBARD: Okay. So there's an
24	additional question that
25	ATTORNEY PROKOP: Yeah, there's an

1	additional question, but
2	TRUSTEE PHILLIPS: Yeah.
3	ATTORNEY PROKOP: So
4	MAYOR HUBBARD: Okay. So talk to the
5	Village Attorney tomorrow about that. I don't
6	know what the question was, so
7	ATTORNEY PROKOP: I found this out at 5:30
8	tonight.
9	MAYOR HUBBARD: Did you?
10	ATTORNEY PROKOP: Yes.
11	MAYOR HUBBARD: Okay. Okay.
12	MAYOR HUBBARD: I called him yesterday. He
13	
13	didn't call me until today at 5:30, and then
15	that's when we got it, I got this.
	MAYOR HUBBARD: Okay. All right. Well, if
16	you can, communicate with the Village Attorney
17	tomorrow and find out whatever that answer for
18	that last question is, and, hopefully, that will
19	settle the whole thing.
20	CHIEF MANWARING: Hopefully. We're running
21	out of time.
22	MAYOR HUBBARD: Yeah. Okay. All right.
23	Thank you both very much.
24	CHIEF MANWARING: Thank you.
25	MAYOR HUBBARD: Okay. The Village

1	Administrator report.
2	ADMINISTRATOR PALLAS: Thank you, Mayor and
3	Board. I'll start with the resolutions. In
4	addition to the request for authorization to go
5	out to bid for a new forklift, just so you're
6	aware, the forklift that we have is 30 years, at
7	least, old, harder harder and harder to get
8	parts. We're going to be looking to purchase a
9	used one, if we can. It's used. It's not used
10	like a storeroom would use a forklift on a daily
11	basis, but used enough where it needs to be
12	available to us to offload equipment and material
13	as it's delivered. So that's, that's one.
14	The next, the first add-on I have
15	TRUSTEE PHILLIPS: Paul.
16	ADMINISTRATOR PALLAS: I'm sorry?
17	TRUSTEE PHILLIPS: Paul, is it is the
18	forklift at the Light
19	ADMINISTRATOR PALLAS: It's at the Light
20	Plant.
21	TRUSTEE PHILLIPS: At the Light Plant. Are
22	you looking for a specific size or
23	ADMINISTRATOR PALLAS: We're going to get
24	comparable to what we have.
25	TRUSTEE PHILLIPS: Okay. All right.

1	Because the forklifts are getting cheaper. You
2	might want to look into a new one on the State
3	contract.
4	ADMINISTRATOR PALLAS: We if we can find
5	one reasonably priced, we would certainly do that,
6	you know, but
7	TRUSTEE PHILLIPS: Okay.
8	ADMINISTRATOR PALLAS: Yeah. I mean, even
9	if we got one 10 years old, it's a lot better than
10	what we have, so
11	TRUSTEE PHILLIPS: No, I'm not disputing. I
12	know what you have up there.
13	ADMINISTRATOR PALLAS: Yeah.
14	TRUSTEE PHILLIPS: But I also know that
15	forklift repairs sometimes cost almost as much as
16	the forklift, so.
17	ADMINISTRATOR PALLAS: Yep, understood.
18	TRUSTEE PHILLIPS: Okay.
19	ADMINISTRATOR PALLAS: The first additional
20	item I have is for New York Association of Public
21	Power Winter Meeting in Albany for Trustee Robins
22	and myself to attend January 22nd, 23rd, I
23	believe. It's, again, a normal meeting that we've
24	attended in the past.
25	We have one personnel potential hiring for

the Account -- an Account Clerk position. We hope to have that resolved by Monday, so it will be in time to make it to the agenda for next Thursday's meeting.

The last add-on I have, we have been notified by Suffolk County Water Authority that they are adding a fee to our rate, essentially. Well, not our rate, but it's actually a per-customer fee, and we -- we have no choice but to pay it. Our -- we're having a public hearing next month for -- to change our rates to accommodate that fee. It's \$80 per customer per year. It's a significant amount of money. That's the reason for the hearing, so everybody's aware.

Moving on to discussion items, the only discussion item I have is a Road End Project update. The project is probably over 90% done at this point. The swales, if you will, have all been constructed, the riprap is in, the brick pavers are in, and the paving on the road ends themselves has been completed. The only thing left is some cleanup work and the plantings, which is critical to the project. That can't be done until the spring. Contractor is on board with that, he's aware of that, and so he's all set up

1	to do that come the spring. And also signage,
2	we're going to have signs at the end, each end
3	of each road and benches on Fourth, so that that
4	will be accomplished in the spring.
5	TRUSTEE CLARKE: Signage and benches similar
6	to the Manor Place installation?
7	ADMINISTRATOR PALLAS: Correct, yes, yes.
8	So, again, I just wanted to give you an update on
9	that.
10	Moving on to individual Departments, start
11	with Road Department. Just a couple of items to
12	highlight. I may have mentioned this last month.
13	We are doing the testing of RPZs for the Sewer
14	Department. We're doing that inhouse. We have
15	somebody trained to do that, so we're
16	accomplishing that inhouse.
17	The Road Department assisted with the tree
18	planting that was done across, throughout the
19	Village. They worked helped to install the ice
20	rink, did some sidewalk work, worked assisted
21	the Light Crew with transporting the Christmas
22	tree. That was kind of an all-hands-on-deck to
23	get that tree moved and set up. So it was an
24	important, obviously, important project.
25	Moving on to Sewer Department, no real

highlights, other than one item that they were just showing that we're winterizing what's the RPZ, and the -- I don't know. I forget what they call it, but right at the -- at the headworks, there's a screw pump that brings all the debris and moves that out of the way. That heater is all set up and ready to go for the winter. That's it on sewer.

Moving on to Electric Department, no specific highlights, other than that the -- most of the items here had to do with Christmas displays. The Electric Department spends a lot of time working on Christmas displays and assisting with the additional lighting that the BID has provided throughout the downtown area. In addition to that, there were a couple of minor outages.

We did -- assisted with the New York Power Authority in testing the main incoming meter. It tested at 100% accuracy, so that we can be confident that the bill from NYPA is, in fact, accurate. That's it for Electric.

Building Department, again, just the standard reports and reminders about snow. I've read that a couple of times, so I'm not going to

read it again, but everybody's aware of the rules 1 2 for snow and cars on the road. Sorry. 3 Moving on to the Recreation Department. 4 Again, most of the work dealt with setting up the ice rink, getting things, staffing ready, the 5 6 facility itself. We are -- we did start spraying 7 the ice rink last night. We've got a good base 8 down. We're spraying again tonight, and we'll be 9 able to assess it, assess in the morning where we 10 stand for a formal opening, hopefully, on 11 Saturday. I won't make that a positive 12 announcement yet, but I will, hopefully, be able 13 to say that tomorrow, that we are ready to open on Saturday. Certainly, if it stays cold on Friday 14 night and we're not ready, we definitely will be 15 16 ready on Sunday, without question. I'm a little concerned about the weather next week, but we'll 17 18 take one day at a time. 19 The Rec. Center itself, just one, one 20 highlight. There's a -- the Rec. Center wanted me 21 to make sure that I gave a big "thank you" to 22 Sylvia, who took care of some donations and sponsors for gifts for the children in the After 23 24 School Program. So they did an outstanding job, 25 as always, with that, and it's very much

1	appreciated.
2	And that's it for me, if anybody has some
3	questions.
4	MAYOR HUBBARD: Okay. Any questions?
5	TRUSTEE MARTILOTTA: No, sir.
6	MAYOR HUBBARD: Thank you. Okay. Village
7	Treasurer.
8	TREASURER BRANDT: Good evening, everyone.
9	TRUSTEE CLARKE: Good evening.
10	TREASURER BRANDT: I have two budget
11	amendments. One, the first one is to fund the
12	engineering services for the Miniature Railroad.
13	The second one is funding for maintenance services
14	that happened at four different pump stations for
15	the wastewater treatment plant.
16	Utility Billing: Red tags were processed
17	today, they're ready to go in the mail. One we
18	had two disconnected residentials. One was
19	reconnected the same day, the other one was the
20	following day, so nobody was out.
21	Community Development: There is going to be
22	no meeting this month, because most of the Board
23	will be unavailable or out of town. So they're
24	scheduling that for the beginning of January.
25	They haven't decided on the date yet, but I

1	believe it will be the first week in January.
2	Significant Collections: Property tax,
3	including the water and sewer re-levy were up to
4	a-million-85. We've had a couple of regular
5	expected payments this month as well. We got our
6	Suffolk County sales tax revenue sharing. That's
7	for our sewer district. We get an annual payment
8	from Suffolk for that.
9	Mortgage Tax Aid quarterly payment was
10	pretty, pretty high this month as well for 9,031.
11	That's pretty much all I got. Any
12	questions?
13	MAYOR HUBBARD: Any questions for the
14	Treasurer?
15	TRUSTEE MARTILOTTA: No.
16	MAYOR HUBBARD: Okay. Thank you.
17	TREASURER BRANDT: Merry Christmas,
18	everyone.
19	MAYOR HUBBARD: You, too.
20	TREASURER BRANDT: And to the ones that
21	don't celebrate Christmas, Happy Holidays.
22	MAYOR HUBBARD: Yes. Okay. The Village
23	Clerk, Sylvia Pirillo, is next.
24	CLERK PIRILLO: Good evening, everyone.
25	MAYOR HUBBARD: Good evening.

1 TRUSTEE CLARKE: Good evening, Sylvia. 2 CLERK PIRILLO: Starting as usual from the 3 back end with the additions. We do have a few 4 resolutions as additions this month. As you'll 5 notice from my report, we had quite a few bid 6 openings on the 16th, so we have recommendations 7 as to how to award those. The first one is the 8 contract for contractor services, and we recommend 9 that go to the sole bidder, Stanley Skrezec. second is the removal of snow, again, to Stanley 10 11 Skrezec, the sole bidder. 12 Delivery of diesel fuel to Burt's Reliable, sole bidder, at a bid price of 11 cents over rack. 13 The awarding of a contract for No. 2 heating 14 oil to Burt's Reliable, sole bidder, at a bid 15 16 price of 11 cents over rack. We did not receive a bid for 87 octane. 17 18 previous -- the previous bidder was Hands Fuel. 19 Per our contract with them from last year, we do have the opportunity to extend that contract two 20 21 times for one year each time. Hands is willing to 22 do so if this Board accepts it at the price quoted last time, which is what I negotiated with them. 23

If that's acceptable to the Board, we'd like to

recommend to extend that contract.

1	MAYOR HUBBARD: Yeah, I think that's fine.
2	TRUSTEE ROBINS: That's fine.
3	TRUSTEE PHILLIPS: Yeah, I'm fine.
4	TRUSTEE MARTILOTTA: All right.
5	CLERK PIRILLO: Thank you. Moving on to my
6	report, under legal notices, there was also a
7	notice of a new application for a liquor license
8	for Porto Bello Restaurant, and that will be
9	published in next week's paper.
10	You'll notice under resolutions as well that
11	I've presented a resolution scheduling a public
12	hearing for next week. That is for wetlands
13	permit application on behalf of 123 Sterling. In
14	order for that to become effective, that needs to
15	be voted on this evening, if the Board chooses to
16	do so. Mr. Mayor, would the Board like to do
17	that?
18	TRUSTEE ROBINS: That's for the public
19	hearing, correct?
20	CLERK PIRILLO: Correct.
21	TRUSTEE PHILLIPS: This is just for the
22	public hearing?
23	CLERK PIRILLO: Yes.
24	TRUSTEE CLARKE: Okay.
25	MAYOR HUBBARD: This is to have the public

1	hearing, because of the discrepancy at last
2	month's vote when we had it, that the bulkhead
3	work was not included in the wetlands permit
4	application that we had on there, and that was the
5	confusion. This is to rectify that situation and
6	to have a public hearing on the bulkhead work for
7	next week, all right? So
8	TRUSTEE PHILLIPS: So would you like me to
9	make the motion?
10	MAYOR HUBBARD: Yeah, I was going to, but go
11	ahead.
12	TRUSTEE PHILLIPS: Okay. No, you can
13	make it.
14	MAYOR HUBBARD: Well, I was going to make a
15	motion that we schedule a public hearing for
16	December 26, 2019 for the wetlands permit
17	application pertaining to the bulkhead work at
18	123 Sterling.
19	TRUSTEE PHILLIPS: I'll second it.
20	MAYOR HUBBARD: All in favor?
21	TRUSTEE MARTILOTTA: Aye.
22	TRUSTEE CLARKE: Aye.
23	TRUSTEE PHILLIPS: Aye.
24	TRUSTEE ROBINS: Aye.
25	MAYOR HUBBARD: Aye.

1	Opposed?
2	(No Response)
3	MAYOR HUBBARD: Motion carried.
4	That will be noticed in Newsday to meet the
5	requirements for the public notice. That will go
6	out tomorrow. And we'll post it on the website so
7	everybody knows. Anybody that's interested in
8	that will be able to come and discuss that.
9	We did have a public hearing. It was
10	partially discussed at the previous public hearing
11	at the October meeting or November meeting.
12	October meeting we had the public hearing.
13	TRUSTEE PHILLIPS: Yes.
14	MAYOR HUBBARD: And we went to vote on it
15	and that was the legal notice and everything we
16	had did not include it included the dock work
17	and the finger piers and everything else, did not
18	include the bulkhead. So that's just to clarify
19	that. That will happen 7 o'clock next Thursday.
20	CLERK PIRILLO: Yes. That will be noticed
21	in I've already sent it to Newsday for the
22	Saturday edition. Thank you.
23	Just a couple of announcements. CAST will
24	be once again revitalizing their ESL program, and
25	will be using the schoolhouse to do so in 2020.

1 There are Monday and Wednesday evening classes, 2 right now, scheduled for January through March. 3 Our update on the website includes the fact 4 that we revamped the entire agenda. Excuse me. 5 The entire agenda placement area, okay, so that 6 each Board and each group, if you will, has its 7 own agenda item. 9	TRUSTEE ROBINS: It's January 19th?
10	CLERK PIRILLO: It is. Okay. Trustee
11	Martilotta, this is the fully executed IMA
12	TRUSTEE MARTILOTTA: Thank you very much.
13	CLERK PIRILLO: between the School and
14	the Village for the upcoming recess time.
15	TRUSTEE MARTILOTTA: Thank you very much.
16	CLERK PIRILLO: You're welcome.
17	Last, but not least, I would like to thank
18	the people, companies, individuals, everyone that
19	helped make this Rec. Center year such a success
20	with the holiday program that we had. Phillip
21	Ross Industries, Altice, DeAl Concrete, James
22	Olinkiewicz, the Rotary Club of Greenport, BST,

6	TRUSTEE CLARKE: Thank you, Sylvia.
7	CLERK PIRILLO: You're welcome. Any
8	questions or comments?
9	MAYOR HUBBARD: No questions?
10	(No Response)
11	MAYOR HUBBARD: Okay. Thank you.
12	CLERK PIRILLO: Thank you.
13	MAYOR HUBBARD: Okay. The Village Attorney
14	report.
15	ATTORNEY PROKOP: I just have a few things.
16	One is PESH we already covered. The second is
17	that with regard to the opioid litigation, we I
18	sent the paperwork into the court and withdrawing
19	from the class action, and also to the Attorney,
20	Mr. Grossman, and I'm waiting for confirmation
21	that they've started the second lawsuit.
22	The one thing I wanted to mention, if you
23	had a question about it, you know, feeling that
24	you might have a question about it, was there was
25	an article in Newsday today about bail guidelines

and document production guidelines in court proceedings. I -- it will affect some of the things that the Village does, but generally we follow a policy that would have been compliant anyway.

It's not -- with the new regulations, anyway, it just has to do with providing information that the Village has regarding the cases that are in court. And we usually provide that at the first court date anyway, which would be in compliance, and we'll continue doing that.

There is a -- I think that's all I wanted to mention about my report, unless somebody has a question.

TRUSTEE PHILLIPS: Habitat For Humanity?

ATTORNEY PROKOP: Yes. So Habitat For

Humanity, we have -- the paperwork that the

Village -- the paperwork from both sides is still

with Habitat's title company waiting for their

signoff on the -- on the paperwork, and so then we

can schedule the closing. They have had it a

little bit longer this time, that they're actually

reviewing it, so I'm hopeful that the means that

they'll sign off on it, and hopeful that we can

have the closing within the next -- I don't want

to guess a time and jinx it, but I'm hoping that it's --

MAYOR HUBBARD: Needs to get it done by the end of the year, because we have to reaffirm with Suffolk County what we're doing with the property beginning next year, because we have stipulations on that piece of property. It would be really nice to get it out of our hands and let them start doing something with it.

TRUSTEE PHILLIPS: It's been dragging feet for --

ATTORNEY PROKOP: We've sent paper -- the Village has sent paperwork to the title company that they requested at least three times so far, probably this is the fourth time, and each time we've waited for the title company to respond and they wanted a change. We complied 100% with this last request. And, as I said, it's made it through a couple of levels of review in their title company, so I'm hopeful. I'm hoping that that's a hopeful sign and we can move ahead with it.

It's a little bit of an unusual transaction as far as the title company is concerned, and they're -- that's resulting in a longer review of

1	the paperwork than would be normal.
2	Does anybody have a question about that? I
3	mean, I can that's basically where we're at.
4	I'm happy to discuss it further.
5	TRUSTEE PHILLIPS: Well, we gave up a
6	portion of something to increase the property
7	size, did we not?
8	MAYOR HUBBARD: The paper road and
9	everything on it.
10	TRUSTEE PHILLIPS: Yeah.
11	MAYOR HUBBARD: We gave that we abandoned
12	that. They didn't want it being abandoned, they
13	wanted different terminology on it. I mean, I
14	signed the deed on this last summer for it to be
15	done.
16	ATTORNEY PROKOP: And we delivered.
17	MAYOR HUBBARD: And we delivered them a
18	signed deed
19	TRUSTEE ROBINS: Did they transfer?
20	MAYOR HUBBARD: from the Village and they
21	still have not accepted it.
22	TRUSTEE PHILLIPS: So it's the Habitat
23	For Habitat For Humanity who is actually
24	holding up, or is it their legal division that's
25	holding it up?

MAYOR HUBBARD: Well, they've had four different Directors since I sent the paperwork in, and every time somebody new comes in, they go and change what they want. And the title company doesn't like the wording that we had supplied them for the first group that said this is what need to be. We abandoned the paper road to clarify that, and then they didn't want it being abandoned. They wanted it to be transferred or something. It just -- it was a terminology difference, but the same thing. It's the same piece of property and everything else.

And Joe's been working on that with them, and it just -- it's completely on them, it's not us. Our legal staff has been handling it.

Whatever they asked for we've been giving it to them. I've been getting emails from the new

Director up there saying, "When are we going to get something done on this?" And I write back,

"We've already given you everything you needed."

You know, and Joe and Paul are working on that,

trying to get that settled before we have to go and re-up for another extension with Suffolk

County, because our two-year extension we had gotten --

1	TRUSTEE PHILLIPS: Is almost due.
2	MAYOR HUBBARD: It's almost due, yes. And
3	Suffolk County sent us a letter asking any
4	properties that we have that are in their program,
5	we need to tell them what's going on with the
6	properties.
7	TRUSTEE PHILLIPS: Okay.
8	MAYOR HUBBARD: So, hopefully, Joe
9	ATTORNEY PROKOP: Yeah.
10	MAYOR HUBBARD: could get this done
11	within the next couple of weeks, so we don't have
12	to re-up with all the paperwork with Suffolk
13	County again to say that we still have title to
14	this property.
15	ATTORNEY PROKOP: June of 2018. I had
16	forgotten that, but you're right. June of 2018 we
17	signed all the deeds and all the transfer
18	documents, and I personally drove them to the
19	Habitat headquarters in Middle Island
20	MAYOR HUBBARD: Right.
21	ATTORNEY PROKOP: and delivered them.
22	And we were off and running. We expected a
23	closing within a day or two and then
24	MAYOR HUBBARD: Exactly.
25	ATTORNEY PROKOP: the title company got

1	involved and
2	MAYOR HUBBARD: Right.
3	ATTORNEY PROKOP: It's there's a legal
4	issue where it's not quite an abandonment and it's
5	not quite a discontinuance, and they're trying
6	to the title company is trying to manage the
7	language, and we're hoping this time they'll sign
8	off on it.
9	TRUSTEE PHILLIPS: No good deed goes undone?
10	MAYOR HUBBARD: Well, you know, we're trying
11	to let somebody just build a house and it's
12	been you know, this has been going on for over
13	four years from the start.
14	TRUSTEE MARTILOTTA: Definitely has.
15	TRUSTEE PHILLIPS: Yes.
16	MAYOR HUBBARD: You know, it's
17	TRUSTEE PHILLIPS: Yeah.
18	MAYOR HUBBARD: Five years, it's been a long
19	time, and it would really be nice to just be done
20	with it. Okay.
21	ATTORNEY PROKOP: That's all I have, again,
22	unless you have questions.
23	MAYOR HUBBARD: Any questions for the
24	Village Attorney?
25	TRUSTEE MARTILOTTA: No, sir.

1	ATTORNEY PROKOP: Thank you.
2	MAYOR HUBBARD: Okay. All right. Thank
3	you.
4	Okay we had a public hearing last month on
5	the revamped parking and times and everything
6	else. We had really no comments at the public
7	hearing. It's up to the Board discussion now. Is
8	the Board comfortable with the changes that the
9	law that Joe had written and the proposed changes
10	that Paul had put together with everything? Is
11	TRUSTEE MARTILOTTA: I have to say, I think
12	it looks great. It makes a lot more sense.
13	TRUSTEE PHILLIPS: I think yeah.
14	TRUSTEE ROBINS: I'm actually not
15	comfortable with it.
16	TRUSTEE MARTILOTTA: Oh.
17	MAYOR HUBBARD: You're not? Okay.
18	TRUSTEE ROBINS: Yeah.
19	MAYOR HUBBARD: Okay.
20	TRUSTEE ROBINS: First of all, I think
21	30-minute parking spaces these days are extremely
22	limiting. Maybe, maybe the one or two right in
23	front of the pharmacy. But most people are going
24	to do more than one errand when they stop in town.
25	They're going to go into one store, they're going

1	to run across the street to the parking lot, they
2	run into a friend on the sidewalk or whatever. I
3	just think it's very, very short term, so I would
4	prefer to see those spaces remaining 60 minutes.
5	MAYOR HUBBARD: All right. Which spots are
6	they? Which spots are you talking about?
7	TRUSTEE ROBINS: The First Street spots, the
8	ones that are running from South Street to Front
9	Street; am I correct, Paul?
10	ADMINISTRATOR PALLAS: I didn't bring my
11	TRUSTEE ROBINS: First, both sides, Front
12	Street to South Street, 30 minutes.
13	ADMINISTRATOR PALLAS: Yes.
14	TRUSTEE ROBINS: Okay. That's the entire
15	side of First Street?
16	ADMINISTRATOR PALLAS: If I may.
17	TRUSTEE PHILLIPS: You mean by IGA?
18	TRUSTEE ROBINS: Yeah, yeah. The whole
19	strip in front of the IGA would also be 30
20	minutes, right, because that's South Street.
21	TRUSTEE PHILLIPS: Well, they've been 30.
22	TRUSTEE ROBINS: To Front.
23	TRUSTEE PHILLIPS: Some of them have been 30
24	minutes as it is already.
25	TRUSTEE MARTILOTTA: I believe they are 30.

25	mind the 10 o'clock. But the 8 p.m. I think, y	ou

1	know, is going to have a pretty tough impact on a
2	lot of restaurants. I mean, if you're going to go
3	out to eat 5:30, 6 o'clock, you know, and, you
4	know, you don't get out of the restaurant by 8
5	you know, in time, you're going to be, you know,
6	rushed and
7	MAYOR HUBBARD: Well, if you're going to a
8	restaurant, you wouldn't go to a 30-minute parking
9	spot anyway.
10	TRUSTEE ROBINS: No, no. But these aren't
11	just the 30-minute spots, are they? These are
12	two-hour spots as well, Paul, right?
13	MAYOR HUBBARD: If you put a two-hour
14	parking spot at 6:30, we stop enforcing the code
15	at 8 o'clock, so you have enough time to do that.
16	TRUSTEE ROBINS: Well, you're changing the
17	time to one-hour parking now, right?
18	MAYOR HUBBARD: They're all being changed
19	from
20	TRUSTEE ROBINS: And you're changing the
21	time from 10 a.m. to 8 p.m.
22	MAYOR HUBBARD: Correct.
23	TRUSTEE ROBINS: Okay.
24	MAYOR HUBBARD: So you want to keep it
25	from

1	TRUSTEE ROBINS: I think that the current
2	MAYOR HUBBARD: You want it from 8 to 6?
3	TRUSTEE ROBINS: Eight to 6 I think would be
4	preferable.
5	MAYOR HUBBARD: Okay. That would have been
6	helpful when we had the public hearing to have
7	those comments, but
8	TRUSTEE ROBINS: Well, it was a public
9	hearing, I didn't really you know, I mean, I
10	did I had
11	MAYOR HUBBARD: Okay. Well, that's
12	TRUSTEE ROBINS: I did have some comments
13	from the BID today, you know, and we discussed it,
14	and I understood where they were coming from on
15	that, so that's why I wanted to bring it up as
16	discussion.
17	TRUSTEE CLARKE: I'm going to mention
18	MAYOR HUBBARD: So did the BID make a
19	recommendation? Did they want to keep parking
20	only enforced until 6 o'clock, is that what the
21	BID wants?
22	TRUSTEE ROBINS: They would prefer it to
23	remain as it is with the current.
24	TRUSTEE PHILLIPS: What, the 8 to 6?
25	TRUSTEE ROBINS: Eight to 6, yeah.

1	TRUSTEE PHILLIPS: But the okay. But the
2	observations in the morning are from what I
3	understand, is that parking at 8 o'clock,
4	9 o'clock, 10 o'clock is not an issue.
5	TRUSTEE CLARKE: But that's not the issue,
6	the issue is 6 to 8.
7	TRUSTEE ROBINS: It's the back end.
8	TRUSTEE PHILLIPS: Is 6
9	TRUSTEE CLARKE: Nobody really probably
10	cares what time it starts. The issue is between 6
11	and 8.
12	TRUSTEE ROBINS: That's the change that
13	they're objecting to.
14	TRUSTEE CLARKE: But that was a purposeful
15	change.
16	TRUSTEE PHILLIPS: Well, part of the change
17	was to help, because the 6 o'clock with the
18	30 minutes around the whole First Street
19	properties I mean, the First Street parking
20	spots were being filled by 5 o'clock from those
21	who wanted to go down and go to the restaurants,
22	because there was an open spot.
23	TRUSTEE CLARKE: Right.
24	TRUSTEE PHILLIPS: And those who wanted to
25	get into get in and get out of the IGA were not

1	finding any parking spaces.
2	TRUSTEE CLARKE: Right.
3	TRUSTEE PHILLIPS: So I think that that was
4	the goal of
5	TRUSTEE CLARKE: That was the intent.
6	TRUSTEE PHILLIPS: That was the intent for
7	that, for some of those spaces on Front Street
8	I mean, on First Street, excuse me. That was the
9	original intent, was to you know, to make the
10	ease of traffic flow around there, because it was
11	getting stymied.
12	TRUSTEE CLARKE: Because the IGA is open
13	until 8
14	TRUSTEE PHILLIPS: Until 8 o'clock.
15	TRUSTEE CLARKE: in the summer.
16	TRUSTEE PHILLIPS: In the summertime.
17	TRUSTEE CLARKE: When this matters, because
18	nobody is really worried about it in January.
19	TRUSTEE PHILLIPS: No, they're not worried
20	about it in
21	TRUSTEE ROBINS: No. Well, I mean, I
22	usually find that the IGA parking lot does have
23	parking, you know, up at you know, before they
24	close, the last hour or so, even in the summer.
25	I, I mean, personally, never had any problem

1 finding a space. One exception might be on a 2 night when there's like Dances in the Park, or something like that, and people are coming in --3 4 MAYOR HUBBARD: Uh-huh. 5 TRUSTEE ROBINS: -- and those spaces would 6 fill up, but not the rule. 7 TRUSTEE CLARKE: The other intention was to 8 facilitate short shopping trips in the evening or 9 in late afternoon, so that the increasing numbers 10 of restaurants don't fill up the entire Business 11 District by 5 o'clock, so that if you have an 12 after-work errand to run in the summer and you 13 can't find any parking anywhere, this would alleviate, particularly for residents, that 14 So restaurant customers who want to park 15 problem. 16 for a longer time would have to park further away 17 or in other lots or in other areas, rather than 18 that one primary corridor, which is a preferred 19 parking spot for restaurant-goers. 20 So I understand the BID's point of view, but 21 I believe that the Board's point of view and the 22 Administration's point of view of trying to

facilitate turnover for visitors and residents

alike who are coming in at the end of the day for

shorter periods of time, that they have access to

2	TRUSTEE ROBINS: Okay. I mean, you know
3	TRUSTEE CLARKE: If that makes sense.
4	TRUSTEE ROBINS: Yeah. No, I get that. I
5	just I didn't really feel that that short-term
6	problem was a you know, at least based on my
7	observation, that that wasn't a problem at that
8	hour, you know.
9	TRUSTEE CLARKE: No. In the summer you
10	can't park at 6 o'clock anywhere.
11	TRUSTEE PHILLIPS: At 6 o'clock.
12	TRUSTEE MARTILOTTA: It's impossible.
13	TRUSTEE ROBINS: Nowhere?
14	TRUSTEE PHILLIPS: Nowhere.
15	TRUSTEE CLARKE: Not that I can find.
16	TRUSTEE PHILLIPS: I've had so much no.
17	TRUSTEE ROBINS: Okay. All right. I mean,
18	you know, I'm not sure if I've observed that,
19	but
20	TRUSTEE CLARKE: There was a letter that was
21	received that we all
22	TRUSTEE ROBINS: We had that.
23	TRUSTEE CLARKE: had a copy of
24	TRUSTEE ROBINS: It was in October.
25	TRUSTEE CLARKE: which reflected these

1	points. We didn't discuss them at the hearing,
2	but that letter is on file, and I know everyone
3	received it.
4	TRUSTEE ROBINS: Yeah. No. I tried to get
5	the people from the BID to come and speak at that
6	meeting. I hold them we have we were having a
7	public hearing. So, you know, I was asked to, you
8	know, bring up this point and question, you know,
9	if this is the you know, now, this is just this
10	area now, Paul, or is this going to be beyond this
11	area, because I know you're working one segment at

13	ADMINISTRATOR PALLAS: Correct.
14	TRUSTEE ROBINS: This is just First Street.
15	ADMINISTRATOR PALLAS: As of now, yes.
16	TRUSTEE ROBINS: Okay. There is some
17	there are Adams Street spaces here as well, right,
18	but they're already 30 minutes, correct?
19	ADMINISTRATOR PALLAS: Yeah. I think that
20	was just a limit of time as well.
21	TRUSTEE PHILLIPS: That's a correction.
22	ADMINISTRATOR PALLAS: It's a correction,
23	more of a correction, yes.
24	TRUSTEE PHILLIPS: Those were those
25	were the there was a mistake in the code

1	TRUSTEE ROBINS: Uh-huh.
2	TRUSTEE PHILLIPS: that was discovered
3	when everything when everyone started looking
4	at this, and that's a correction. That's the ones
5	that are on Adams.
6	TRUSTEE ROBINS: Okay. And then that also
7	has the same time change, though, from 10 a.m. to
8	8 p.m.?
9	ADMINISTRATOR PALLAS: Correct.
10	TRUSTEE PHILLIPS: Correct.
11	TRUSTEE ROBINS: So okay.
12	MAYOR HUBBARD: The time the enforcement
13	is the biggest change. We're enforcing it,
14	instead of the TCAs don't go out at 8 o'clock
15	in the morning, because there's not an issue.
16	TRUSTEE ROBINS: No, of course.
17	MAYOR HUBBARD: They normally start at
18	10 o'clock, so they're putting in their 8-hour
19	day. We're changing it to match up with the time
20	frame of when they're working.
21	The other change was the spots behind Front
22	Street Station. They were 30-minute spots,
23	because of the dry cleaner that used to be there.
24	Those were changed to one-hour spots instead of 30
25	minutes, to give people more time to shop on Adams

1	Street. And the rest of it is really just
2	changing clarifying the code, where the code
3	was, which spots were what, and changing the time
4	of enforcement from 10 o'clock to 8 o'clock,
5	instead of from 8 o'clock to 6 o'clock, because
6	the night life has gotten busier, and we're trying
7	to keep spots available and moving until 8 o'clock
8	at night.
9	TRUSTEE ROBINS: Okay. So, yeah, I hadn't
10	heard that before about the you know, trying to
11	coordinate it with the Code Enforcement time.
12	That does make sense to me, you know, that
13	MAYOR HUBBARD: Yeah.
14	TRUSTEE ROBINS: Because we don't have our
15	people out. Do we have our TCOs out until 8 p.m.
16	at night? I haven't observed that.
17	MAYOR HUBBARD: Well, no. They were
18	stopping at 6 o'clock, because that's what the
19	code was. So they'll be changing and they'll be
20	working until 8 o'clock.
21	TRUSTEE ROBINS: So, then, they were only
22	doing six hours, then. They were only coming on
23	at 10 o'clock and working until 6?
24	TRUSTEE MARTILOTTA: They were coming on at
25	8 and

1	MAYOR HUBBARD: They were work from they
2	were coming in at 10, working until 6.
3	TRUSTEE ROBINS: Ten to 6.
4	MAYOR HUBBARD: So they were doing an 8-hour
5	shift.
6	TRUSTEE ROBINS: Okay.
7	MAYOR HUBBARD: So now they'll be coming in
8	at noon, or whatever, and be splitting it up
9	between the two of them to cover the whole time
10	frame.
11	TRUSTEE ROBINS: Okay. All right. Okay.
12	Thank you. Thanks.
13	MAYOR HUBBARD: Okay. That's an
14	explanation. Well, we're going to put it on the
15	agenda for a vote for next week, we'll have
16	discussion on that. The public, if the BID wants
17	to comment on it before we vote at our regular
18	meeting, they're welcome to come and could put in
19	their comments on the overall wording of what it's
20	going to be before we actually take the vote.
21	You know, we had the public, where at this
22	point it's trying to just get it moved forward.
23	So we're going to put it on the agenda to vote on
24	it, and we will take, you know, any comments
25	during the regular meeting, and we'll have another

1	discussion with that before we vote, if anybody
2	wants to.
3	TRUSTEE CLARKE: Very good.
4	TRUSTEE ROBINS: I'll also send an email
5	back to their president and inform him of the
6	discussion tonight, and, you know
7	MAYOR HUBBARD: Okay, that's great.
8	TRUSTEE ROBINS: see if they want to make
9	any comments before the meeting next week.
10	MAYOR HUBBARD: Sure.
11	TRUSTEE ROBINS: Okay? Great.
12	MAYOR HUBBARD: All right.
13	TRUSTEE ROBINS: Thank you very much.
14	MAYOR HUBBARD: All right.
15	TRUSTEE MARTILOTTA: I think, too, just what
16	you tell me, it's just so much simpler. You know,
17	we're looking at a large area and setting a time
18	we're going to enforce it, and to me it makes more
19	sense. Like when we looked at the is it six
20	months ago or something? You guys, when you got
21	the map of like how parking was, again, or I guess
22	it currently is, it was kind of
23	TRUSTEE PHILLIPS: Chopped up.
24	TRUSTEE MARTILOTTA: You know, what I mean?
25	It was really to me

1	MAYOR HUBBARD: If you're new in town, you
2	didn't know these are 30 minutes, that's one hour,
3	this is two hours.
4	TRUSTEE MARTILOTTA: You didn't know what
5	you were getting.
6	TRUSTEE ROBINS: No, no. Well, I believe in
7	continuity.
8	MAYOR HUBBARD: We're trying to centralize
9	it
10	TRUSTEE MARTILOTTA: Yes.
11	TRUSTEE ROBINS: Definitely.
12	MAYOR HUBBARD: and make it so everybody
13	knows you could just put something on the website,
14	somebody knows when do we enforce parking. It's
15	from 10 to 8, and trying to make
16	TRUSTEE MARTILOTTA: Yes.
17	MAYOR HUBBARD: everything the one-hour
18	spots and make it more user friendly for what it
19	is. And now where people don't get confused, is
20	this a two-hour spot, a 30-minute spot, whatever,
21	and just trying to clarify that. Behind the
22	laundromat, when the signs were taken down, we
23	went to put them back up, but the code didn't
24	match what we were putting back up.
25	TRUSTEE MARTILOTTA: Yeah, no.

1	MAYOR HUBBARD: So we're trying to just
2	rectify those issues, because those we couldn't
3	write tickets in those areas, because it didn't
4	match what the code had actually said. So we're
5	trying to just rectify all the stuff and get it
6	all so that it is enforceable. And people can get
7	in and do their laundry and get back out, so
8	there's spots to get in, and it's not a dining
9	customer that parks for four hours and takes up a
10	spot.
11	TRUSTEE PHILLIPS: Well, I think it makes
12	a it makes a fairer time lag for the
13	restaurants and for the residents. And I think we
14	have to give the residents some opportunity to get
15	to the stores downtown or down the street, so.
16	TRUSTEE ROBINS: Just I do have one other
17	question. How long have 30-minute spaces been in
18	effect in the Village? Was that since the parking
19	study that was done back in 2006?
20	TRUSTEE PHILLIPS: No.
21	TRUSTEE CLARKE: No.
22	TRUSTEE PHILLIPS: That's been in the code
23	for awhile.
24	ADMINICIDATOD DALLAC. That's ald
	ADMINISTRATOR PALLAS: That's old.

1	ADMINISTRATOR PALLAS: Yeah.
2	TRUSTEE PHILLIPS: 01d, yeah.
3	MAYOR HUBBARD: That's old, yeah.
4	TRUSTEE PHILLIPS: Just it was never
5	really
6	TRUSTEE ROBINS: No, I know it wasn't
7	enforced, but
8	TRUSTEE PHILLIPS: Well, not only that, the
9	signage was
10	TRUSTEE CLARKE: The signage was inaccurate.
11	TRUSTEE PHILLIPS: There was no signage for
12	it either.
13	TRUSTEE ROBINS: Yeah, okay.
14	TRUSTEE CLARKE: There's also greater
15	uniformity in what's on that paper than there is
16	today. It's clear and it's more uniform.
17	TRUSTEE ROBINS: Yeah. No, I
18	TRUSTEE CLARKE: I mean, whether you agree
19	with it or not, it's more uniform.
20	TRUSTEE ROBINS: Yeah. No, I totally agree
21	with the uniformity. I'm still a little iffy on
22	30 minutes versus 60 minutes, though. I just
23	think that, you know, 30 minutes is more pressure
24	for a lot of errands that people need to come and
25	do, you know, and they have to give up that spot.

1	MAYOR HUBBARD: I mean, I understand it, but
2	I come home from work, I get home at 6, 6:15, I
3	stop at IGA, and it's very nice to be able to hit
4	a spot, go in, get my stuff, and get back out.
5	You know, when I go on Sunday morning, and then
6	talking to people and everything else, I don't
7	park in those spots, because you spend a lot more
8	time seeing people on Sunday morning. But me just
9	getting home from work, I finish work, I want to
10	just run in to get something for dinner, and it's
11	nice to have a spot there, instead of having to
12	park three blocks away to walk up there.
13	TRUSTEE CLARKE: He's a fast shopper.
14	MAYOR HUBBARD: Yes.
15	(Laughter)
16	TRUSTEE ROBINS: I've seen you pull in and
17	out at our office spots. George, you are good.
18	MAYOR HUBBARD: I mean, I get what I want
19	and out.
20	TRUSTEE PHILLIPS: We kind of like bump into
21	each other, and like vavoom, so.
22	MAYOR HUBBARD: Right. You know, but it is
23	convenient to have the spots available around the
24	supermarket and everything else, especially when
25	they're open until 8 o'clock.

1	TRUSTEE ROBINS: Okay.
2	MAYOR HUBBARD: So, okay.
3	TRUSTEE ROBINS: Thank you.
4	MAYOR HUBBARD: All right. We will put that
5	on the agenda for a vote for next week.
6	Okay. Trustees reports, Trustee Martilotta.
7	TRUSTEE MARTILOTTA: Sure. Just briefly, I
8	wasn't at the light ceremony. My children
9	absolutely loved it. Unfortunately, I was out of
10	town.
11	Mine's real brief. The Mayor was able to
12	sign the Intermunicipal Agreement with the school.
13	So over the break, we will have the shared
14	services again at the gymnasium, the 26th I
15	got it. I've got dates real quick.
16	TRUSTEE PHILLIPS: Yeah, that was
17	CLERK PIRILLO: Starting the 26th.
18	TRUSTEE MARTILOTTA: It's 26th, twenty
19	CLERK PIRILLO: For four days, 26th, 27th,
20	28th and 29th.
21	TRUSTEE MARTILOTTA: Is that what it is?
22	CLERK PIRILLO: Twenty-sixth.
23	TRUSTEE MARTILOTTA: I got it. I just I
24	looked at it one minute ago and I had it committed
25	to memory, but it's not there anymore.

1	Twenty-sixth, 27, 30, 30th, and January 7th. So
2	we'll have someplace for the kids to go over
3	break. And, hopefully, it won't be as cold as it
4	is today.
5	MAYOR HUBBARD: Uh-huh.
6	TRUSTEE MARTILOTTA: Because then it will be
7	a real full house. But, again, real briefly,
8	that's all I really have for the week for the
9	month, sir.
10	MAYOR HUBBARD: Okay. All right. Thank
11	you.
12	TRUSTEE MARTILOTTA: To you.
13	MAYOR HUBBARD: Trustee Clarke.
14	TRUSTEE CLARKE: I have no report this
15	month.
16	MAYOR HUBBARD: That's fine. Very good.
17	Trustee Robins.
18	TRUSTEE ROBINS: I was writing away today.
19	I take notes at every meeting I go to, so most of
20	my reports come from that.
21	The Carousel Committee had their meeting on
22	the 3rd. They were planning for and took care of
23	the decorations at the Carousel, which looks
24	great. You know, they did that over two days.
25	They got some help from John Diaz from the Marina

crew, hanging the large wreath on the outside.

They were -- they'd like to send a thank you

card to Kate Eisenberg, the young woman who was helping with the painting of the horses. She's going back to school full time now. She's offered to donate a few hours, but I think the committee is going to thank her for her time.

Bob Wissmann reported that Fred Schoenstein from North Fork Welding has created a new sleeve to hold extra rings to replace the original one that had gone missing.

Marjory Stevens spoke with Jim Fenton about making a template for the detailing of inner scenic panels. That was part of the project with those paintings in the middle of the Carousel. There's supposed to be some decorative painting around the -- like trim around the outer part of the panel. Mr. Fenton does a lot of dealing -- detailing work on fire trucks. I don't know if he's done any work for the Village or not, but --

CLERK PIRILLO: Yeah, plenty.

TRUSTEE ROBINS: Okay. And he works with Bill Von Eiff and he said he could create a template to be used for all 14 panels. So I will be coming to talk to you, Sylvia, and to find out

if the committee would be able to have any help from the Village to pay Mr. Fenton for his work.

They -- I spoke with Paul Pallas about the sign for the Carousel, so we had a discussion about that, and he suggested that rather than trying to put a sign up somewhere in the Carousel, a fixed sign, that we do a freestanding one, similar to the ones that they have for the time that the Carousel is open, etcetera. The committee said that that would be acceptable to them and that they would switch. Instead of putting the descriptions about the paintings on a sign, that they would do a map or a small booklet explaining each scene that they could be selling, or, you know, at least on display at the Carousel.

There was more discussion about an anniversary at the Carousel. There's the 100th Anniversary of this particular Carousel is coming up next year. They decided, rather than to do an anniversary of that, that they would think about doing a 20th Year Anniversary of the date that the Carousel was dedicated at Mitchell Park. I don't know if any of you guys remember, but they refreshed my memory. They had a big ceremony there. Governor Pataki actually came to that

ceremony. It was a big deal. So that would be 2021 we're talking about, twenty years from now.

The other one is my report from the BID meeting. This was from already back in November. At that point, they were dealing with the seasonal plantings being changed over in the planters. As you could see, everything looks quite beautiful right now. So that was also part of the preparation of the whole downtown lighting for the Christmas tree and the parade, and everything like that.

They did not add any new lights to the trees this year. However, they did add some more starbursts. If you drive down Front Street now or Main Street and you look up and you see all those bursts, you know, of light, it's really, really bright and pretty, so it's a very good look for little Greenport, I think.

There -- the big thing they're working on right now is the travel show that's coming up at the end of January at the Javits Center. This is the first year the BID's going to have their own booth. It will be a 10-by-10 corner booth. They have a team that are going to be going there to represent the Village at the booth. I'm

considering going in for part of the day myself.

There'll be a rack or a brochure rack, a monitor on a stand that will have a five-minute video loop that will be a story of what's going on here in the Village. There are going to be daily raffles, and they're going -- the photos and stuff, they're going to promote primarily Greenport's fishing, boating and sailing heritage, not our foodie and restaurant culture.

(Laughter)

TRUSTEE ROBINS: Other things we did discuss, giving some money to the Manhattan Film Institute, which is gearing up to do a really great season again this year at the movie theater.

The other thing that they're planning is a fundraiser in March, a 5K run. The theme is going to be "Going Green". It will be on Saint Patrick's Day. So it would be -- you know, that's being led by Barbara Poliwoda. She's a new Board member, and also the Director over at the Maritime Museum.

We had a report on our social media, and the social media for the BID had some amazing numbers, really. There were over 50,000 likes or engagements to the page over the Christmas Parade.

1	That was apparently a really big event, you know,
2	that a lot of people saw. Likes, 400 new page
3	engagement page likes on Facebook, up 34,000.
4	There were 34,061 likes on Facebook. That's up
5	20% from last month. Currently, 8,918 likes.
6	Instagram is up also with 30 over 3500
7	followers.
8	They're working with some new photographers
9	who are going to be doing you see some of
10	these I don't know if anybody follows the BID
11	on Instagram, and they have these Instagram
12	moments, and they're featuring photographs from
13	different photographers that are sending in their
14	photographs to the BID. You know, so you have a
15	constant stream almost every day of new photos,
16	you know, people's take on what they're seeing in
17	the Village, and most people are really loving it.
18	And I think that's about it. As I said, the
19	big thing is the travel show. If anybody is
20	interested in representing the Village, I'll give
21	you a contact number. You could make your
22	contribution and have a little fun in New York
23	City. That's it. Thank you.

When a warning is going to be issued next year, the warning will not be verbal, it will be written. So when people said that they didn't get a warning, they didn't know about it, even though it was verbal, it could be to a manager or a bartender, or whatever, to tell you -- to say to do something. When a warning is issued, it's going to be in writing, so they can't come back and say, "Well, I got a ticket on my first offense, I didn't know about it." And it's going to be like here it was, somebody was there at 9 o'clock on Friday, June 5th, and here's the warning, and we'll have that documented.

TRUSTEE PHILLIPS: Okay.

MAYOR HUBBARD: We will be doing that so that there is no second-guessing of what it was. They really want to know what the -- where the playing field is and what's going on with it.

The Village Clerk spent a lot of time this week reviewing all of the noise complaints that we had, because Rich had asked for that, "How many complaints did you have?" She's compiled it.

1	They're working on putting a spread sheet together
2	with information, we had, you know, "X" amount of
3	complaints. We're also reaching out to Southold
4	P.D. for how many complaints they had, because
5	they wanted to know is it two complaints or is it
6	200 complaints. And, as I told him, I said every
7	Monday morning the emails will go around and there
8	was five or six almost every weekend.
9	TRUSTEE PHILLIPS: Okay.
10	MAYOR HUBBARD: And it's an ongoing issue,
11	and most of them are between 12 o'clock and 2:30
12	in the morning. It's not
13	TRUSTEE ROBINS: Right.
14	MAYOR HUBBARD: you know
15	TRUSTEE CLARKE: It's not 9:30.
16	MAYOR HUBBARD: Most people, they'll
17	tolerate the noise and stuff at a certain point,
18	but then once it gets past midnight. So the
19	suggestion was, that, you know, midnight, boom,
20	move this party inside, close the doors, do
21	whatever you have to do, but, you know, the
22	outside noise will not be tolerated.
23	We also have talked about getting a decibel
24	reader. Paul is investigating that, the cost, the
25	cost of training, what it's going to be to have

1 somebody out there doing it. But it will make it 2 easier for Joe, when he's prosecuting in court, to say the code says this, boom, and at the entrance 3 4 of the edge of your property, it was 62 decibels, 5 or whatever. 6 TRUSTEE PHILLIPS: Okay. Okay. 7 MAYOR HUBBARD: You know, we haven't 8 actually done that yet, but, you know, we're 9 investigating prices, how much training it's going to take. 10 11 And we also have to look at, you know, 12 staffing. If we're going to change parking 13 enforcement until 8 o'clock at night and doing 14 Code Enforcement until midnight, you know, it's a whole different ball game than what we've had 15 16 people on staff. 17 Last time the Village noise ordinance was 18 actually truly enforced was when the Village had a Police Department and all Police Officers on duty 19 20 were trained in that. That goes back to '93? 21 TRUSTEE PHILLIPS: '92. 22 MAYOR HUBBARD: '92, when we did away with the Police Department? All right, '92. 23 24 But when that was done away with, so we close. 25 don't have anybody on staff to do that. So if

1	we're going to be doing this and trying to enforce
2	this every weekend, we're going to need to put in
3	the budget for another part-time Enforcement
4	Officer, and send them to training in order to do
5	that.
6	TRUSTEE CLARKE: On a seasonal basis.
7	TRUSTEE PHILLIPS: Seasonal basis, yeah.
8	MAYOR HUBBARD: Yes, for the summertime,
9	putting somebody on that's going to be there
10	Friday/Saturday, or Thursday, Friday, Saturday, to
11	go out with a noise meter and have the training.
12	So we could end up sending three people to
13	training with a decibel reader, a noise meter. So
14	that's all in the works.
15	But I told Rich that we'd like to if
16	we're going to make code changes, I'd like to have
17	a report back to us for our January meeting, so at
18	February meeting, we could schedule a public
19	hearing for March, and any changes we're going to
20	make, to make those and vote on it in March, so
21	that it's set and everybody knows the playing
22	field for the season in April going forward.
23	TRUSTEE CLARKE: This will require updating
24	of the code?
25	MAYOR HUBBARD: Yes.

1	TRUSTEE PHILLIPS: Yes.
2	MAYOR HUBBARD: If we're going to change the
3	code and say outside right now, I mean, we're
4	in a little catch, because our code from back then
5	says no outside amplified music, but it's never
6	been enforced. And all these restaurants,
7	everybody has the outside music, and that's what
8	they're doing. So now it's being abused, because
9	now its not just one or two places, it's eight,
10	ten places that are doing it.
11	TRUSTEE ROBINS: That's right.
12	MAYOR HUBBARD: So we need to update the
13	code and say, you know, as of midnight, or
14	whatever, change the code to say as of midnight,
15	no outdoor music. You know, if that's that's
16	the general consensus that I got from the meetings
17	that we had talked about.
18	TRUSTEE PHILLIPS: Right.
19	MAYOR HUBBARD: I relayed it to him. He's
20	going to relay that to the business owners
21	downtown and let them know where we're kind of
22	going with it and see what they come back with.
23	TRUSTEE ROBINS: So some of these businesses
24	literally have their music out on a deck, or
25	whatever, okay, and others are actually inside,

1	but they're opening their doors and the music is
2	coming out onto the street.
3	MAYOR HUBBARD: Correct.
4	TRUSTEE ROBINS: So, I mean, you know, when
5	you say, well, you know I mean, it really has
6	to be the noise has to be cut off by you know,
7	by midnight, I mean, and how are you how are
8	you going to prove that? Like I said, you're
9	going to that it can stand up in court? And,
10	you know, how do you the decibel meter will
11	work in terms of proving that even if the
12	complaint that came in wasn't about the particular
13	venue where we're going, okay, if you if you go
14	to that venue and their music is too loud, you've
15	got them on a decibel meter, okay?
16	Because that was it's interesting to hear
17	what you're saying, because Rich came this morning
18	to the meeting and described your meeting and I'm
19	hearing two different stories. I mean, there's
20	certainly common ground, you know, but it sounded
21	a lot different with what Rich brought to the
22	Board.
23	(Laughter)
24	MAYOR HUBBARD: Right. Because they want
25	the noise, they want the business, they want

1	everybody to be so he's trying to be proactive
2	from his side.
3	TRUSTEE ROBINS: Right.
4	MAYOR HUBBARD: I'm trying to be proactive
5	from our side, saying this is what we talked
6	about. His take on it may not be exactly the
7	same, but we will have public hearings on it and
8	everybody can voice their opinions on what we
9	actually propose to do, but that's where we're
10	trying to get everything cut down.
11	TRUSTEE ROBINS: He thought you were very
12	reasonable, so I'm just but what I'm hearing
13	you say right now isn't necessarily what maybe he
14	was thinking. They're looking for common ground,
15	I can tell you that. I mean, that was the
16	consensus
17	MAYOR HUBBARD: Right.
18	TRUSTEE ROBINS: at the end of the
19	meeting. We have to find a way, you know, where
20	you're not going to totally, you know, throw the
21	businesses under the bus, you know, and still
22	listen to the people who live here, you know
23	MAYOR HUBBARD: Right.
24	TRUSTEE ROBINS: who are entitled to
25	peace and quiet at a certain hour. So I did say,

1	I said I believe there will probably have to be a
2	code change here of some sort, you know, so.
3	MAYOR HUBBARD: Okay. Well, I can
4	because Joe and Paul were there. I mean, is that
5	basically how
6	ADMINISTRATOR PALLAS: Yeah.
7	MAYOR HUBBARD: our meeting went? I
8	mean, I just
9	ADMINISTRATOR PALLAS: Yeah.
10	ATTORNEY PROKOP: The points that were made,
11	which Mayor Hubbard just mentioned, were repeated
12	several times so we all knew what they were. It
13	wasn't
14	ADMINISTRATOR PALLAS: Yeah.
15	TRUSTEE ROBINS: I'm sure. You know, I'm
16	just smiling at what
17	TRUSTEE CLARKE: I recognize that we're
18	listening to Mary Bess' report. Could you indulge
19	me for just one other comment on this subject?
20	Mary Bess shared an article about sort of
21	the tipping point in communities between mixed
22	use, retail, and the actual legislation of how
23	many food and drink establishments can be within a
24	Business District.
25	TRUSTEE PHILLIPS: Yeah.

1	TRUSTEE CLARKE: And the case in point
2	was I don't remember the municipality.
3	AUDIENCE MEMBER: Babylon.
4	TRUSTEE PHILLIPS: Babylon? I don't
5	remember.
6	TRUSTEE CLARKE: Thank you for whoever
7	shared that.
8	TRUSTEE PHILLIPS: Babylon.
9	TRUSTEE CLARKE: It was in the Village of
10	Babylon. I just wanted it go on record just to
11	on this subject. We are also at a very dangerous
12	tipping point of the commercial property being
13	increased in value due to the significant increase
14	in food and beverage businesses has caused rents
15	to rise to where it's becoming prohibitive for
16	retailing, unless it's national or chain
17	retailing, which is also not in our character,
18	so otherwise known as the Montauk Syndrome
19	TRUSTEE PHILLIPS: Yeah.
20	TRUSTEE ROBINS: Right.
21	TRUSTEE CLARKE: which they're still
22	trying to recover from. So I'm all for a good
23	time, I'm all for music, I'm all for drinking and
24	eating and having a good time. I'm right up there
25	with the rest of the people when it comes to that,

1	but there is a point where we will no longer have
2	a community that really serves those who live here
3	full-time, or even seasonally, or even part-time,
4	for the sake of driving business for visitors.
5	And that's something that we can't get into now,
6	but it's something that's very close to my heart,
7	and that I brought with me onto the Board this
8	year as something I'm very concerned about, and
9	would like to look at that at a time when time
10	allows.
11	MAYOR HUBBARD: Okay, that's fine. Also, I
12	can say we did mention to him that our Marina was
13	suffering because of noise complaints and people
14	leaving the Marina because of the noise
15	TRUSTEE PHILLIPS: Right.
16	MAYOR HUBBARD: on both sides, which has
17	a big impact on what we do with the whole Mitchell
18	Park area.
19	TRUSTEE CLARKE: Absolutely.
20	MAYOR HUBBARD: So, you know
21	TRUSTEE ROBINS: And I told them, too, I
22	said the only check that we have right now of what
23	you're doing in your business is when you go to
24	the Planning Board and you check off that you're
25	going to have music. And I think when that

1	question went on there, we weren't thinking about
2	the kind of music that they're talking about right
3	now. And I told them, I said, you know, when the
4	restaurant stops serving food at 10 o'clock, or
5	whatever, and then it's strictly music and drinks,
6	it becomes a nightclub, it's not a restaurant
7	anymore.
8	TRUSTEE PHILLIPS: Which is something that
9	you and I have had a discussion
10	TRUSTEE ROBINS: Yep.
11	TRUSTEE PHILLIPS: and Peter and I in
12	just in just talking about it, is there a point
13	we need to designate between what's called a
14	nightclub and what's called a true restaurant? I
15	mean, you know, that could be another topic that
16	needs to get thrown in. But I think, at this
17	point, you know, that's just a discussion point,
18	it's not
19	TRUSTEE ROBINS: No, no, I get it.
20	TRUSTEE PHILLIPS: That's
21	TRUSTEE ROBINS: I mean, you know, the thing
22	is the time is now, though, because, I mean, the
23	summer will be upon us, you know. And so, really,
24	in these kind of off-season months is the time
25	when we really need to put our heads together

	, , ,
1	and
2	MAYOR HUBBARD: That's why we had the
3	meeting with him.
4	TRUSTEE ROBINS: Yep.
5	MAYOR HUBBARD: We're going to compile the
6	information. The Village Clerk will get that
7	information out to us and to the BID
8	TRUSTEE PHILLIPS: Okay.
9	MAYOR HUBBARD: so they can review it and
10	look at how many complaints there were and what
11	we're doing. I mean, this past year, we had more
12	complaints than we ever had before, because people
13	are utilizing the Village website. But then,
14	also, you know, the Village Attorney brought up
15	that sometimes people, after they complain five or
16	six times, they give up complaining
17	TRUSTEE PHILLIPS: Right.
18	MAYOR HUBBARD: and they're not getting
19	the complaints, which is, you know, also a valid
20	point, so, you know. So we'll get the information
21	together, get it around to everybody the beginning
22	of the year and we'll continue the conversation.
23	TRUSTEE PHILLIPS: Good. I'm glad to hear
24	that.
25	TRUSTEE CLARKE: I appreciate the update.

1	TRUSTEE ROBINS: Thank you.
2	TRUSTEE PHILLIPS: I do, too.
3	TRUSTEE CLARKE: I would say we should
4	consider we're at a point where we actually
5	should consider, just to get people thinking about
6	it, a moratorium in the Business District of more
7	food and beverage development. Just want to put
8	that on the table.
9	TRUSTEE PHILLIPS: Boy, that came out the
10	other day.
11	(Laughter)
12	TRUSTEE ROBINS: We were talking about this
13	the other day.
14	TRUSTEE PHILLIPS: We were talking about
15	that the other day. Okay. Thank you. Thank you
16	for the update. I'm glad to see that moving
17	forward, and we need to discuss things like that.
18	The net metering, that was something that I
19	brought up, January. You know, that's it's an
20	idea to throw out.
21	One point that I do want to make is I was
22	listening to the Planning Board meeting, and ${f I}$
23	have listened to I do listen to all the Board
24	meetings, and there has been a frustration
25	expressed by some of the members dealing with our

1	Article 150-12 and 150-16, I think it is, of our
2	exemption of certain properties from parking. I
3	think that both the Planning Board and I know the
4	Zoning Board has dealt with the issues many times,
5	and it's probably something that we need to look
6	at. It probably is going to tie into what Peter
7	was just mentioning about the, you know,
8	restaurants and seating, and I think it's just
9	time we need to discuss it. Whether we change it
10	or not, that would be a decision down the road,
11	but I think we need to hear from the Planning
12	Board Chair maybe some of the frustrations that
13	they've had to deal with, with dealing with some
14	of their site reviews. So I was just I don't
15	know. They had said something about writing a
16	letter. Did they write a letter to the Mayor and
17	the Board or no?
18	ADMINISTRATOR PALLAS: I don't believe
19	they've penned it yet.
20	TRUSTEE PHILLIPS: Okay.
21	MAYOR HUBBARD: No.
22	TRUSTEE PHILLIPS: Okay. All right, so
23	MAYOR HUBBARD: No, nothing's been received
24	yet.
25	TRUSTEE PHILLIPS: Oh, okay.

1	MAYOR HUBBARD: But Paul can reach out to
2	the Chairman of the Board and see if they have
3	something they want to discuss and
4	ADMINISTRATOR PALLAS: Yep, I will do that.
5	MAYOR HUBBARD: bring it forward to us.
6	ADMINISTRATOR PALLAS: Yep.
7	TRUSTEE PHILLIPS: Okay.
8	MAYOR HUBBARD: We'll take the
9	recommendations and we'll discuss it.
10	TRUSTEE PHILLIPS: Okay. That's it for me.
11	MAYOR HUBBARD: Okay. Thank you.
12	Okay. Most of my stuff has been covered. I
13	did have we had a meeting, the Village
14	Administrator and myself, with someone that's
15	interested in possibly taking over and running our
16	Marina for us, instead of us handling that, not
17	the park itself, but handling the Marina part.
18	The Village Treasurer is working on numbers
19	and figures of what we would actually need to
20	cover maintenance, bond payments, everything else
21	that we have. We did talk about it briefly at the
22	Audit Committee meeting. I just want to let the
23	rest of the Board members and the public know that
24	somebody has approached us of possibly running the
25	Marina part of it and paying us rent for it, and

1	we would be out of actually running the Marina.
2	They feel they could fill the slips up all week,
3	instead of just filling it up on weekends. They
4	have a market to put people in on Tuesday,
5	Wednesday and Thursday, when typically our Marina
6	is not full.
7	TRUSTEE MARTILOTTA: Somebody didn't we
8	do this years ago?
9	TRUSTEE ROBINS: A couple of years ago.
10	MAYOR HUBBARD: It was talked about when
11	we
12	TRUSTEE MARTILOTTA: Okay.
13	MAYOR HUBBARD: When the Marina first
14	opened, when
15	TRUSTEE MARTILOTTA: I thought it was
16	MAYOR HUBBARD: No.
17	(Laughter)
18	MAYOR HUBBARD: When you
19	TRUSTEE MARTILOTTA: I missed it.
20	MAYOR HUBBARD: first got on the Board
21	and everything else, it was discussed, and it was
22	like no. At that point, bond payments were too
23	high, Marina revenue was going up and everything
24	else, and we were covering that. After the
25	refinancing of the bond payments down there, the

1	cost to us has come down and Marina revenue has
2	gone up.
3	TRUSTEE MARTILOTTA: Yes.
4	MAYOR HUBBARD: So it's been better. But
5	there is a lot of you know, there's empty boat
6	slips a lot of times midweek and everything else.
7	And so it's a discussion that we're going to
8	continue. We really need to do the financial
9	analysis, which is coming from the Treasurer's
10	Department, to see what we need, what number we'd
11	even be talking about to see how we would actually
12	word a contract or whatever.
13	But it's just throwing it out there, so
14	that, you know, the people that are interested
15	know we're discussing it. I said I'd bring it up
16	to the whole Board. The Village Treasurer is
17	working on numbers, and we'll continue that
18	discussion.
19	TRUSTEE PHILLIPS: Okay.
20	MAYOR HUBBARD: The other thing is Johnson
21	Tree has started work on the tree bid that has
22	been out there, cutting down, grinding stumps.
23	They're already working on that, so that,
24	hopefully, that stuff will all be taken care of.
25	Those dangerous trees will be gone before we get

1	into the dead of winter and everything else. So I
2	want to just update everybody that they are
3	working on it and we're moving forward with that.
4	Okay. That's all I have. We'll open up
5	to
6	ATTORNEY PROKOP: I just have one thing.
7	MAYOR HUBBARD: Oh, yeah, go ahead.
8	ATTORNEY PROKOP: I forgot to mention, and I
9	hope she doesn't mind me mentioning this, but
10	Lucia Braaten, our Transcriptionist, if I'm
11	please correct me if I'm wrong, but she received a
12	commendation from Suffolk County, the Suffolk
13	County Legislature on her many years of service,
14	excellent service to as a the
15	Transcriptionist also for the Suffolk County
16	Legislature. And I don't want to mention the
17	number of years, but it's impressive work that
18	she's done, and she the full Legislature voted
19	to award her a commendations for her work.
20	TRUSTEE PHILLIPS: Congratulations.
21	TRUSTEE MARTILOTTA: Congratulations.
22	TRUSTEE CLARKE: Congratulations.
23	TRUSTEE ROBINS: Congratulations.
24	TRUSTEE CLARKE: Congratulations.
25	MAYOR HUBBARD: Congratulations. Thank you.

1	(Applause)
2	MAYOR HUBBARD: Okay. Now we will open to
3	the public to address the Board.
4	MR. BULL: Welcome. Good evening. I
5	address you first as the Chair of
6	MAYOR HUBBARD: Just name for
7	MR. BULL: Ah, Stephen Bull.
8	MAYOR HUBBARD: And address.
9	MR. BULL: 24 Sandy Beach. I address you
10	first as the Chair of the Historic Preservation
11	Commission. So tonight the Commission has passed
12	a resolution to give to the Mayor and to the
13	Trustees the guidelines that we've been working on
14	for your comment and approval, that we would hope
15	that we could get that at the meeting that you
16	will be having in January, so that we could
17	proceed with those guidelines, or make changes, if
18	there are some parts of it that you feel need to
19	be changed. And at that and part of that will
20	be a discussion of the presence on the website of
21	these guidelines, so that they'll be available for
22	the public, and also brochures that might be also
23	created, so the public knows that they could find
24	these guidelines on the website, and other parts
25	of that promotion, which might also include some

public presentations for people who might have questions about that.

So now I'm going to change my hat and talk to you a little bit about some news I heard today, which I'm not sure everyone has heard, but some people have heard, and this has to do with the grant. I heard that the Village of Greenport has received a grant on the sewer project. And I've been working with, you know, both in the community which I'm in, which is Sandy Beach, and also working with the Marina, and also working with Paul and the Village about this sewer project.

And, Paul, what was the amount that we got?

ADMINISTRATOR PALLAS: I believe it was 390,000.

MR. BULL: So we received \$390,000 as a grant to take this project forward. And so I would like the -- to -- I would ask that the -- that we continue to deal with this grant that we have, that we come up with a schedule of the implementation of the grant, that we would use a portion of the grant to come up with a shovel-ready bid that we could, and that we work with our partners to see how we're going to finance it, and see what they're going to be

1	bringing to the party, and make this possibility
2	of a sewer for the peninsula, the only part of
3	Greenport that isn't on the sewer, and how, how
4	we're going to make that happen with everybody's
5	pitching in and doing their little bit on that
6	project.
7	So if that could be put on the agenda for
8	January, some plan about going forward on this, as
9	a resident of Sandy Beach, I would appreciate
10	that.
11	TRUSTEE PHILLIPS: Mr. Mayor, may I ask a
12	question? We I haven't seen anything.
13	TRUSTEE MARTILOTTA: I haven't seen
14	anything.
15	TRUSTEE PHILLIPS: We haven't seen anything,
16	Stephen, so
17	MR. BULL: I know. So we will see
18	something.
19	MAYOR HUBBARD: I mean, the paperwork will
20	be circulated. Paul will circulate it to
21	everybody.
22	TRUSTEE PHILLIPS: Okay.
23	MAYOR HUBBARD: Because we need to find out
24	what the grant can be used for and everything
25	else. We have to go through the particulars

on it.
TRUSTEE PHILLIPS: Okay.
MAYOR HUBBARD: This is something that Paul
told me he got an email at 5:30 today.
TRUSTEE PHILLIPS: Okay.
MAYOR HUBBARD: He told me about it when I
walked in the door.
TRUSTEE PHILLIPS: Okay.
MAYOR HUBBARD: So I haven't seen it.
Nobody's seen anything yet.
TRUSTEE PHILLIPS: Okay. All right. So
MR. BULL: Yeah, I haven't seen anything
either.
TRUSTEE PHILLIPS: If we're anticipating
something for January, I would kind of like, you
know
ADMINISTRATOR PALLAS: If I may clarify.
What we weren't officially notified. There is
a publication that the State puts out from the
consolidated funding application process that
lists awardees. We have I have not received
TRUSTEE PHILLIPS: Okay.
ADMINISTRATOR PALLAS: This is just a
listing of all grants that they I assume that
they will be sending paperwork on. You know, it's

1	150 pages long of all the throughout New York
2	State, what grants have been they anticipate
3	awarding, so but no official paperwork has been
4	delivered to the Village.
5	TRUSTEE PHILLIPS: Okay, thanks.
6	MAYOR HUBBARD: Okay. No, that's fine. I
7	mean, it's a very positive thing. You know,
8	congratulations to everybody
9	TRUSTEE MARTILOTTA: Yes, sir.
10	MAYOR HUBBARD: that worked on that
11	trying to get it. It's a step in the right
12	direction. But now we need to get the paperwork
13	and everybody see it, and then we can discuss
14	where we're moving forward with that.
15	MR. BULL: Exactly. Congratulations to
16	Paul
17	MAYOR HUBBARD: Yes.
18	MR. BULL: and the staff here for putting
19	that grant in place.
20	MAYOR HUBBARD: Sure, yes.
21	MR. BULL: And for the hard work that was
22	done in order to possibly get the reward, which
23	we'll read about soon.
24	MAYOR HUBBARD: Exactly, yes.
25	MR. BULL: Thank you.

1	MAYOR HUBBARD: Okay. Thank you.
2	TRUSTEE CLARKE: Thank you, Stephen.
3	MAYOR HUBBARD: Anybody else wish to address
4	the Board?
5	MR. WEISS: Good evening.
6	TRUSTEE CLARKE: Good evening.
7	MR. WEISS: Stephen Weiss, Stephen with a
8	P-H, 117 Sterling Street, Greenport. I'm
9	curious
10	MAYOR HUBBARD: Okay. Can I just before
11	you start, I just want to give some information.
12	I know you gentlemen are here to speak about
13	123 Sterling. If that's the topic, to let you
14	know, we were served with Article 78 paperwork.
15	The Village Planning Board, Zoning Board, and
16	Village Board are being sued by neighbors down on
17	that property. And we are not going to be able to
18	answer questions, because there's pending
19	litigation on that project. You're welcome or
20	whatever, but we are not going to be answering
21	questions because of the pending lawsuit
22	against us.
23	MR. WEISS: Okay. Thank you.
24	MAYOR HUBBARD: Okay, yep.
25	MR. WEISS: Has the 123 consultant been

1	brought on board yet, Holzmacher?
2	MAYOR HUBBARD: Yes.
3	MR. WEISS: Have they started work yet?
4	MAYOR HUBBARD: Yes.
5	MR. WEISS: Have they been on the site and
6	done testing yet?
7	ADMINISTRATOR PALLAS: No.
8	MAYOR HUBBARD: No. They're reviewing plans
9	and stuff.
10	MR. WEISS: They're reviewing plans and the
11	building permit?
12	ADMINISTRATOR PALLAS: Yes.
13	MAYOR HUBBARD: Yes.
14	MR. WEISS: Merry Christmas.
15	MAYOR HUBBARD: Same to you. Thank you.
16	TRUSTEE CLARKE: Same to you. Thank you.
17	MAYOR HUBBARD: Anybody else? Yeah, go
18	ahead.
19	MR. KULSZISKI: I'm Charlie Kulsziski from
20	433 Main Street, and it's K-U-L-S-Z-I-S-K-I.
21	So you're all talking about noise today,
22	which is why I came here. And across the street
23	from me a restaurant opened this past season
24	that's called Bar Three Fourteen, and they
25	advertise as an after-hours club, and they

advertise as selling nibs, which I assume is 1 2 nibbles. And they have speakers on the outside of 3 their building, which according to the code says 4 that they can't have speakers on the outside of their building. They also have a stage built for 5 6 live bands. So four nights a week they're 7 blasting the music that shakes my house. 8 I know that they are in some kind of court 9 thing, but I haven't found out from the Village 10 what that is, and I haven't found out from 11 Southold what that is. I haven't found out if I'm 12 allowed to be present to hear what's actually 13 being said. And I still see the stage and I still 14 see the speakers on the outside of the building. And I'm thinking that May 15, when they 15 16 begin their season again, they just closed, that 17 they're going to start up again. So I went 18

begin their season again, they just closed, that they're going to start up again. So I went through the whole season listening to it with seemingly nothing being done, even though it is against their site plan and against the code. So I'm wondering if anything is being done about that?

MAYOR HUBBARD: Okay.

ATTORNEY PROKOP: About 20, 20 tickets were issued, approximately 20 tickets were issued, it

1	might be 18.
2	MR. KULSZISKI: Yeah. I have
3	ATTORNEY PROKOP: But I'll use the number
4	20, and they covered all of the things that you
5	just mentioned.
6	MR. KULSZISKI: So who issues I'm sorry.
7	ATTORNEY PROKOP: The case is they do
8	have an attorney who's been appearing. It was
9	scheduled, the case was scheduled yesterday for a
10	pretrial conference, because the attorney said
11	that he wanted a trial. At the pretrial
12	conference he said that that they would be
13	he expected that they would be pleading guilty to
14	the charges. And I gave him a form called a
15	Conditional Discharge form, which in which they
16	would have to I'm sorry. They would have to
17	enter an agreement that would be so ordered by the
18	court, and in that in the proposed order, they
19	would have to get Planning Board approval for
20	anything that's there that they don't have
21	approval for now, Historic Preservation Committee
22	approval, and remove anything that doesn't get
23	approved.
24	The whole all of the violations and the
25	fact that they've been pending for so long has

1	also been referred to the SLA by the Village.
2	MR. KULSZISKI: SLA?
3	ATTORNEY PROKOP: State Liquor Authority.
4	TRUSTEE PHILLIPS: State Liquor Authority.
5	MR. KULSZISKI: Oh, okay, yeah.
6	ATTORNEY PROKOP: We got a notice from the
7	State Liquor Authority that they had made an
8	application for a liquor license approval
9	renewal, and I sent the package to the SLA, which
10	included copies of all the violations that had
11	been issued, and also the fact they have been
12	pending for so long without resolution.
13	MR. KULSZISKI: So the violations, is that
14	something from the Southold Police, or is that
15	from our Code Enforcement Officer?
16	ATTORNEY PROKOP: It's from our Code
17	Enforcement Officer.
18	MR. KULSZISKI: So he finishes work at
19	5 or 6, and they have outside music that goes
20	until 2 or 4 in the morning. And I remember once
21	he did show up when I was around, but they didn't
22	have the outside music at that point, so I guess
23	they were behaving themselves.
24	ATTORNEY PROKOP: So he has unscheduled
25	there are unscheduled nights that he works late at

1	night.
2	MR. KULSZISKI: Four nights a week during
3	the whole summer?
4	ATTORNEY PROKOP: It's not scheduled. It's
5	depending what we think the need is.
6	MR. KULSZISKI: I see. And then as far
7	as
8	ATTORNEY PROKOP: Actually we I should
9	say we work, because he's supported by staff.
10	There's not he's not on his own, he's supported
11	by staff.
12	MR. KULSZISKI: Okay. So as far as the
13	decibel thing, you don't really need a decibel
14	meter to tell. Like my house shakes. You can't
15	stand on my front porch without and have a
16	conversation, because the music is so loud. But I
17	think that a lot of people in the community would
18	be interested in volunteering as a decibel meter
19	or a Code Enforcement Officer to walk around and
20	check out certain places with noise. So if the
21	budget is something with that, I think a lot of
22	people would probably be interested in it.
23	ATTORNEY PROKOP: So the case in court is
24	called Khedouri, K-H-E-D-O-U-R-I. It's not under
25	314, it's under Khedouri Ezair or but the first

1	word is Khedouri.
2	MR. KULSZISKI: Okay, yeah. When I've gone
3	to the Southold Court, they just post what's there
4	on that day, they don't post like upcoming. So
5	it's hard to tell when something is actually going
6	to be unless you go every day. Is there some
7	kind of schedule that I don't know about where it
8	would be
9	ATTORNEY PROKOP: They have a court day
10	in the next court date is in January. I forget
11	if it's January 8th or January it's a
12	Wednesday. I forget if it's the 8th or the 15th,
13	but it's I believe it's one of those days.
14	MR. KULSZISKI: Maybe I can drop a letter at
15	Town Hall for you and you could let me know when
16	it is.
17	ATTORNEY PROKOP: At Village Hall.
18	MR. KULSZISKI: At Village Hall, I'm sorry.
19	And then the other thing which you also
20	brought up was density. So on my block, within
21	half a block of my house at 433 Main Street,
22	there's either nine or eleven liquor licenses. So
23	that's more than 50% of the businesses are right
24	now bars. And the owner of Three Fourteen told me
25	that it's now supposed to be called Bar Row, and I

	1	think that's a huge change to the neighborhood.
	2	And when I hear certain things discussed at these
	3	meetings which go in front of the community, I
	4	feel like this is a really big change to the
	5	block. And I've only heard that from her,
	6	Bar Row, but it seems now that I'm counting the
	7	actual liquor licenses, and it's going over the
	8	50% mark, I think people are probably going to
	9	start calling it that. And that's it.
1	.0	MAYOR HUBBARD: Okay. Thank you.
1	.1	TRUSTEE CLARKE: Thank you very much.
1	. 2	MR. KULSZISKI: Thank you very much.
1	.3	MAYOR HUBBARD: Okay. Anybody else wish to
1	.4	address the Board?
1	.5	MR. MACKEN: Hello. How are you doing?
1	.6	Frank Macken, 138 Sterling Avenue.
1	.7	So I asked a question or I brought up an
1	.8	issue as regards accessory buildings, accessory
1	.9	apartments back in September, and I was wondering
2	20	if anything had I haven't seen any discussion
2	21	since about that. I know that, you know, I had
2	22	asked that this be considered, and that our vision
2	23	of the code be considered, but I haven't seen any
2	24	mention of that in any of the subsequent work
2	25	sessions or Boards.

1	MAYOR HUBBARD: Yeah. There's been no
2	discussion on changing the code on that at all. I
3	mean, by code, they're not allowed.
4	ADMINISTRATOR PALLAS: Right.
5	MAYOR HUBBARD: And that's there's been
6	no change on that.
7	MR. MACKEN: Well, no. But the issue was
8	that the issue that I brought up was that
9	the in a revision, a recent revision of the
10	code, accessory buildings and accessory
11	apartments, which do exist, and numerous do exist
12	in the Village, had been written out of the code,
13	effectively written out of the code, and were not
14	dealt with in the code, and that was my question.
15	I mean, you can't just, you know, pretend
16	something doesn't exist by and write it out of
17	existence. It needs to be
18	MAYOR HUBBARD: We haven't changed the code
19	on that, so nothing's been changed.
20	MR. MACKEN: But it was. But I'm saying
21	that the code was changed, and in the revision,
22	accessory buildings and accessory apartments were
23	removed from the code. They don't they're not
24	mentioned in the code.
25	MAYOR HUBBARD: Okay. When was the code

1	changed? I'm just asking, when was the code
2	changed?
3	MR. MACKEN: A couple of years ago, just
4	very recently.
5	MAYOR HUBBARD: No. I don't believe that
6	we've changed the code
7	ADMINISTRATOR PALLAS: No.
8	MAYOR HUBBARD: to outlaw accessory
9	buildings.
10	ATTORNEY PROKOP: There was discussion, but
11	nothing took place.
12	MAYOR HUBBARD: No, there wasn't. There's
13	been no code change that
14	TRUSTEE PHILLIPS: I don't remember one. I
15	know there was a lot of discussion about things,
16	and there was some reaching out years ago in the
17	previous administration, but I don't know where it
18	went from there.
19	MR. MACKEN: Well, the issue was under the
20	Nyce Administration, towards the end of the Nyce
21	Administration, basically overnight, this
22	two-family in one structure was brought in and the
23	code was revised. I mean, if you look at the code
24	now, there's actually no mention of whereas,
25	under the Kapel Administration, accessory

1 buildings were dealt with and, you know, were 2 legal to convert and accessory apartments. ATTORNEY PROKOP: The code on that point 3 4 hasn't changed. 5 MR. MACKEN: But then under the Nyce 6 Administration, it just -- it just went --7 ATTORNEY PROKOP: The code hasn't changed. 8 The code hasn't changed on this. Those points 9 that you're mentioning, I agree with the Mayor, 10 the code hasn't changed. What was -- what was 11 happening and what was then not happening, you 12 know, is one thing, but the code, the code has not 13 been changed. 14 MR. MACKEN: Okay. Well, okay, that was my 15 understanding of it, and that's what my lawyer 16 told me and my architect told me, basically, that this is what had happened, and -- but, in any 17 18 case, you know, the -- as I -- I think it 19 was the September meeting, I described how the 20 Kapel Administration had a much more hands-on and 21 positive attitude towards these structures, and 22 there's something like two, three dozen of them in 23 the Village, and numerous -- about half of them 24 have been actually legalized. But since then, 25 since the Nyce -- some time in the Nyce

Administration, this was -- this was changed, and it was made far more difficult. And, effectively, the code doesn't address them anymore, whereas in Southold they do and in other communities in the East End they do, or in eastern Suffolk at least.

So, I mean, my point is that like it needs to be looked at. I mean, there's, you know, a curious situation where you have these structures. As I pointed out in September, like if you went back to the minutes, it was -- there was a whole discussion of it, and it was back and forth with you and several other members. That, basically, you know, this is a ready, a ready source, and people talk about affordable housing, on the affordable housing issue; that these are actual structures that exist in the building and could be brought into the housing stock, but, I mean, held out, simply because they're not addressed and they're excluded under the -- under the -- this kind of blanket.

You can only have a two-family structure -two-family units within one structure on the
property. But the thing is that accessory
apartments aren't -- is not -- is a separate thing
to a two-family. So I'm just saying that like

that's what I was asking. I thought this was -we had got to a point in the September meeting
where this was -- where you guys were going to
look into it and see if you get a positive
reception.

MAYOR HUBBARD: It was discussed and it was talked about, and that's as far as it had gone at that point, I mean, because the idea of the code, the way the code was written was that so people, if they have a big backyard, that they don't put two small cottages in the back and start renting all other properties out. You have the piece of property, you can have a two-family house on it, and that's the only structure that's allowed to be inhabited, so people don't just go and start making other apartments in the back of their yards. That's what the intention of the code was and that's what's being enforced now.

MR. MACKEN: Well, I think that was probably why it was -- it was -- that's why this approach was taken, was to stop people building other things. But given the fact that there are numerous, you know, separate structures, you know, cottages, call them cottages, call them barns, whatever you -- whatever you will, but they exist

1	on the property, you know. And the issue was
2	unless you connect the main house to the to
3	that structure, which can be you know, they
4	could be a distance away, but if those are, you
5	know, of the appropriate size and appropriate
6	you know, appropriate for housing, then why would
7	you not want to why would you just not want to
8	utilize them?
9	MAYOR HUBBARD: Right. I think the
10	intention was because people said they want to put
11	a shed in, and all of a sudden a year later the
12	shed became an apartment, or a pool house was just
13	a pool house, and then somebody was living in
14	there.
15	MR. MACKEN: Yeah, I know.
16	MAYOR HUBBARD: And the idea was to stop the
17	overcrowding and the illegal use of properties,
18	because you wouldn't know somebody was actually
19	living in the shed. They're not supposed to be
20	there with a kitchen or running water, and other
21	things like that. That's how the code is written,
22	and that's the way the Building Department is
23	enforcing it now, because that's what the
24	intention of the code was. That's
25	MR. MACKEN: Right. Yeah, somebody putting

an apartment above a garage or something, yeah, I know, I get that. Like, you know -- but, I mean, you know, the Kapel Administration had a different approach to that.

MAYOR HUBBARD: Okay. I mean, but that's also going back. That's pre-2007 when he got out. And what they were doing back then, there was a different Building Department, there was different people there. Right now, we're trying to just enforce what's on the code and issue permits for what's legal to be built and moving forward. That's what we're trying to do.

I mean, if you want to put together a letter and send it to the whole Board, they could discuss it. But if somebody really wants to do something, they could appeal to the Zoning Board for a variance to add something to do something else and go through the legal channels of doing it. But at this point right now, that is what the code is and that's what's being enforced.

MR. MACKEN: Right, but that's where I've been for the last 18 months is in the ZBA, you know, and I've got -- just got nowhere. So that's why I came to you guys. But, basically, you know, it's just like running around in circles.

1	MAYOR HUBBARD: So the ZBA denied your
2	application?
3	MR. MACKEN: The ZBA is like kind of caught
4	in this kind of no man's land, because where
5	they can't address it.
6	TRUSTEE MARTILOTTA: What?
7	TRUSTEE PHILLIPS: What?
8	MAYOR HUBBARD: I don't remember seeing it
9	on the ZBA agenda.
10	TRUSTEE PHILLIPS: I don't see it on the
11	agendas.
12	MR. MACKEN: Well, I didn't make this up.
13	MAYOR HUBBARD: Is there an application in?
14	Well, let me just ask the Village Administrator.
15	Is there an application in on his property to go
16	to the ZBA?
17	ADMINISTRATOR PALLAS: There are he's
18	been they've been before the ZBA a couple of
19	times. There's some changes that were requested
20	of the application and I we haven't received
21	those, the changes yet.
22	MAYOR HUBBARD: All right. So there's not
23	an application that's before the ZBA right now.
24	ADMINISTRATOR PALLAS: Not pending, not at
25	this moment.

1	MR. MACKEN: There is. Yes, it's current.
2	ADMINISTRATOR PALLAS: Okay.
3	MR. MACKEN: There's a current application,
4	but the issue is in terms of an area variance or a
5	use variance, and that's where it got caught up
6	where the ZBA Attorney was saying it's an area
7	variance, but the Village was saying it's a use
8	variance.
9	MAYOR HUBBARD: Well, that's up to the
10	Attorney to look at the application and decide
11	what that is. The Attorney for the ZBA would give
12	an answer to that.
13	MR. MACKEN: The Attorney is giving two
14	different Attorneys giving I mean, the practice
15	is in general in the East End that they're dealt
16	with as an area variance, it's not but in the
17	Village
18	MAYOR HUBBARD: Okay. Well, there's one
