(The meeting was called to order at 7:00 p.m.)
MAYOR HUBBARD: I'd like to call the meeting to order. Pledge to the flag.
(A11 stood for the Pledge of Allegiance) MAYOR HUBBARD: Please remain standing for a moment of silence for Edward Alaia, Former Village Justice Frederick Tedeschi, Peter John Jauquet, Dorothy Munafo and Irene Murray.
(A11 remained standing for a Moment of Silence)

MAYOR HUBBARD: Thank you. You may be seated. Okay. I've got a few announcements, and then I'm going read the Tree Committee Annual Report to the Board, and then we' 11 move on.

Under Announcements:
The annual tax 1 ien sale will be held on -at 10 a.m. on March 13th.

Mary Given has been appointed as the Chairperson of the Planning Board.

Walter Foote has been appointed to the Planning Board.

Kindly note that, for the safety of that and that of your family, it is best to ensure the legibility of numbers at your house location.

That just comes in handy when the Fire

Department, if they don't know your house, they have a name. If they can't see the number, if there's branches, trees blocking it, and they're looking for a certain number of the house, it just expedites Police and Fire Department, anybody else getting to your -- to your house.

At this time, I would like to read the parts, and I'm not going to read the whole thing, it's four pages, but just highlights from the Tree Committee report.

This is the 2017 Annual Report to Mayor Hubbard and Trustees.
"The Village of Greenport Tree Committee is pleased to present this report of its activities in 2017, hopefully, our eleventh year in a row to earn the Tree City USA designation. Added to
three earlier awards, we have won 14 Tree City awards.

The main mission is removal of trees.
There have been more than 253 trees removed since the reestablishment of the Tree Committee in 2007, including 13 in 2017. The Road Crew removed several trees on Main Street, in conjunction with some extensive reconfiguration of concrete. The Tree Committee plans to add new trees in this area in the spring, as well as Front Street and the Fire Department grounds.

Since the reinception of 2007, the Tree Committee has planted over 452 trees, including two in 2017. They planned on more, but the NYPA Tree Program was cancelled, so that we did not get the extra trees that we were planning on for that.

Maintenance and Pruning: To maintain proper pruning and care for the existing trees that grace our Village is a huge task. By supporting judicious pruning, we can help preserve our existing tree canopy.

Community Support and Collaboration:
Greenport Tree Day/Arbor Day 2017 ceremonies were held at Greenport School, marking the 25th-plus
year of visiting the 4th Grade and delivering a basic lesson on the importance of our trees. The 4th Graders each received a white spruce sapling and instructions how to plant it at home.

Also, as part of Arbor Day celebration, the committee provided a Crimson King Maple, and helped the class of 2017 plant its Senior Tree at Greenport High School, joining the trees planted over 30 years, which create a beautiful ring around the campus perimeter.

Memorial Planting: A much respected and beloved former Greenport High School teacher passed away this year, and the committee voted unanimously to offer a memorial tree to his family, in the person of his daughter, who is now a teacher at Greenport School. The tree was given a site of honor by the school, and it, too, was part of our Arbor Day Program. Plaques were provided to identify several memorial trees.

Just there's no name on that, but that was for Mr. Gary Lillis, who was a teacher at the school. He also drivers ed for over 20 -something years. And I know my daughters had him, along with almost everybody else in Greenport that had kids who went to the school. Mr. Lillis was a
very important part of this school. Always had a smile, and did wonders for all the children in the community.

The Spring Flowering Tree Festival: We brought attention to our annual beautiful festival by mapping all trees in the Village.

Resource Enhancement: Committee Member Jane Ratsey Williams developed an almost indestructible tote bag with our logo for sale as a fundraiser. Especially timely, as 2017 was the ending of -- ending and plastic bags were being banished. Not quite, but close. Totes have become -- proven popular, and can be bought at the IGA, Hoppy's Cleaners, Village Hall, or from any of the Tree Committee.

The committee thanks Mayor Hubbard and the Board of Trustees for their continued support. Respectfully submitted, January 2018, by John Quinlan, Village Tree Committee Chair, Polly Dixon, Jack Weiskott, Jane Ratsey Williams, Joe Cherepowich, and George Hubbard as Mayor.

Also, there's an invitation to join us for Greenport's Second Annual Cherry Blossom Festival throughout the Village, which is going to be from May 1st through May 15th, 2018. There'11 be maps
that will be available at local stores and Village Hall, where special blocks or neighborhoods to go and look at the trees. And that's -- basically, that's the report from the Tree Committee. If anybody would like a copy, there's copies here.

And I want to just thank the Tree Committee, especially John Quinlan, for going around and putting the Treegators on there, filling up the Treegators, the water bags for the trees. And they all -- they take the trees very seriously. They do a good job. It's all volunteer, and they put in numerous hours pruning, maintaining, watering, and everything else for the trees. And I just want to thank the whole committee for the work they did in the past year.

Okay. That's a11 I had under announcements.

Public to address the Board. Is there anybody from the public who would like to address the Board on any topic?

MS. GORDON: Okay.
MAYOR HUBBARD: Just your name and address for the record, please.

MS. GORDON: Dinni Gordon, 152 Sixth Street.

I just want to thank the Board for considering the proposal for our little multicultural festival. It's a repeat of what we did last year. This year, it's going to be on June 3rd, as is proposed in your resolution, and I think it will be even better.

We are broadening our multicultural reach. And I would encourage any of the public or the Board members, if you have ideas about -- we are hoping to get Irish dancers and maybe some Greek dancers, and I think it will be a wonderful event for the Village as a whole. We're trying to keep it very local, so we're having -- we've decided we could have performers as far away as East Marion and Southold, but not much farther than that.

And we have, I think, a very good planning committee that includes people you know, Val Shelby, Sister Margaret Smyth, Ellen Neff, my colleague on the Planning -- on the Zoning Board, and Beatrice Aguilar, who came tonight to learn a little bit about the decision-making of the Board.

So thank you very much. I think it will be a great event. And if you have ideas about whom we should be considering as performers, or where we should raise some money -- last year we gave $\$ 100$ to every performer, just as an honorarium. It would be nice to do a little better this year, and to do something more with the food. So if you have ideas, please get in touch with me, or with Val, or with Sister Margaret, and we'11 make it an even better event. Thanks.

MAYOR HUBBARD: Thank you.
MR. SALADINO: John Saladino, Sixth Street. Is there going to be an Executive Session?

MAYOR HUBBARD: There's not one planned, no.
MR. SALADINO: Are there any walk-off agenda items that --

MAYOR HUBBARD: No.
MR. SALADINO: Okay. I was at the Planning Board -- at the Planning Board. I was at the work session last week and I heard a couple of things, and if you'd let me, I'd like to ask you about, maybe you could share with us.

I thought there was going to be a public hearing for a petition that yous received about -- about resident parking stickers. I don't see

it scheduled. I'm not sure where that stands. But I have a couple of questions if you do consider having that public hearing. I have one question. Who can get a parking sticker?

MAYOR HUBBARD: We have not gotten that far into it yet, John. That's why there's no public hearing scheduled. It was part of a work session report, and we're still going to look at the process and see what we want to try to propose.

MR. SALADINO: Is there a -- is there a sense of who can get it? Was that part of the report?

MAYOR HUBBARD: I mean, basically, I would think it would be anybody that lives in the Village. I mean, that's --

MR. SALADINO: Sounds fair.
MAYOR HUBBARD: You can't discriminate. I mean, that's -- that would be the only proper way I feel that you would be able to do it. But we still -- we don't have a place to put additional parking in yet. We're waiting for an answer from the MTA on -- we thought it would be --

MR. SALADINO: Don Fisher's here. Don
Fisher's is here.
MAYOR HUBBARD: Yeah.

MR. SALADINO: We could ask him.
(Laughter)
MAYOR HUBBARD: No. We thought that would be easy, but the proposal that went to them, when we talked about putting parking in the area, they said that could cause water to go onto the tracks. And so they want an engineering report and everything else. We can't just put down RCA and make parking spots, because it could affect their train service, and they want an engineering report first. So we're -- that's kind of why it got delayed for the time being.

MR. SALADINO: What's the term, paralysis by analysis?

MAYOR HUBBARD: Analysis, exactly, yeah.
TRUSTEE PHILLIPS: That's it.
MR. SALADINO: And we've heard a lot about a use evaluation, you know, and we hear it's illegal. If I can ask the Attorney, through the Board, is that, in fact, true? Is our use evaluation illegal?

MAYOR HUBBARD: Okay.
MR. SALADINO: You got to give him permission to answer.

MAYOR HUBBARD: Joe, do you have an answer
on that?
MR. PROKOP: I -- well, first off, I'm no longer the Attorney for the Planning Board. That's a matter for the Planning Board, so I would prefer that that -- that that Attorney --

MAYOR HUBBARD: Okay.
MR. PROKOP: -- answer that question.
MR. SALADINO: And your previous 10 years of experience with the Planning Board would like enjoin from answering that? Okay. I'11 ask him, I'11 ask him, then.

I also heard in the Trustees Report that the Zoning Code will be able to prevent \$50 a plate restaurants.

TRUSTEE PHILLIPS: What?
MR. SALADINO: I'm curious how that happens.

TRUSTEE PHILLIPS: What?
MR. SALADINO: And that's a quote.
TRUSTEE ROBERTS: Can you cite -- I think you're talking about me, so can you cite the --

MR. SALADINO: The time of the tape? It was --

TRUSTEE ROBERTS: No. In my report, where did I say that?

MR. SALADINO: Well, you said it --
MS. ALLEN: On the tape.
MR. SALADINO: You said it in discussion with, I believe, the Village Administrator, when the subject of use evaluation came up. And one of the concerns would be to prevent $\$ 50$ a plate restaurants, and you could do it through the Zoning Code. I'm curious how that -- how that would work.

TRUSTEE ROBERTS: So it's hard to remember the context of a discussion from a week ago. I could review the tape. But I think what I was -maybe what I was trying to say, maybe perhaps clumsily, but I was saying that a municipality has the ability to use its Zoning Code to figure out the density of certain types of uses. We don't have that in our code now, but we could go through a process through our LWRP and Zoning Code of saying we can have --

MR. SALADINO: So limit a certain type of business from opening, if a new business wanted to open in a vacant space?

TRUSTEE ROBERTS: As I understand it, that's -- that's what Zoning Code is used -- it's used to define what can and cannot be done in
each zone.
MR. SALADINO: So if a restaurant is a permitted use in, pick a zone, CR, you would say you would add something to the Zoning Code that would allow this Board or the Planning Board to say, "No, we have enough restaurants"?

TRUSTEE ROBERTS: As I understand it, and I am not a lawyer, or, you know, I'm a part-time Legislator trying to figure out the best thing for my community, as I understand Zoning Code, you can put -- you can zone such that there is a maximum density of certain kinds of uses. So if the Village wanted to say avoid a block being all trinket shops, it could say there can only be up to -- we don't do this currently. I'm saying that this is a possible planning tool that municipalities use. Am I an expert in this? No. Could I be wrong? Yes. Your question is making me think I better do my homework on whether or not that is possible.

MR. SALADINO: We11, no. Wel1, actually -actually, I -- you went to Princeton. I have experience. My brother owned a business in Princeton, in the Borough. For those that don't know, there's a Princeton -- like Greenport,
there's Princeton, there's the Borough of Princeton.

TRUSTEE ROBERTS: Why does my university always come up in these meetings? Go ahead.
(Laughter)
MR. SALADINO: No, because it's -because -- because I had -- I had asked about a certain question there, probably while you were still dating cheerleaders in high school. I mean, long before you went to --

TRUSTEE ROBERTS: I wasn't so lucky, my friend.

MR. SALADINO: Long before you went to Princeton.

TRUSTEE ROBERTS: Okay.
MR. SALADINO: They limit the amount of liquor licenses in Princeton. At that time, there was four, and -- in the Borough of Princeton. So to me, this -- and people were happy with it, I guess, except people that wanted a liquor license. But this kind of sounds like the same thing. You would intend to pass a portion or add to the code where, say, there's only 11 -- right now, we have two $\$ 50$ a plate restaurants, so we'11 have four $\$ 50$ a plate
restaurants. I don't know how that's possible. My point is, to say stuff like that and to put it out there starts a whole chain of events, a whole conversation about stuff that $I$ don't want to say doesn't make sense, but probably doesn't have a chance of coming into -- into fruition, you know? So -- so I would -- I would think that unless there's something you could share with me, maybe, I don't know, maybe -MAYOR HUBBARD: Okay. I could just say, John --

MR. SALADINO: I want to say -- actually, what I want to say is maybe you stop saying that, you know. Is it --

TRUSTEE ROBERTS: What?
MAYOR HUBBARD: We11, I could just say, I did not hear that. When you brought that comment up, I don't remember reading that. If it was said in a conversation at a work session, I did --

MR. SALADINO: It was at a work session.
MAYOR HUBBARD: I did not pick up on it, so --

MR. SALADINO: It's on tape, and I'm sure if you want to just look at the tape, you --

MAYOR HUBBARD: No, I'm not asking that.
TRUSTEE ROBERTS: I believe you.
MAYOR HUBBARD: I'm just saying you said it, and I'm like -- looking at each other like where did that come from, because I don't remember reading it. If it was a comment that was made, you got very good hearing and good memory.

MR. SALADINO: We11 --
MAYOR HUBBARD: I didn't remember it.
MR. SALADINO: That's because I listen.
MAYOR HUBBARD: That's fine. I'm complimenting you, because when you said that, I didn't remember. I was at the meeting and I didn't remember that being said.

TRUSTEE MARTILOTTA: Not at all.
MR. SALADINO: And the last thing I have a question about also is a portion of your report that - and this is a quote, also. It's "Ensure diversity of businesses catering to locals." Thirty-four percent of the people, and you seem to be advocating for that. Hey, Paul. I don't - I don't know how you do that either. How do you decide? I guess that goes back to 1 ike, you know, 50 a plate restaurants. How do
you -- how do you decide who gets to open and who doesn't? I'm not opposed to it, don't get me wrong I'm just asking how you do it.

TRUSTEE ROBERTS: And I don't -- you know, comments I'm making at a work session about things we could do in a planning exercise are intentionally hypothetical so that we might engage in the planning exercise. I don't believe we've done a planning exercise, not since I've been involved. And so all of this was in the context of $I$ want us to potentially do some planning and engage -- this is all in the context of -- I think I was talking about the housing study, and so I'm interested in understanding how communities can plan, so that the people who live there don't have to drive a half an hour to buy anything that they need. I'm interested in figuring out how our community can protect the very soul of our community, so that the folks who live here can afford to live here, and so we don't get -- so we don't become an entirely tourist destination

MR. SALADINO: I don't know if you can unring that bell, but --

TRUSTEE ROBERTS: So should we give up?

MR. SALADINO: No, no.
TRUSTEE ROBERTS: Okay.
MR. SALADINO: Absolutely not. But when you come up with a concept as -- like what you're saying that was, I thought you had a plan. When you say this is a concept, in fairness to the people in the audience that are listening to this, there should be a second sentence, also. This is my concept and this is how I propose we do it, not that this is my concept, you figure it out. You know, to me --

TRUSTEE ROBERTS: I do bring a lot of --
MR. SALADINO: -- instead of -- instead of me like having to come up here the next day, I could come up here and talk about something else, the price of tea in China. I don't have to try to remember this, because I'm interested in the answer, I'm truly interested in the answer. But, you know, it's like -- it's like the guy that gets at the podium and says, "Yeah, we have to lower taxes." So a guy like Saladino that's sitting in the office -- in the audience says, "Yeah, that's really a great idea, how do you plan on doing it," and they don't have an answer. You know, it turns out to be almost -- I don't
want to say rhetoric, but it just turns out to be noise.

So thanks. Thanks for -- anybody want to know about PSEG? Thanks. Have a good night. (Laughter)

MAYOR HUBBARD: Thank you. Anybody else wish to address the Board?

MR. ELKIN: Eric Elkin, 912 Main Street. I will be very brief. Just wanted to thank the Board for considering the resolution, proposed amendment to change the speed limit. There's obviously differing opinions on that. But one of the great things about Greenport is that you have this hyper-localized representation, and I think this is a particular agenda item that is best considered at a very local level, because it affects our community. We're a unique walking village, and I'm just happy that that's going to get further attention.

MAYOR HUBBARD: Wel1, second it first, and then you could have discussion.

My comment on this is that $I$ see in the newspaper that the Chief of Police has gone on record publicly that he doesn't, you know, think this is something he -that he approves of. And I'm thinking that rather than go to a public hearing immediately, that we proceed with a suggestion, I think that Trustee Phillips made, to invite the Chief to come and discuss the situation with us here in
the Village.
I did some of my own driving around today to take a look at the places in the Village that could use additional signage. The thing that I found most striking, I think to the petitioner, the folks, the Elkins, was that I drove up to the North Road and I came into the Village, and when you come up off of the North Road, the speed limit is 45. And there is no place, once you get on Main Street, before we come to the corner of Bridge, where there is a sign for 30 miles an hour. Anybody that's coming in assumes that the speed limit is 45 miles an hour. I would literally have to slam on my brakes to get down to 30 , and I drive slow.

And I have no objection to slower speed limits in the Village, but I think we need to engage with the Chief of Police, because I don't think we can enforce this without his support. So that's why I'm asking to, you know, hold off on the public hearing until we have a conversation with him first. Thank you.

TRUSTEE PHILLIPS: Mayor, can I just have a clarification, because my understanding is, is in this particular -- in this particular public
hearing, in this particular code, this is only dealing with Village streets. We cannot change the code on Main and Front, correct?

MAYOR HUBBARD: This is to change the code Village-wide for 25 miles an hour.

TRUSTEE PHILLIPS: But that doesn't affect Front and Main.

MAYOR HUBBARD: It will--
TRUSTEE ROBERTS: It's unclear.
MAYOR HUBBARD: If we pass this, we will be petitioning the State to change the designation on the State road.

TRUSTEE PHILLIPS: We11, that's what I'm saying. But, at the moment, we would have to petition the State, and we could actually physically change the code within all the streets within the Incorporated Village before we could change the street speeds on Front and Main, correct?

MAYOR HUBBARD: Yes.
TRUSTEE PHILLIPS: Okay. That's what I'm saying.

MAYOR HUBBARD: We could change Village-wide. We could change our code to go from 30 to 25 miles an hour, but before you could
actually designate that on the State road, the State would have to approve there. But any other road in the Village would go down to 25 miles an hour.

TRUSTEE PHILLIPS: Right. Well, I just want to make that clarification, because people get confused sometimes and not understanding that the code that we have, the Village Code only deals with our own inner -- inner streets.

I do know that I do strongly feel that Chief Flatley should be involved in any discussion of this. The public hearing, I think, will probably just bring out some facts and some examples from perhaps the Chief to get from the community. So that's all I'm asking, okay?

MAYOR HUBBARD: Right.
TRUSTEE PHILLIPS: I just want a clarification that everybody understands that this is not going to solve a problem immediately on Front and Main.

MAYOR HUBBARD: No. We could vote on it, we could pass the code, we could change our code, but until the State rules on Front and Main Street, which they have jurisdiction over, that could take them a year or two for that to go into
effect, but we would change it on all our other Village-designated roads.

TRUSTEE PHILLIPS: Right. I just want everyone to be aware of that, that's a11.

MAYOR HUBBARD: Right. And the public hearing is really -- is more a fact-finding information from the Chief of Police, from the public, from everybody else who wants to talk about it, to open the dialogue and discuss it. And we may find after the public hearing and after speaking to the Chief of Police, if we can get updated enforcement to try to slow everybody down going through, we may not need to change the code.

TRUSTEE PHILLIPS: Right.
MAYOR HUBBARD: Which I said at the work session. You could say it's 20 miles an hour. But if it's not being enforced and there's no way to slow people down, it doesn't matter what the sign says on the side of the street, if there's no enforcement, encouragement to make sure people do that.

TRUSTEE PHILLIPS: Okay.
MAYOR HUBBARD: So --
TRUSTEE PHILLIPS: I do know that I had
made the suggestion in the past, and I do know from a meeting from Southold Transportation Commission that it was suggested that we put a sign at our borderline between the Village and the Town of the Southold stating that our speed 1imit is Village-wide 30 miles an hour, or whatever. But I don't know if that's taken place or if it's in the works for the budget year, or whatever.

MAYOR HUBBARD: No, the sign, when construction was being done downtown by New York State, they took down the sign that we had on the corner of Washington Avenue and Main Street. They took the sign down and never put it back up, and it has not been there for several years.

TRUSTEE PHILLIPS: Okay. Al1 right. I think --

MAYOR HUBBARD: There is one on the other way coming into town, but as Trustee Robins said, coming in, the sign used to be right there.

TRUSTEE PHILLIPS: Right.
MAYOR HUBBARD: As soon as you got to Washington Avenue and Bridge Street, there was a sign there. That sign is no longer there.

TRUSTEE PHILLIPS: I would like --

TRUSTEE ROBINS: And I was -- I was looking for the sign and one didn't jump out at me by any means, you know.

MAYOR HUBBARD: No. There used to be a two-foot-by-two-foot sign there.

TRUSTEE PHILLIPS: There used to be one.
MAYOR HUBBARD: So it's not.
TRUSTEE MARTILOTTA: Just to also -- if I may, because I live on the end of this, there's a 20 mile an hour sign that blinks yellow in front of the high school, which is -- what is it, like three blocks from my house, Chatty, something like -- you know, like right over there. And I am trying to cross that street with three little kids and there is nobody going 20 miles an hour. The only time it slows down is when the crossing guard literally stops cars.

So I'm totally comfortable inviting the Chief of Police, invite anybody we want over here, but that over there to me is not safe. And kids have been hit there in the past, and anything that lowers the chances in the future, $100 \%$ behind. So there you go.

TRUSTEE ROBERTS: And I've heard this about it being a State highway. At Washington's

Birthday, I asked our Assemblyman what he thought of all this, and he said, "I'm not sure. I think you guys can just change the speed limit yourselves." So, clearly, there's no definitive answer. No one's given us a definitive answer. We've asked Joe, we haven't gotten one, or maybe we have. If we did, I missed it. I don't think we know the answer to this question of whether we can change Front and Main. I hear you guys say this a lot, but I've never read it anywhere, and the Assemblyman didn't seem to think so. But he was willing to be very supportive if we do need his help.

TRUSTEE PHILLIPS: Chief Flatley has said it. Chief Flatley has --

TRUSTEE ROBERTS: So I am eager to have his help on it.

This hearing, I mean, Trustee Robins, we have to be able to walk and chew gum at the same time. We can have this hearing. This is not going to hurt anything. You know we're not voting on a new law, right? We're just having a hearing. So let's have the hearing, and let's have the Chief. We need his help, because, really, to the Mayor's point, we need his help
if -- whatever speed $1 i m i t s . ~ S p e e d ~ 1 i m i t ' s ~ 10, ~$ 20 50, we need his help. And I can tell you, I need it on my block, especially in the summer, and we need a couple of signs, because people for some reason see water at the end of the street and speed up, I have no idea why.

So I hope we'11 have the hearing, and let's -- this takes a while to make a new law, so let's, please, get the hearing done.

TRUSTEE ROBINS: Okay. I'11 support, I'11 support it. So he -- all right. So I had seconded. You want me to read it again or --

It took two years worth of paperwork and convincing to allow us to touch their road.

So I'm just saying that's -- the DOT
doesn't always answer to the Assembly and the Senate. They've got their own set of people in charge, and they're the ones that had said that's the way it's supposed to go, but --

THIS INTERMUNICIPAL COOPERATION AGREEMENT entered into as of the ___day of, 2018 by and between the GREENPORT UNION FREE SCHOOL DISTRICT ("School District") with offices for the transaction of business located at 720 Front Street, Greenport, New York 11944 and the VILLAGE OF GREENPORT ("Village") with offices for the transaction of business located at 236 Third Street, Greenport, New York 11944.

## WITNESSETH

WHEREAS, the School District and Village would like to share services to provide a safe, fun and inviting opportunity for children to come to the Greenport High School during the December break to play in a supervised environment;

WHEREAS, the School District and the Village recognize the limited options for children in the School District during the breaks throughout the day, as well as the weather;

WHEREAS, both parties believe that it is in the best interest of the taxpayers of School District and Village to share resources to provide a safe, fun and inviting opportunity where children can be encouraged to come, exercise through play, and be in a safe and positive environment among friends;

WHEREAS, individual resources can be made available for mutual use when it is in the public interest;

WHEREAS, the parties wish to contract with one another for the operation and provision of such supervised environment as described herein to School District residents during the breaks in accordance with General Municipal Law § 119- o; and

WHEREAS, the parties recognize what their respective rights and obligations will be under the contract;

NOW THEREFORE, in consideration of the mutual covenants set forth herein, the parties agree as follows:

1. This Agreement shall take effect on the date of execution by both parties and shall remain in effect until April 7, 2018. Notwithstanding the term of agreement set forth herein, the parties shall have the option to renew the Agreement upon mutual consent and adoption of a resolution authorizing renewal by each party's respective Board.
2. School District and Village each represents that it is authorized pursuant to both Article 9 § 1 of the New York State Constitution and Article 5-G of the General Municipal Law to enter into intermunicipal agreements.
3. School District and Village believing it to be in the best interest of their taxpayers, do hereby authorize inter-municipal cooperation and assistance with and between each other for the operation and provision of a supervised environment to provide a safe, fun and inviting opportunity where children can be encouraged to come, exercise through play, and be in a safe and positive environment among friends (the "Program") at the Greenport High School to School District residents during the December break in accordance with General Municipal Law § 119-0.
4. Village and School District agree to cooperate with one another in furtherance of the operation of the Program to School District residents during the December break in accordance with General Municipal Law § 119-o.
5. The Program will run at the Greenport High School on February 20, 21, 22, 23, 2018 and April $3,4,5$, and 6,2018 from 12:30 p.m. to $3: 00 \mathrm{pm}$ in accordance with the following agreed upon schedule:

6. The School District agrees to supply the facility and two (2) School District employees.
7. The Village agrees to supply four (4) recreation center employees.
8. The parties agree that the secondary students (grades 7-12) will be in the "Big Gym" with one (1) School District employee and one (1) Village Recreation Center employees and the elementary students (grades K-6) will be in the "Small Gym" with one (1) school district employee and three (3) Village recreation center employees.
9. The parties' obligations hereunder shall be performed in accordance with all applicable laws, rules, regulations and ordinances and requirements of the State Education Department.
10. The parties agree to purchase and maintain an insurance policy to protect School District and Village from claims under workers or workmen's compensation, claims for damages because of bodily injury, occupational sickness or disease, or death of employees, claims for damages insured by usual personal injury liability coverage or injury to or destruction of tangible property, including loss of use resulting therefrom for which the either party may be legally liable. Insurance shall be required as follows:
a. Commercial General Liability Insurance: $\$ 1,000,000$ per occurrence and $\$ 2,000,000$ aggregate.
b. Commercial Auto Liability Insurance: $\$ 3,000,000$ combined single limit.
c. Commercial Excess Insurance: $\$ 3,000,000$ per occurrence and $\$ 3,000,000$ aggregate.
d. Workers' Compensation and N.Y.S. Disability: Statutory Workers' Compensation, Employers' Liability and N.Y.S. Disability Benefits Insurance for all employees.
e. Insurance policies in effect shall include coverage for sexual misconduct.

Each party agrees to name the other as an additional insured using ISO additional insured endorsement CG 2026 or equivalent and shall furnish to the other certificates evincing its procurement of such policies. Policies shall contain a 30 day notice of cancellation.
11. The parties each agree to indemnify and hold harmless the other, its agents, officers, and employees from and against all claims, damages, losses and expenses caused by the negligent act or omission of the indemnifying party in the performance of its obligations hereunder.
12. Either shall have the right to terminate this Agreement upon sixty (60) days written notice to the non-terminating party.
13. Any alteration, change, addition, deletion or modification of any provision of this Agreement or of any right either party has under this Agreement must be made by the mutual assent of the parties in writing and signed by both parties.
14. This Agreement shall be governed by the laws of the State of New York. If any portion of this Agreement is found by a court of competent jurisdiction to be invalid or unenforceable, the remainder of this Agreement shall remain in full force and effect.
15. This Agreement constitutes the full and complete Agreement between the parties and supersedes all prior written and oral agreements, commitments or understandings with respect thereto.
16. Nothing contained in this Agreement shall be construed to create an employment or principalagent relationship or partnership or joint venture between School District and Village.
17. This Agreement had been mutually arrived at and shall not be construed against either party as being the drafter or causing this Agreement to be drafted.
18. The undersigned representatives of each party hereby represents and warrants that they are officers, agents, or directors of the party for whom they sign with all legal rights, powers and authority to enter into this Agreement on behalf of the respective parties and bind them with respect to all obligations enforceable against them in accordance with the terms contained herein.
IN WITNESS WHEREOF, the undersigned hereby do acknowledge that they have read and fully understand the foregoing Agreement and further, that they agree to each of the terms and conditions contained herein.

# Resolution of the Board of Trustees of the Village of Greenport 

In the matter of amending the
Service Award Program
for active volunteer firefighter
members of the Greenport
Fire Department

WHEREAS; eligible voters of the Village of Greenport approved a referendum to establish a Service Award Program for active volunteer firefighter members of the Greenport Fire Department effective January 1, 1994, in accordance with Article 11-A of the New York State General Municipal Law; and,

WHEREAS; under the current Program provisions, Participants can earn up to 30 years of Service Credit for a maximum Accrued Monthly Service Award of \$600; and,

WHEREAS; Article 11-A authorizes the Village to allow up to 40 years of Service Credit to be earned; and,

WHEREAS; Article 11-A further authorizes the Board of Trustees to seek voter approval of amendments to the Program; and,

WHEREAS; these amendments are intended to enable Village to improve the Service Award Program benefits to active volunteer firefighter members of the Greenport Fire Department; and,

WHEREAS; such improvement in Service Award Program benefits is consistent with the intent of the Program to help the Greenport Fire Department recruit and retain active volunteer firefighters;

Now, Therefore, BE IT RESOLVED, That:

The Board of Trustees of the Village of Greenport, as authorized by Article 11-A of the New York State General Municipal Law, directs that there shall be a public
referendum of eligible voting residents of the Village of Greenport on August 14, 2018 to determine whether the Village of Greenport Service Award Program shall be amended effective January 1, 2019 to increase the maximum years of Service Credit under the Program from 30 to 40 and thereby the maximum Accrued Monthly Service Award from $\$ 600$ to $\$ 800$.

The calendar year 2018 cost of the Village of Greenport Service Award Program is approximately $\$ 242,000$, or $\$ 1,780$ per covered participant, which includes the cost of administration of $\$ 7,500$. Should voters approve this amendment, the annual cost of the amended program for current participants is estimated to increase by $\$ 30,000$, or $\$ 220$ per covered participant. However, the Village has been budgeting $\$ 260,000$ annually for the Program, and expects to increase the budget to $\$ 290,000$ if the amendment is approved. There is not expected to be an increase in administration fees as a result of this amendment.

All other provisions of the Village of Greenport Service Award Program shall not change and the program shall continue to be administered by the Village Board of Trustees in accordance with Article 11-A of the New York State General Municipal Law as such law is amended from time to time.

## A LOCAL LAW AMENDING SECTION 118-15

## OF THE GREENPORT VILLAGE CODE

## REGARDING MERGER OF LOTS

## BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE

INCORPORATED VILLAGE OF GREENPORT AS FOLLOWS:

1.1 .Title.

This Local Law shall be entitled "Local Law of 2018 Amending Section 118-15 of the Greenport Village Code.

### 1.2. Enactment.

Pursuant to Section 10 of the Home Rule Law and the Village Law of the State of New York, the Incorporated Village of Greenport, County of Suffolk and State of New York, hereby enacts by this Local Law of 2018, a Local Law of the Village of Greenport.

### 1.3. Effective Date.

February 14, 2018

This Local Law shall take effect on the filing of the approved Local Law with the Secretary of State of New York, which shall be within twenty (20) days after its approval by the Board of Trustees of the Incorporated Village of Greenport.

### 1.4 Purpose and Intent of Local Law.

The purpose and intent of this Local Law is to create regulations regarding the merger of lots in the Village of Greenport.

### 2.0 General Provisions.

2.1 Section 118-15 of the Greenport Village Code, is hereby amended to read as follows:
"118-15. Merging or combining of lots prohibited.
Owners of lots or an owner of lots in the Village of Greenport shall be prohibited from combining or merging two or more of those lots except that where a nonconforming lot is adjacent to a conforming lot and the nonconforming lot and conforming lot have the same owner, the owner may merge the nonconforming lot with the conforming lot with the prior approval of the Zoning Board of Appeals of the Village of Greenport. The criteria to be used by the Zoning Board of Appeals in the consideration of the application for approval of a merger shall be the same criteria as for an area variance and such other criteria as the Zoning Board of Appeals may determine to be relevant.

### 3.0 Severability

In the event that one or more provisions of this local law may be deemed to be invalid, the remaining portions of the local law shall remain in full force and effect.
