1	changes, then. Okay. When are you going to
2	get rid of the picnic table?
3	MR. KHAN: Picnic table
4	CHAIRMAN JAUQUET: That goes. We don't
5	want that there.
6	MR. KHAN: It's not we can't put it
7	there?
8	CHAIRMAN JAUQUET: It's not on the plan,
9	and we don't want it on the plan.
10	MR. KHAN: I mean, the whole rest of the
11	town has tables sitting outside.
12	CHAIRMAN JAUQUET: The town might, but
13	the private we don't want that there,
14	because the restaurant across the street does
15	not want that there, and, you know, their
16	people are sitting there.
17	MR. KHAN: I sit myself, sometimes we
18	sit outside.
19	CHAIRMAN JAUQUET: I know. But when I
20	went by today, there was someone sitting on
21	the table all bedraggled. And it's just
22	you know, as far as we're concerned so far, it

23	doesn't work, and it just collects all your
24	you know, people that look, you know, like
25	they're on their last legs sitting there on

1	their elbows and lying down on that. So it
2	doesn't work. And it wasn't in your original
3	plan, so it doesn't get in just because you
4	put it there. And this is none of this is
5	going to get approved until you, you know, do
6	that. And, you know, we're not you know,
7	anyway, the picnic table's got to go.
8	MR. KHAN: Okay.
9	CHAIRMAN JAUQUET: Anyway, so then
10	you've got to bring that revised
11	MR. KHAN: Revise the plan and
12	CHAIRMAN JAUQUET: Revise, then we'll
13	take it up from there.
14	MR. KHAN: Sure.
15	CHAIRMAN JAUQUET: Unless okay. So
16	I'm done talking.
17	MR. BURNS: We really are ready to
18	approve your project if these things are met.

19	MR. KHAN: Yes. Only a couple of things
20	which I did, that I just spoke to the owner
21	and he has to provide me some papers. Eileen
22	asked me
23	MS. WINGATE: That's easy.
24	MR. KHAN: He has to do it. Then we
25	have to bring back the two-car parking space.

1	MS. WINGATE: I gave you that whole
2	list.
3	MR. KHAN: Yes.
4	MS. WINGATE: Just go
5	MR. KHAN: We have to do one other
6	thing.
7	CHAIRMAN JAUQUET: All right.
8	MR. KHAN: So, hopefully, at the next
9	meeting.
