2 Work Session 2/15/24 1 (The Meeting was Called to Order at 6 p.m.) MAYOR STUESSI: Please stand for the Pledge of 2 3 Allegiance. 4 (Pledge of Allegiance) MAYOR STUESSI: Please be seated. I'd like to 5 6 make a motion to open the meeting of February 15th. TRUSTEE PHILLIPS: 7 Second. 8 MAYOR STUESSI: All in favor? TRUSTEE ROBINS: 9 Ave. TRUSTEE BRENNAN: 10 Aye. 11 TRUSTEE PHILLIPS: Aye. 12 TRUSTEE DOUGHERTY-JOHNSON: Ave. 13 MAYOR STUESSI: Aye. Motion carries. 14 With that, we are going to open the *Public* Meeting to receive comments on the following State 15 16 *Liquor Authority application.* This is an application for the North Fork Arts Center, Incorporated, 17 18 211 Front Street, Greenport, operating in the historic Greenport Theater. 19 Would the applicant and/or his Counsel like to 20 21 come to the podium and speak? MR. SPIRIDAKIS: I'll bring my Counsel with me. 22 23 MAYOR STUESSI: If you could state your name 24 and address for the record, please, and then --25 MR. SPIRIDAKIS: Tony Spiridakis, 178 Sterling

1 Street.

2 MS. STEVENS: Jane Stevens, 3595 Beebe Drive, 3 Cutchogue.

MAYOR STUESSI: Great. So if you could tell us a little bit about the organization, the theater, the plans for it, and then the plans specifically for the application for the beer and wine license. I will make note for the public that it is a beer and wine license.

MR. SPIRIDAKIS: Yes.

11 MAYOR STUESSI: The State of New York several 12 years back allowed theaters to begin selling beer and 13 wine, but not hard alcohol, and this is an application 14 to do that at the concession stand, correct?

MR. SPIRIDAKIS: That's exactly -- that's 15 16 exactly right, in the building. Theaters have been hard hit because of COVID, and Governor Hochul 17 18 basically implemented this emergency plan for COVID 19 to give theaters a fighting chance to get people to come into the theaters by offering them a 20 21 wine-and-beer-alone liquor license. And then when 22 COVID sort of settled down, it was the State Senate 23 that decided to make that a permanent rule for the --24 I think they realized that movie theaters, even 25 without COVID, were COVIDy, and not doing as great as

they should have been. And I think it was a very wise decision by the politicians in the State to help businesses that are having theater, movies and other, and other functions.

5 So the movie theater in Greenport, which is 6 very dear to so many of us, was put up for sale, as 7 people may know. And in January of 2023, I received 8 a call from the owner who said, "I have this idea 9 that I'm going to sell the theater, unless you can 10 get the public's support and create a nonprofit," and 11 that's what North Fork Arts Center was -- that's how 12 North Fork Arts Center was born.

And we took on the challenge in January, raised over a million dollars, received over 500,000 in grants. And we are now in the process of fixing a few things. And our desire is to have beer and wine as another way of bringing people in the public to come to our arts center and enjoy the arts, basically.

MAYOR STUESSI: Great. And so your plans -- I
know you have an application for the Building
Department for some renovations in two stages.
You're starting with one part and looking to -MR. SPIRIDAKIS: Would like me to talk about
that?

MAYOR STUESSI: Yeah, very are briefly.

5 Work Session 2/15/24 1 MR. SPIRIDAKIS: Sure. 2 MAYOR STUESSI: And you're reopening and then 3 closing again. 4 MR. SPIRIDAKIS: This is all I do all day long, so you don't want to wind me up and let me loose. 5 6 (Laughter) 7 MR. SPIRIDAKIS: But, yeah, it was a very, very 8 interesting pull one thread and another bunch of 9 threads will come undone. The thread that was pulled 10 was the realization -- when we did our due diligence 11 and did a deep dive and opened up walls, we 12 discovered that the stage in the upstairs theater, 13 which is a beautiful -- the old balcony of the movie theater is a 295-seat theater, which is not an 14 15 insignificant seating arrangement for any kind of 16 performance. And the screen is there for movies, and in front of the screen is an 18-foot-by-60-foot stage, 17 18 which turns out is an illegal term for the stage. It's actually a soffit, meaning it can't be used as a 19 20 stage, it has no CO as a stage. It has certain 21 capabilities that are probably around similar to the 22 weight bearing of a suburban ranch house living room, 40 square feet -- 40 pounds per square foot. A 23 24 theater needs much more than that to get CO'd. So we 25 pulled that thread and then decided to take on making

it a proper CO'd stage, and we have great engineer, architects and contractors on it.

3 We're going to start work as soon as we're --4 Monday we're going to begin demolitioning the stage, and hope to be done by mid April. And then we're 5 6 going to also do an upgrade to the film viewing 7 experience, because I don't know if people know this, 8 but, you know, we still have the mono speakers from 9 way back. So if you go see a Marvel movie at our 10 theater, you got one little speaker in the back of 11 the screen, and it's just different to see Thor 12 that way.

(Laughter)

14 MR. SPIRIDAKIS: And so what we're doing is we're paying for a film company from Netflix to put 15 16 in Surround Sound, a beautiful automatic curtain. We're lowering the stage, we're putting in a brand 17 new floor for the stage. And we're going to put 18 19 lighting, and also have audio equipment, so that when we have lecture series, there's going to be a 20 21 beautiful way to hear those lecturers.

And then we're also going to have our projectors talking to each other, so that if you see something upstairs, you could actually simulcast it to any of the theaters down below. So that's the

1 first phase.

2	The second phase, and we're going to do that by
3	May, and we have our first event is going to be a
4	three-week residency of the Brooklyn Ballet, and
5	they're coming. And then we're going to do a premier
6	of a new film, which I wrote and produced, that's
7	going to be May 31st. And then in June, we just
8	booked and solidified a deal with Colin Quinn to come
9	do an evening of comedy for us as a fundraiser to
10	help us pay for all this.
11	MAYOR STUESSI: Okay.
12	MR. SPIRIDAKIS: And yeah. And then what we
13	plan to do is we'd like to, and this is all Board
14	this second part is Board-dependent. Everything I
15	just told you is happening and was voted on, and we
16	have the money and everything's great. Part 2 is
17	in on Labor Day we'd like to shutter the place and
18	do the second part, which is a little more
19	complicated, but it's about taking, taking back space
20	that's right now up in the air.
21	About 7,000 square feet of our building is
22	literally open air for I don't know how high it
23	is, but it's really high. So what we're going to do
24	is continue the steel that we're doing to support the
25	stage and continue it and just create a second floor,

1	and just not finish it, but just have it so that we
2	can then raise money toward finishing that space
3	upstairs, and that would include becoming ADA
4	compliant, that would include having water
5	sprinklers. You know, all the things people are
6	terrified of, that's what I'd like to do, is do the
7	terrifying stuff, but it's going to make the
8	healthy it's going to make a healthy building,
9	right?

10 So the infrastructure of that building will be 11 steel, and we will have the ability for people to get 12 upstairs. We'll have a backstage area to the screen 13 upstairs, and we'll have about 7,000 square feet of 14 space where we can do so much more educational 15 programming for the community.

16 MAYOR STUESSI: Wonderful. Does anybody on the 17 Board have any questions for the applicant on the 18 beer and wine license, or anything else relative to 19 the theater?

20 TRUSTEE ROBINS: No.

21TRUSTEE BRENNAN: I do. That all sounds great.22Thank you for describing that.

23 MR. SPIRIDAKIS: Sure.

24TRUSTEE BRENNAN:Can you tell us how beer and25wine will be served at the concession stand?Is that

like a part of the concession stand, is it by employees of a certain age? How does that work?

MR. SPIRIDAKIS: Yeah, you do. 3 There's 4 different laws. There's some laws that allow under 18 -- under 21 to serve. But we're right now 5 6 operating with the understanding that if we're going to be serving beer and wine only, and it's not a --7 8 it's going to be canned, everything is going to be 9 canned, even the wine as well. That will be part of our concession offering, which is, and was not 10 11 something I really understood, absolutely happening 12 everywhere where you go to the movies, and it was 13 even happening before they chose axe-throwing at the 14 Mattituck Theater. I actually had a beer and saw a 15 movie. So it was something that because of this law 16 was very common.

17 And I remember the persons who were serving me 18 in Mattituck were not 20 -- they didn't look 21 to 19 me, I think they were high school kids. So I don't know the laws of that, but what I can tell you is 20 21 that we are a public company, we are a nonprofit 22 organization, we have one of the best lawyers in the world, you know, at Venable who does nonprofit law 23 24 only, and we are being sort of advised within an inch 25 of our lives not to do anything like have the wrong

1 age person serving behind the counter. 2 But the idea of the beer and wine is simply to 3 have beer and wine offered where everywhere else, 4 Sag Cinema, in East Hampton, anywhere you go you have the same thing, so we're just trying to have what 5 6 everybody else has in our theater. 7 Jane, did you want to add anything to that? 8 MS. STEVENS: No. I mean, obviously, we intend 9 to comply with whatever --10 MR. SPIRIDAKIS: Here, stand here. 11 MS. STEVENS: We intend to comply with whatever 12 the law requires in terms of the age of people serving, and make sure that we don't do anything 13 14 that's not appropriate or compliant with New York 15 Law. 16 TRUSTEE BRENNAN: Thank you. I was just curious about how, how it works. 17 18 MR. SPIRIDAKIS: No, it's really true. I mean, one of the things I found out is like do we have 19 enough storage to lock stuff up at night? Like 20 21 that's a big -- that was like my first thing. It was 22 because, I don't know, I was that kind of a teenager, 23 I guess. 24 (Laughter) 25 MR. SPIRIDAKIS: And so there is a great big,

big storage room, which is where everything can be stored and locked up. And even our -- you know, the kitchen, to get into the concession and the door around the corner by the fire exit, all these are doors that lock, you know, and that we're going to have to start paying attention to how that part of it works.

8 I mean, right now it's been everybody running 9 around, but we have a very good system in place where we're going to be interviewing all the people who are 10 11 management. You know, there are going to be two 12 theater managers who are also going to be projectionists. We're going need to hire three or 13 four, you know, for the summer. Since we're going to 14 be operating Memorial Day to Labor Day, it's not 15 16 overwhelming. We could do a test run and see how everything works. But we're going to really bear 17 18 down on hiring great people and making sure that it's -- that that's totally covered, yeah. 19 20 TRUSTEE BRENNAN: Thank you. 21 MR. SPIRIDAKIS: Yeah. 22 TRUSTEE ROBINS: Yeah. Actually, Patrick's 23 question, when you mentioned that you're going to be serving the beer and wine in cans, I like that. You 24

25 know, I'm picturing ballpark beer sloshing around all

12 Work Session 2/15/24 1 over the place, not going to happen. 2 MR. SPIRIDAKIS: That's --TRUSTEE ROBINS: And no bottles, right, just 3 4 cans? 5 MR. SPIRIDAKIS: Oh, and no bottles. And 6 during the winter films, I don't know if anybody 7 remembers, I did the winter films, MFI. That was 8 like a great time. A year-and-a-half we lasted, but 9 I was cleanup crew. So I made sure that it was cans 10 and not those other things you described, because 11 cleaning a theater after a movie is not exactly a 12 great time. 13 (Laughter) 14 MR. SPIRIDAKIS: And so we're going to, we're going to do anything we can to minimize that, that 15 16 kind of thing. 17 TRUSTEE PHILLIPS: I just have one question. MR. SPIRIDAKIS: Yes. 18 19 TRUSTEE PHILLIPS: From somebody who through 20 college worked in the restaurants, and I'm assuming 21 that you're going to have some policy as to -- I 22 mean, I know you're going to deal withe the underaged, because they're going to be checking you 23 24 to make sure that you're checking. But what are you 25 going to do with someone who becomes extremely

1 disruptive? I don't know if --MR. SPIRIDAKIS: Yeah, that's a great point, 2 Mary Bess, that's really a great point. 3 I don't 4 think it's going to be a big problem. But the people who we are picking as managers are people who also 5 6 have lived here their whole lives, and who will make 7 sure that, you know, whoever it is, that will be --8 you know, I think maybe the people from the firehouse 9 will come down and take those people out of the theater, if we play our cards right. 10 11 (Laughter) 12 MR. SPIRIDAKIS: But, you know, we do -- we really are hiring local people, which is going to be 13 14 so great, and we kind of all know, you know, what's 15 going on. 16 TRUSTEE PHILLIPS: No, no, I know. MR. SPIRIDAKIS: Yeah. So I -- yeah, I think 17 18 that's going to be okay. MS. STEVENS: Also, this has been so much of a 19 20 community engagement project, and we have lists of 21 hundreds of volunteers who want to work with us once 22 the theater is open, act as ushers, you know, be present onsite. And, you know, so there's going to 23 24 be ample adults in the room once we get going. 25 TRUSTEE PHILLIPS: Yeah, but it's food for

1 thought. 2 MR. SPIRIDAKIS: Oh, no, absolutely. And we're going to -- you know, I'm going to keep the kids' 3 4 movies down to a minimum, that's what I'm going to No, I'm kidding, no. 5 do. 6 (Laughter) 7 TRUSTEE PHILLIPS: You mean, the big kids? 8 MR. SPIRIDAKIS: Have you met children? No. 9 (Laughter) 10 MR. SPIRIDAKIS: No. I think what's really 11 great is that there are only three theaters now. 12 There were four theaters at one time. One of the theaters is going to be turned into a full-time 13 black box educational space, right, because the 14 theater in the back was never anything. I've never 15 16 seen a movie there, I don't know anyone who's seen a movie there, per se. But we felt that space in that 17 18 theater is a great way to create a classroom space, 19 right, and make it very clear that we're more than just a movie theater. And I think that begins to 20 21 trickle down, where people really understand this is 22 a place where you go and take a class, and there's 23 more going on here than just movies. 24 And the idea that you're going to go to the 25 movie theater and like raise hell, and run in and out

15 Work Session 2/15/24 of the bathrooms, I've seen it all, because I did two 1 2 years of it and I get it, but it's not going to be there in this time. 3 And we're going to try to really let people 4 know this is -- the difference here is it's not like 5 6 someone owns this, you're the owner. 7 TRUSTEE PHILLIPS: Yes. 8 MR. SPIRIDAKIS: You all own it, it's your 9 place. And so the more that becomes clear to the 10 public that this is actually the community's space, it's going to be a different story, I think, entirely. 11 12 TRUSTEE PHILLIPS: Okav. 13 MR. SPIRIDAKIS: Yeah. 14 TRUSTEE DOUGHERTY-JOHNSON: I don't really have 15 any questions, I mean, except, I guess, for curiosity. 16 Is it just going to be in the concession space, or also like the little cafe? 17 18 MR. SPIRIDAKIS: It might be in the cafe as 19 well, because it's tied together, so we really don't 20 know how that's going to work. I think the easiest 21 way right now is to keep it in the concessions, but 22 we have events coming. Like then the events may 23 dictate having to need more space to have people 24 sitting, in which case it will be spread out, and, 25 you know, that's the answer there.

1	But I think if it's approved for the building,
2	it should be the building, at which time, if anything
3	different should happen with the cafe, that's a whole
4	separate issue, and we have no plans for that right
5	now. We just don't know, we really don't know what
6	to do with that. But for us, it's both sides of
7	to me and everybody, we feel like the cafe and the
8	concession is one concession, that's kind of how
9	we're looking at it.
10	TRUSTEE DOUGHERTY-JOHNSON: I'm excited.
11	(Laughter)
12	MAYOR STUESSI: Well, I think it would be
13	wonderful. Do you have something else?
14	TRUSTEE BRENNAN: I have a question for
15	Counsel.
16	MAYOR STUESSI: Yeah.
17	TRUSTEE BRENNAN: I think I asked this question
18	on another SLA application, but should this Board be
19	seeing the application materials? Like we're not
20	it's not in our packet here.
21	TRUSTEE DOUGHERTY-JOHNSON: I think it was
22	emailed to us.
23	ATTORNEY STOLAR: That's up to the Board,
24	discretion of the Board. You have the notice
25	comes to you, that's all you get, you don't get

17 Work Session 2/15/24 1 anything else. If you want to look at additional 2 documentation for each application, you're entitled 3 to ask for that so you understand what's being 4 proposed. MAYOR STUESSI: Let's make a point of 5 6 circulating that in the future. 7 CLERK HALL: The application was circulated. 8 MAYOR STUESSI: No, not the application, 9 there's backup to it. So let's have a separate 10 discussion and figure what needs to be done to do 11 that. 12 TRUSTEE BRENNAN: Okay. Thank you. 13 MAYOR STUESSI: You guys have applied under the 14 501(c)(3), correct, for this? MS. STEVENS: Yes. 15 16 MR. SPIRIDAKIS: Oh, yeah, we're a -- we are a 501(c)(3). 17 18 MAYOR STUESSI: And so the only thing I would add is, you know, having had multiple liquor licenses 19 20 in the State of New York, and as your Counsel noted, 21 you are bound by all State liquor laws. And so it is 22 a privilege to have a license, and so the serving age is, you know, bound by State Law --23 24 MR. SPIRIDAKIS: Exactly. 25 MAYOR STUESSI: -- as is not overserving

1 people, whether you're a movie theater or a 2 restaurant. You know, from personal experience, it would seem to me it's much less likely somebody's 3 4 going to get overserved in a movie theater versus 5 sitting across at a bar. 6 MR. SPIRIDAKIS: Oh, exactly. MAYOR STUESSI: But it's, I think, going to be 7 8 a wonderful amenity for the theater and for the public, and I'm looking forward to enjoying it. 9 10 MR. SPIRIDAKIS: Great. 11 MAYOR STUESSI: Any other questions from the 12 Board? Is everybody in agreement in support of this 13 application? 14 TRUSTEE PHILLIPS: Yes. TRUSTEE BRENNAN: 15 Yes. 16 TRUSTEE ROBINS: Yes. 17 TRUSTEE DOUGHERTY-JOHNSON: Uh-huh. 18 MAYOR STUESSI: Great. Thank you so much. 19 MR. SPIRIDAKIS: Thank you very much. Thank you. 20 MAYOR STUESSI: All right. With that, I would 21 like to make a motion to open the *Public Hearing* 22 regarding the proposed Local Law 2 for the maximum 23 speed limit in non-school zones throughout the 24 Village to 25 miles an hour. 25 Brian, these should be separate, correct?

19 Work Session 2/15/24 1 ATTORNEY STOLAR: Yes. 2 MAYOR STUESSI: Okay. May I have a second? TRUSTEE DOUGHERTY-JOHNSON: 3 Second 4 MAYOR STUESSI: All in favor? TRUSTEE ROBINS: Aye. 5 6 TRUSTEE BRENNAN: Aye. 7 TRUSTEE PHILLIPS: Aye. 8 TRUSTEE DOUGHERTY-JOHNSON: Aye. 9 MAYOR STUESSI: Ave. 10 Do we have anybody from the public that would 11 like to speak for or against lowering the speed limit 12 on Village streets to 25 miles an hour from 30 miles an hour? 13 14 MS. YOURCH: I thought it already was 25. No. So, currently, the Village 15 MAYOR STUESSI: 16 speed limit is 30 miles an hour everywhere, with the exception of Front and Main Street, which were 17 18 lowered several years back down to 25 miles an hour. 19 The Village, normal Village streets were not lowered 20 at that time. And then, obviously, there's an 21 exception for the school zone. 22 TRUSTEE DOUGHERTY-JOHNSON: Can I make a 23 comment about that? And I could be wrong, and maybe 24 it doesn't matter, but I think -- I thought that was 25 15, it's not 20 by the school.

20 Work Session 2/15/24 1 TRUSTEE PHILLIPS: This is on Moore's Lane. TRUSTEE DOUGHERTY-JOHNSON: 2 0h. TRUSTEE PHILLIPS: Moore's Lane is 20, because 3 4 the speed limit --5 TRUSTEE DOUGHERTY-JOHNSON: But isn't --TRUSTEE DOUGHERTY-JOHNSON: -- there is 30 and 6 the --7 8 TRUSTEE DOUGHERTY-JOHNSON: But isn't Front --TRUSTEE PHILLIPS: Front is different. 9 TRUSTEE DOUGHERTY-JOHNSON: Front is 15. 10 TRUSTEE PHILLIPS: Front is 15, because it has 11 12 to be ten --13 MAYOR STUESSI: The school is outside of the 14 Village. 15 TRUSTEE DOUGHERTY-JOHNSON: That is true there. 16 MAYOR STUESSI: Yeah. 17 TRUSTEE DOUGHERTY-JOHNSON: Right, yes. Okay. 18 Thank you. Never mind. 19 MAYOR STUESSI: No other public comments? 20 (No Response) 21 MAYOR STUESSI: Any discussion on the Board about this? I think we're all in favor of it. Was 22 23 there anybody who had any concerns about lowering it 24 to 25? 25 TRUSTEE ROBINS: Most people already thought it

21 Work Session 2/15/24 1 was 25, but, you know, we're making it formal, that's fine. It should be in the code. 2 MAYOR STUESSI: Yeah. It's been an issue in 3 4 the Fifth and Sixth Street neighborhood policing some of the speeders over there, and so they can't cite 5 6 anybody unless they were going more than 30 miles an hour, which, you know -- anybody else? 7 8 TRUSTEE DOUGHERTY-JOHNSON: (Shook head no). 9 ATTORNEY STOLAR: Mayor, before you take action 10 on this, if your engineer has not looked at it, I 11 would recommend that your engineer take a look and 12 issue any comments that may be appropriate with 13 respect to this before you take final action. 14 MAYOR STUESSI: Okay. So should we keep it 15 open, then? 16 ATTORNEY STOLAR: That's what I would do. MAYOR STUESSI: All right. Paul, let's follow 17 18 up with LKMA on that. 19 ADMINISTRATOR PALLAS: I did, in fact. 20 MAYOR STUESSI: Uh-huh. 21 ADMINISTRATOR PALLAS: And they're -- I'm 22 expecting a proposal some time next week. They said probably late next week, so you wouldn't be able to 23 24 get it approved at next week's meeting, there just 25 wouldn't be time. As soon as I get it, I'll

1 circulate it. Okay. Well, but that's a 2 MAYOR STUESSI: 3 separate issue than just getting them to opine on the 4 speed limit change. 5 ADMINISTRATOR PALLAS: Well, they would, they 6 would -- they won't just give you an opinion, they'll 7 want to study it to some, to some degree. That's the 8 proposal --MAYOR STUESSI: Uh-huh. 9 10 ADMINISTRATOR PALLAS: -- that they're going to 11 give me. 12 TRUSTEE PHILLIPS: So we should leave the 13 public hearing open. 14 MAYOR STUESSI: Yeah. So --TRUSTEE PHILLIPS: You want me to make the 15 16 motion? 17 MAYOR STUESSI: Sure. TRUSTEE PHILLIPS: I'll make the motion that we 18 19 leave the -- bah -- the public hearing open for the 20 proposed Local Law of changing the speed limit within 21 the Village roads to 25 miles per hour. So moved. 22 TRUSTEE BRENNAN: Second. 23 MAYOR STUESSI: All in favor? 24 TRUSTEE ROBINS: Aye. 25 TRUSTEE BRENNAN: Aye.

Is there 5 a contract that needs to be completed for the 6 contractors, just because we're transferring money 7 for the Community Development --8 ADMINISTRATOR PALLAS: I don't, I don't think 9 Typically, we wouldn't do contracts for projects SO. 10 of this size --11 TRUSTEE PHILLIPS: Okay. 12 ADMINISTRATOR PALLAS: -- because there's no --13 the machinations of the funding really is not 14 relative -- relevant to that. TRUSTEE PHILLIPS: Okay. She would be returning. She's great, and, again, I'm recommending that the Board accept this contract as is.

Moving on in my report to Public Assembly Applications. We've received quite a few. People are gearing up for the summer and upcoming holidays. So the first application that was received is from the Greenport BID for the annual Egg Roll, which is going to be held on March 30th, 2024.

9 I received three public assembly applications from the Greenport Skate Park, Inc. The first one is 10 11 a community photo shoot, which is going to be held on 12 May 18th, 2024. The next application is for National 13 Get Out and Skate Day, which will be Friday, June 21st and Saturday, June 22nd, 2024. And then their final 14 event application at this time is for the Skate Park 15 16 Festival, which will be held on July 13th, with a rain date of July 14. 17

And then the final public assembly application was received for our annual Maritime Festival by the East End Seaport Museum and Maritime -- Marine Foundation, and that is to be held on September 21st and 22nd of 2024.

And then, finally, on my report is just a list
of legal notices that have gone out over the last
month or so. So the first one here is for our

Special Work Session, which already happened on

The next one that was submitted was for the RFP for McCann Campground management. That RFP was a tight turnaround, it was February 8th through the 13th. As mentioned previously, we opened it and had one submission from Lisa Otis.

8 The bid for Mitchell Park bathrooms, the 9 renovations there, that bid is still happening now. 10 I believe it closes on February 29th, if I'm not 11 mistaken. So that is -- that is incorrect here, my 12 apologies.

MAYOR STUESSI: So, to be clear, the Code 5 6 Committee's recommendation was that there would be no 7 rentals for less than 30 days --8 TRUSTEE PHILLIPS: Thirty days. 9 MAYOR STUESSI: -- under any circumstances, correct? 10 11 TRUSTEE PHILLIPS: Correct. That was, that was 12 the first one. MAYOR STUESSI: Outside of a bed and breakfast. 13 Right, outside of a --14 TRUSTEE PHILLIPS: MAYOR STUESSI: A licensed bed and breakfast. 15 16 TRUSTEE PHILLIPS: The other thing was we were -- removal of the definition of owner-occupied. 17 18 We are suggesting removal of the exception for the 19 two-family houses. That puts everyone on the same, 20 same level playing field. And some regulation 21 changes that when we do the rental permits, that the 22 property owner is going to have to declare which dwelling or bedroom, on some of them, on short-term 23 24 rentals, which ones they're going to be short-term 25 rentaling, so that the enforcement becomes a little

1 bit clearer for down the road.

And another suggestion was to have a sunset clause for one or two years to review the changes towards the eventual phaseout of short-term rentals in some sections or throughout the Village. Pretty much that was it, short-term rentals.

7 MAYOR STUESSI: A sunset clause, or a review8 after a period of time?

TRUSTEE PHILLIPS: Well, we called it, we 9 called it a sunset clause, because I think that's how 10 11 it has to get written, to be honest with you, for the 12 review, but it doesn't have to be that way. I was just going -- the terminology is something that we 13 14 use in the fishing industry on management plans, so -- that have to become Federal Law, so that's the 15 16 only reason why I used the word sunset. I'm not 17 sure. Brian would have to come up with the legalese for that. 18

19ATTORNEY STOLAR: The intent is understood.20TRUSTEE PHILLIPS: Right.

21 ATTORNEY STOLAR: It doesn't matter what you 22 call it.

TRUSTEE PHILLIPS: So that is pretty much the
conversation. We felt strongly that before we even
consider auxiliary dwelling units, that we needed to

have a clear, clearer guidance or clearer code in
 definition -- I mean, in dealing with short-term
 rentals, so that was it.

MAYOR STUESSI: Yeah. So one of the issues we've had is that the language that was created, I think it was six years ago, defining owner-occupied is quite loose. And I believe the spirit of the Board at the time was that somebody was actually living there and it was their home.

10

TRUSTEE PHILLIPS: Correct.

11 MAYOR STUESSI: And, you know, the way it's 12 written is that it could be anybody who has ownership. Obviously, this is a critical issue in 13 the Village in looking at balancing the needs of 14 residents together with those that are trying to gain 15 16 some sort of rental income, whether they live there or not, which is in dispute. What are the Board's 17 18 thoughts on this?

19 TRUSTEE ROBINS: I think it's a good step in 20 the right direction, definitely. I sat in on that 21 Code Committee meeting, when you had that initial 22 discussion about it, and I think it's a good first 23 step. I hope that at some point the Village is going 24 to go further, but I think this is a good initial, 25 you know, entry into the -- cracking down on the

67 Work Session 2/15/24 1 short-term rentals. I think they are detrimental to 2 the housing in the Village, to be honest with you. COURT REPORTER: I'm sorry. Julia, I can't, I 3 4 can't hear you. MAYOR STUESSI: You need to pull your 5 6 microphone closer, Julia. I just -- that I would 7 TRUSTEE ROBINS: Yeah. 8 like to see the Village move on this, and, hopefully, 9 continue to get more aggressive in terms of regulating 10 short-term rentals. 11 ATTORNEY STOLAR: So you're in support of the 12 language that the Code Committee proposed --13 TRUSTEE ROBINS: Absolutely. 14 MAYOR STUESSI: -- on this? TRUSTEE ROBINS: Absolutely, yes. 15 16 MAYOR STUESSI: Patrick? 17 TRUSTEE BRENNAN: I'm just unclear about the 18 owner-occupied piece, Mary Bess. What are you 19 suggesting is the change? 20 TRUSTEE PHILLIPS: The suggestion of removing 21 the definition of owner-occupied, because that falls 22 into the exception for the two-family houses, is it has -- you have to either be owner-occupied in one of 23 24 the units to rent the other unit, or you have to have 25 a long-term lease, which we've had instances where

that hasn't worked, where they've rented both, both
 short-term rentals, you know, both units as short-term
 rentals.

4 MAYOR STUESSI: Well, so, very simply, what the 5 Code Committee is proposing, if I'm reading it 6 correctly, what I've heard is that there would be no 7 exceptions for any rentals of less than one month, 8 correct?

9

TRUSTEE PHILLIPS: Correct.

10 MAYOR STUESSI: And so there's no reason to 11 keep the owner-occupied language in there if there's 12 a minimum one-month rental in what you guys are 13 proposing.

14 TRUSTEE BRENNAN: Okay. So it doesn't matter 15 whether there's an owner or -- living there, or 16 whether it's an investment property, someone else 17 lives elsewhere? It's a non-issue, provided that 18 it's a 30-day minimum?

19 TRUSTEE PHILLIPS: Well, it's 30 days, but if 20 it's a two-family, in doing away with the exception, 21 they would have to declare one of them as a 22 short-term rental, because I -- yeah, one of --23 that's what was the suggestion, that we -- in order 24 for us to get a better handle on how many are within 25 the Village, as far as short-term rentals, if you're

Like do we want to say you can -- you can't rent a bedroom in a house for less than a 25

1 month? TRUSTEE PHILLIPS: Well, right now it says it's 2 3 14 davs. 4 TRUSTEE DOUGHERTY-JOHNSON: Right. No, I know, but I'm just saying, I'm not sure that -- I feel like 5 a bedroom in a house is different than a full house 6 7 or an apartment. 8 MAYOR STUESSI: No. Right now, if you live 9 there, you can rent it out for a weekend. TRUSTEE DOUGHERTY-JOHNSON: No, you can't. 10 You 11 can rent it out for two weeks. TRUSTEE BRENNAN: So that's another issue, 12 13 right, because the way the 14 days -- I understood 14 that some people interpreted that they could only rent it once within a 14-day period, and I don't 15 16 think that was the intent originally, correct? 17 TRUSTEE PHILLIPS: What, the intent of one, one 18 time within the 14 days? 19 TRUSTEE BRENNAN: Yes, like one weekend. 20 TRUSTEE PHILLIPS: Yeah, that was the original 21 intent, but that's not how it's been working. People 22 have been renting every weekend. As I said, if this --TRUSTEE BRENNAN: So if people were renting 23 24 like a --25 MAYOR STUESSI: Short-term in the current code

4 But, on the other hand, we also realize that 5 people have bought homes here, you know, as 6 investments, and this would -- the reason was going back to review it, was to give them the opportunity 7 8 to say, "Well, maybe this isn't so profitable for me 9 anymore to keep this investment house, so we'll either long-term it for" -- you know, "To provide 10 11 more housing, or we'll put it back on the market and 12 let somebody else take it from there." That was, that was some of the other thought process, was, 13 14 you know, we can't just cut people off at the knees in something that they've invested in. So it was 15 16 giving them the opportunity to see if it was going to work for them. 17

18 TRUSTEE BRENNAN: So is that different than a 19 phase-in, the review that you're describing? TRUSTEE PHILLIPS: Well, the review was to see 20 21 if we -- if we're actually asking them to declare 22 which ones on the rental permit is short-term rental, we should start to see when the renewals come up 23 24 every two years, because that's what goes with the 25 permits, the rental permits are every two years.

1 We'll start --MAYOR STUESSI: Well, the implement -- if I 2 could interject for a second. 3 TRUSTEE PHILLIPS: 4 Yeah. 5 MAYOR STUESSI: The implementation, if I 6 recall, was suggested to be January 1 of next year. 7 TRUSTEE PHILLIPS: Yes, that's -- yeah, it was. 8 MAYOR STUESSI: Correct? 9 TRUSTEE PHILLIPS: Correct, yeah. 10 MAYOR STUESSI: And then the review would be at a year, and then the Board has a discussion about how 11 12 things are going at that point. TRUSTEE BRENNAN: What about the end of Bay 9 where the circle is, is that no parking, where the 10 11 dock is at Bay Avenue? 12 MAYOR STUESSI: Yeah. 13 TRUSTEE PHILLIPS: Yeah, that's a no parking, too. 14 MAYOR STUESSI: You have to park back in front of the houses. 15 16 TRUSTEE ROBINS: The circle you're talking about? 17 TRUSTEE BRENNAN: Yeah. MAYOR STUESSI: Yeah. 18 19 TRUSTEE PHILLIPS: Yeah. 20 MAYOR STUESSI: So we had a public hearing 21 scheduled for next week on Parks and Mass Assembly. It would seem like at this moment we should cancel 22 23 it --24 TRUSTEE PHILLIPS: Postpone. 25 MAYOR STUESSI: -- or table it, postpone it.
